Milwaukee, Wis., Sept. 26.—Openly charging that President Roosevelt was a party to the agreement by which the United States Steel corporation secured control of the Tennessee Coal & Iron company, thus "fastening its grip" on the steel industry of the south, William J. Bryan tonight addressed a vitriolic letter to the president, in which he answers the recent charges made by the president, and also attacks the anti-trust beliefs of Governor Hughes of New York, who, he declares, was made governor by the trusts.

HERMAN RIDDER NEW TREASURER

Chairman Mack Announces Appointment of the Well Known German Editor.

AN OLD GRAVE UNVEILS A MYSTERY

What Is Supposed to Be Remains of Fred McBride, the Notorious Bandit, Are Discovered in Harney County.

Burns, Or., Sept. 26.—Fifty miles from civilization, in the foothills of the Blue Mountains, at the north limit of Harney county, has been discovered evidence of a long past murder. Turfs of human hair, a portion of a shoulder blade, six vertebrae and scraps of a man's clothing have been brought to light. Some say the corpse must be that of Fred McBride, accused of being the leader of a notorious band of horse-thieves that operated in this country for years. McBride fled from the county over a year ago, and no trace has been had of him since. There is a possibility that it could not have been McBride, for he would not have jeopardized his personal safety by lingering here. Only by the odd bits of clothing can the investigation be carried on, for in the 34 hours that elapsed between the first discovery of the body and the arrival of an investigating party, the corpse was spirited away.

HILL SECURES COOS BAY TERMINUS

5,000 Acres of Land, the Libby Mine Properties and the Steamship Plant, Its Wharf and Waterfront, Are Taken Over.

Marsfield, Or., Sept. 26.—Western brokers have bought the Oregon Coal & Navigation company's holdings for James J. Hill. The deal includes the Libby coal mines, the waterfront and wharf of the steamship M. F. Plant, which runs between Coos bay and San Francisco and 5,000 acres of land. It is the biggest transaction of the year and has created a stir in local railroad circles.

HARRY THAN WILL GO FREE

Money Fight All the Way, Jerome Says, and Anti-Thaw Money Is All Gone—Judge Mills Forecasts His Decision.

DICE GAME ENDS IN FATAL FIGHT
