Greatest Livestock Show in City's History Disappointment from Attendance Point of View—Managers Plan Greater Things.

The first annual livestock show and racing meeting of the Portland Country Club and Livestock association came to a close last night after a full week that was a success in every way except as regards attendance and interest shown by Portland people in what was undoubtedly the biggest thing of the kind they have ever had opportunity to visit.

The managers of the show do not deny that they are greatly disappointed in Portland. They figured that the show they were putting up ought to bring out from 15,000 to 20,000 people each day, whereas the record attendance was not over 8,000.

In the most exciting of the races yesterday, Starter Bollean stated that the management was greatly disappointed at the results of the show, but was not discouraged and would try to put up as good a show next year. The livestock parade of Friday, he said, was undoubtedly the best by far that had ever been seen west of the Mississippi river, while better times had been made in the races right through the meet than was made at Columbus in the grand circuit.

Yesterday the cash prizes were paid over and the horses and ponies removed their stock and started it homeward, though many of the animals were left to be removed today.

The crowd yesterday afternoon was smaller than on either Thursday or Friday, though it had been expected that Saturday's half-holiday would bring out the crowd of the week. The speed events were the feature of the day, a track record of 2:04 1/2 being made by Mona Wilkes in the 2:05 pace. Yesterday the cash prizes were paid over and the horses and ponies removed their stock and started it homeward, though many of the animals were left to be removed today.

She made the half mile in 1:01, but ran off the track and lost time, finishing in 2:09 1/2, when she seemed to have a chance to set another record of the record.

A number of youngsters of the race-track went against their old 2:30 1/2 records in an endeavor to lower them and get into faster company. Most of them failed to do any better, however. It was nearly 6 o'clock when the last heat was run off and the stock show, fair and racing meet came to an end until next year. It has been a great success and the show will be more appreciated and better patronized by Portland people.

TAFT ANSWERS FORAKER; OPPOSES GUARANTY PLAN

Argues Difference Between Standard Oil Doyle and Standard Oil Foraker—Not Trust Men's Guest—Prefers Postal Savings Plan.

(United Press Leased Wire.) Minneapolis, Minn., Sept. 26.—With a straight-from-the-shoulder reply to Senator Foraker, and ringing speeches at St. Paul and Minneapolis, Taft tonight closed the end of his five weeks of strenuous campaigning for the presidency. His opponent on the Democratic ticket, Mr. Bryan, will spend Sunday in Minneapolis not many squares from Taft's headquarters.

The end of Taft's day of toil found his voice in very ragged shape. At the close of his speech on postal savings banks he could scarcely be heard 10 feet from the stage. The warmth of welcome accorded him throughout the 24 hours, as well as the tremendous numbers of those who flocked to greet him at every railroad crossing, went far toward compensating him for the discomfort he felt. After he had been shown a copy of the statement issued by Senator Foraker of Ohio, in which the latter charged him with meddling up to Standard Oil magnates, Mr. Taft dictated the following reply:

Explains the Doyle Matter. "First, Senator Foraker says in his statement that I recommended Judge Doyle for a United States judgeship in northern Ohio, and the president acquiesced. I never recommended Judge Doyle for the Standard Oil company. He argues that this is a justification for him, while a senator of the United States, accepting professional employment from the Standard Oil company, and in making what was in effect a newspaper partnership with the Standard Oil company to control an organ of public opinion. Mr. Doyle held no public office and numbered the Standard Oil company as only one among a number of clients. I told the president that Judge Doyle was a man of high character and a lawyer of great ability, but explained what his corporate and personal connections had been and the president referred H. W. Taylor and appointed him."

Trust Favors Explained. "Second, Senator Foraker refers to my alleged receipt of favors from C. F.
