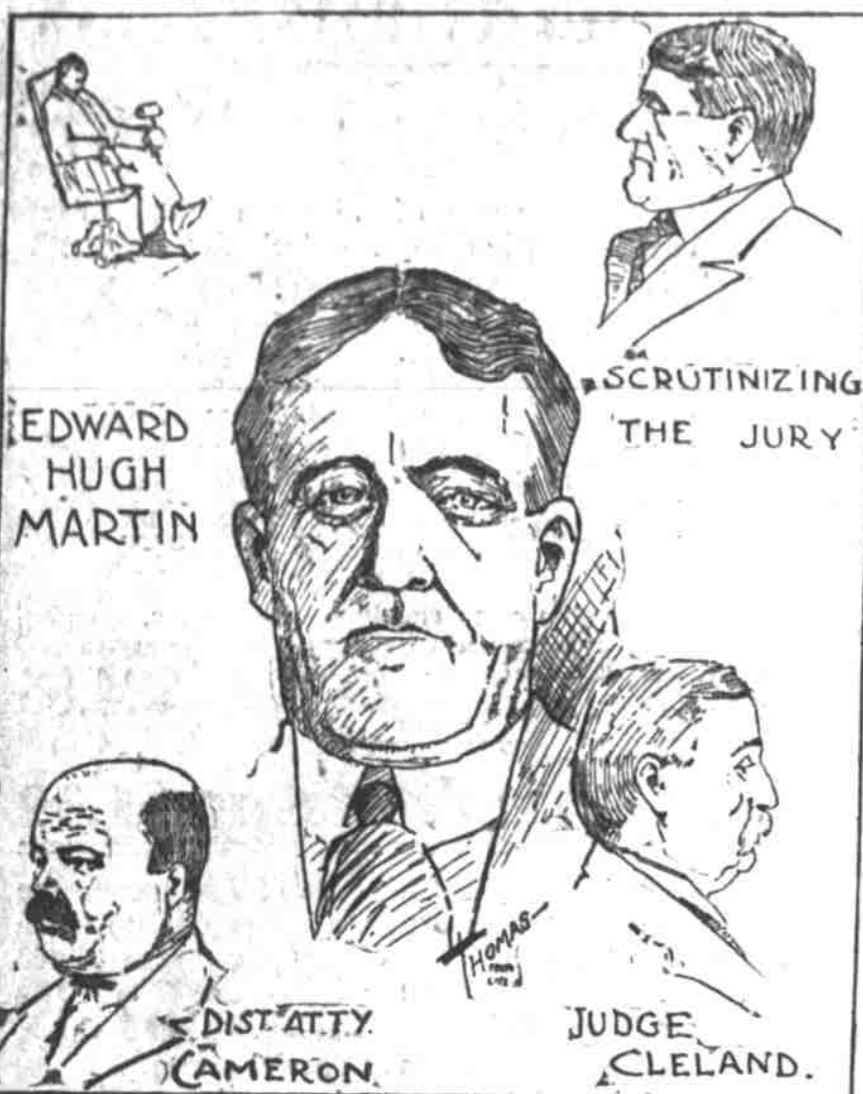

Shortly after the hour of noon today the twelfth juror for the trial of Edward H. Martin, accused by the state of Oregon of committing the atrocious murder of Nathan Wolff, was accepted, and the men who are to decide upon his guilt or innocence were placed under oath.

The first testimony will be taken this afternoon, after the jury has visited the pawnshop on First street, where on the night of May 1, Wolff was shot and hacked to death with a hatchet. Before court adjourned at noon Deputy District Attorney Fitzgerald, in charge of the case for the state, made his suggestion for this visit, and Judge Cleland said it would be taken up this afternoon. Attorneys for the defense afterward stated that they would join in the request to have the jury inspect the place where Wolff met his death.

Not until every peremptory challenge allowed to both the state and the defense had been used was a jury secured this morning at the close of a day and a half's close questioning of 38 men that Judge Cleland had ordered to appear this morning. Had he been disqualified it would have been necessary to send the sheriff forth on a search for another list of takers. Martin seemed even in better spirits than ever this morning. He sat as usual between District Attorney Cameron and John A. Jeffrey, his chief counsel, and frequently whispered to the latter as the examination proceeded. He kept his eyes on the men in the jury box and frequently joined in the conversation.

Mr. McPherson was asked if the tendency of the railroads was to lower or raise the rates. He said that the railroad officials have found it a necessity to raise the rates, if anything, he said, "owing to the great increase in the cost of maintenance, improvements and the enlargements of the systems. Rates, if anything, will continue to rise."

W. C. T. U. President at Convention Appoints Committee to Have Charge of New Oregon Crusade—Much Convention Work.

In accordance with the report of the executive committee presented this morning at the twenty-fifth annual convention of the W. C. T. U. at the Taylor street M. E. church, the president, Mrs. Henrietta Brown, appointed the committee which is to have definite charge of the "Oregon Dry in 1910" movement which is the object toward which the best efforts of the organization will be directed.

The committee consists of Mrs. Henrietta Brown, Mrs. Neal Inman and Mrs. Ada Wallace Unruh. In the morning Mrs. C. T. U. will be federated with the Prohibition party, the Anti-Saloon league and similar organizations working for temperance.
