

BRYAN WANTS \$5,000 DAMAGE THE LIGHT SHED SUIT DISMISSED

G. O. P. and Its Candidate Should State Policies— If They Dare. Judgment Against O. R. & N. Company Reversed by the Supreme Court.

Denver, Oct. 17.—At the Auditorium, after passing through streets crowded with enthusiastic cheering supporters and addressing three overflow meetings on the way, W. J. Bryan last night called for "more light" on the policies proposed by his Republican antagonist in the presidential race.

Mr. Bryan referred to the fact that the Democratic national committee had published a list of contributors and he demanded that the Republican party do the same. He asked that the Republicans make known their positions on needed labor legislation and "not betray the toiler with a kiss."

"What is it going to do on the Philippine question?" he inquired. "It has enormously increased the appropriations for the army and the navy in preparation for wars that ought never to come. It has boasted of possessions in the orient, while the Philippines clamor for an announcement of the nation's policy. Let there be light."

Mr. Bryan said the Democratic convention decided for the popular election of senators, while the Republican convention overwhelmingly voted against it. The Republican candidate had merely expressed personal inclination in its favor, but Bryan insisted that this reform was demanded in the interest of honest government.

Bryan said the Republican platform dealt in generalities and its purposes were not made clear. "The Democratic party," he said, "takes the public into its confidence and submits its policies to their judgment. Let the Republican party be equally candid and open its books and its plans. Let there be light."

Fourteen thousand people heard Mr. Bryan's speech at the Auditorium.

Scores of marching clubs from other Colorado cities were in the procession that followed the candidate to the grand hall. Pyrotechnic and electrical effects deepened the impressiveness of the scene in the streets.

His progress toward this city yesterday was one running fire of speeches delivered to enthusiastic townpeople and farmers, who made up a crowd of shouting enthusiasts at each station.

The publication of the campaign contributions gave Mr. Bryan a text at many of these places and he varied his short speeches on the guaranty of bank deposits with a discussion of the public plank of the Democratic party and called on the Republican party to be as honest with the people.

ITO PROFESSES GOOD WILL FOR AMERICA

CHINA TO ASK DIAZ TO LET COOLIES IN

San Francisco, Oct. 17.—The Chinese government through its diplomatic agent, Paul Chong, will endeavor to obtain from Mexico a rescinding of the order forbidding the entrance of Chinese coolies into Mexico. Chong, a Chinese prefect, in company with Wu Chang, a Chinese magistrate, arrived here today on the Pacific Mail steamship Gibraltar from China. They will go directly to Mexico City for an interview with President Diaz. After presenting China's claims and attempting to adjust the difficulty, the Chinese representative will go to Washington for a conference with the president.

RECENT VICTIMS OF FOREST FIRE

Alpena, Mich., Oct. 17.—Among the recently discovered dead is a daughter of Emil Heaver, who was burned to death in her father's lumber camp. The girl was alone in the camp when a change in the wind brought the fire toward her. She was roasted alive in the house. Her body was found today. The charred body of an unidentified man was found near the railroad track today near Alpena.

Olympia, Wash., Oct. 17.—A judgment against the Oregon Railroad & Navigation company of \$5,000, growing out of a rear end collision on the road at Riverview, Oregon, has been reversed by the supreme court and the case ordered dismissed.

The action was instituted by Joseph Boucher, conductor of freight No. 21, running between Wallula, Washington, and Umatilla, Oregon. Freight No. 21 was followed by an extra freight which overtook it at Riverview and smashed the caboose, injuring Boucher. The record disclosed to the supreme court that No. 21 was delayed, that Boucher knew that the extra was following him and failed to observe the rules of the company regarding throwing out fuses or torpedoes from the rear of the train. It is held that he was contributorily negligent.

The court also affirmed a judgment in favor of the Spokane & Inland Empire Railroad company in a damage suit resulting from the death of Eugene E. Cable, who was killed by a train of the Coeur d'Alene flyer. Cable was driving his two daughters to a station at which the flyer did not stop. The train was late and the party was extra go through and supposed it was the flyer. Thereafter they saw the fast train approaching and mistook it for a local. The horse was not stopped at the crossing and the buggy was struck by the train. Cable was killed and one daughter was seriously injured.

The court holds that the rate that persons about to cross "light" railroad grades should "stop, look and listen" applies as well to interurban electric roads.
