

CALIFORNIA IS WESTERLY LINE FOR BRYAN

Sentiment in All Parts of State Veering Toward Nebraskan—Will Carry San Francisco by 8,000, Says Private Letter.

California is due to give its electoral vote to Bryan, according to a prominent Republican of San Francisco, who writes to a Portland friend. According to this letter the northern part of the state is strong for Bryan, and the Nebraskan is growing in favor throughout the southern part of the state.

Northern California and the towns of the valley as far south as Bakersfield are strong for Bryan. In Stockton and Sacramento Bryan will run like wildfire and in Bakersfield there is sure to be a large Democratic majority.

San Francisco is a Bryan town and the party counts on a lead of about 8,000 for him there. Counties north of San Francisco are mostly Bryan with the exception of Marin.

The Democratic state central committee expects a tie in San Bernardino and is claiming that the strength of Bryan in the central and northern part of the state will offset Taft's southern California majority.
