

# RYAN SEKS HELDS CHANGES CENTER OF FRAY

## Consents to Prosecute an Appeal in Mount Scott Case.

### Busiest Day of Busiest Week Is His Today, in and About New York City—Climax of Campaign at Madison Square Garden.

(United Press Leased Wire.)  
New York, Oct. 26.—William J. Bryan made a 15-mile automobile trip to Paterson, N. J., this morning, where he addressed a big crowd, many of whom were mechanics and laborers. Bryan confined his speech in a large measure to the labor question and denounced the recent letter of President Roosevelt to Senator Knox as an effort to deceive the workmen.

Bryan referred to the anti-injunction plank and said the Republican party was so allied with the vested interests that its leaders were prejudiced in the considerations of questions involving capital and labor. He was enthusiastically received and his speech was loudly cheered.

Immediately after the meeting Bryan started back to New York to deliver an address before the Women's Democratic club at the Waldorf-Astoria. The program for the afternoon includes an automobile trip into Westchester county. Tonight the "fireworks will begin" according to a statement made at headquarters today, when three monster meetings will be held in Manhattan. Bryan will speak at all three meetings and the rush and flurry of excitement, marking the climax of the battle here, has given New York its quadrennial attack of presidential election fever.

Mr. Bryan's busy week. As the pivotal state in the election is evidenced by the fact that both the leading candidates for president will devote this, the concluding week of the campaign, to stumping tours that will extend from this city to Buffalo. In the consummation of their plans of making an extraordinary effort to carry this state the managers of both the Taft and Bryan campaigns are now marshaling their best talent for the fray. Beginning today and continuing until Saturday night the state will ring with the oratory of the foremost campaigners of both parties. Mr. Taft and Mr. Bryan will personally lead the oratorical battle.

There was great activity in Democratic circles today in consequence of the visit to the city of Mr. Bryan. Upon his arrival in the city the Democratic candidate for the presidency found awaiting him a program calculated to take up every moment of his time. Nine speeches were scheduled for the day and evening. The National Democratic club has arranged a reception in honor of the candidate at the club house in Fifth avenue this afternoon. The reception is to be followed by a dinner at which Mr. Bryan was to be the guest of honor. After the dinner the members of the club will personally escort Mr. Bryan to Madison Square Garden where the great Democratic mass meeting of the campaign takes place tonight.

Bryan is to remain in this city and vicinity until tomorrow night, when he will start on a trip across the state, speaking in Albany, Syracuse and Buffalo.

### BURKE MAKES DENIAL, ALSO SOME ADMISSIONS

Los Angeles, Cal., Oct. 26.—Following the publication by the New York World of charges that James Schoolcraft Sherman, Republican nominee for vice-president, was implicated in a plot to grab a vast amount of valuable land in New Mexico, Edmund Burke, the local attorney alleged to have given information to the World, today denied that he made the statement, but admitted many of the facts in the story. The World published the story today as having been dictated at Denver recently by Burke in the presence of T. M. Patterson and other witnesses.

Admitting that he was connected with Sherman in a New Mexico land deal, Burke today made the following statement: "I know nothing concerning the story published, as I am told, in the New York World. In 1901 and 1902 I was associated with Messrs. J. S. Sherman, A. Phillips and some others in the New Mexico Land & Development company and we secured what was called an option on some timber lands in New Mexico, but the matter was finally abandoned. I have no papers or documents relating to the subject."
