

WOMEN DOES NOT MEET THIS OBJECTION FOR COURT TERM

Circuit Court Subpoenas 100 Householders to Serve During Month of November—Only Nine Farmers on List.

One hundred taxpayers have been served with summons to appear at the courthouse next Monday morning for jury service for the November term of court. From this number a grand jury of seven will be chosen by lot, the remainder serving as the trial jurors for the term. The proportion of farmers is unusually small, only nine being on the list.

At the November term there will be two murder cases for trial. The case of Jack La Rose, accused of killing Hyman Neuman with a gas pipe, will be called next Monday. This will attract much attention, the crime having followed closely on the murder of Nathan Wolf, for which Edward H. Martin was recently convicted of manslaughter. La Rose will be prosecuted by Deputy District Attorney Fitzgerald, and defended by J. H. Upton and L. W. Humphreys.

Jackson Reid, the 12-year-old slayer of George La Mars, is to face a jury of his men in the juvenile court to determine the question of delinquency. If he is declared delinquent by the jury, Judge Gantenbein may remand the boy to the circuit court for trial for murder or may deal with him in the juvenile court. But in either case the boy could not be sent to the penitentiary, as he is too young to be received there.

Building Inspector Will Oppose Ordinance Drafted by Architects.

Building Inspector Dobson will oppose the amended ordinance drafted by architects of the city to replace the one introduced at the last council meeting. Mr. Dobson says those who framed that ordinance discovered that they could not push it through and so set to work to offer a substitute. This substitute which will go before the council tomorrow, while worded somewhat differently, practically presents it as is, the same objections as the original measure.

The bill provides that structures may be built outside the fire limits with walls five inches less in thickness than the standard. Mr. Dobson will object to this feature as he holds that the thickness of walls above the second story should be at least 12 inches.

The other modification is that bearing partitions may be used in construction up to and including four stories in height. While this is not the best construction, in the building inspector's opinion, it is permitted by the present law in frame buildings and he will recommend that this be allowed in buildings of three stories or less height.

Bearing partitions are different from the girder structure in that each story is supported by the floor beneath it. Where girders are used they run the entire height of the building and floors of each story are supported on the cement foundation. In event of fire in structures thus supported the floors above that collapse as they have no support.

In the bearing construction as soon as a floor is demolished by fire all the floors above that collapse as they have no support.

The defense in the case of the government against five members of the Pacific Furniture & Lumber company rested this morning. The court ordered the examination of the witness continue. Within 10 minutes, at a time when Mr. Becker was endeavoring to have certain facts and figures identified by Dr. Hedderly, Mr. Manning arose and again made the objection that the attorney for the prosecution was looking at the jurors in a way that he did not think was just right. Again Mr. Becker said that he thought the court was wrong in the wrong impression of his actions.

Judge Wolverton ordered that the matter be continued, saying that Mr. Manning's assertions were without foundation and that the witness was being examined in a proper manner, and that the court would not be troubled with the legal technicalities which have been brought to hand the jury has been excused from duty in the courtroom. At noon Judge Wolverton announced that the jurors should not be held in court until the point of law should be settled.

As soon as this has been decided John McCourt will open for the government in his argument to the jury.
