YOUTH GAVE UP TO DESIRE FOR CRIME

(United Press Leased Wire.) Los Angeles, Nov. 2.—The juvenile court is considering today the strangest case that has come to its notice, that of Larry Watson, aged 18 years, who has lived in the bushes like a hunted animal for weeks, stealing forth at night to plunder houses and stores. Watson today made a full confession of his crimes, stating that viewing moving picture shows had made him a criminal. Until a few weeks ago he was a student at the Polytechnic high school and appears to be afflicted with some sort of mental disease. The youth was found in a hovel near the city when taken to the prison broke down and made a full confession. He said that his father deserted his family when he was 13 years old and that his mother had married again and did not care for him. The boy confessed to having committed a series of crimes from robbing his parents and relatives, many stores and houses, to issuing worthless checks. He will probably be sent to a reform school.

NEWFOUNDLAND HAS STATES LIKE US

Sectarian Issue Present, Due to Peculiar Historic Conditions.

(Special Dispatch to The Journal.) St. John's, N. F., Nov. 2.—Following a spirited campaign, the quadrennial general election in Newfoundland is being held today. Newfoundland is the only portion of British North America which enjoys an independent government apart from Canada. The population of 160,000 is distributed in about 1,800 fishing hamlets, large and small, around 6,000 miles of seaboard. The result of this widely scattered population is that the returns of today's election will hardly be obtained before the end of the week. Sir Robert Bond, the premier, is leading the government forces in the contest, and the opposition is headed by Sir Edward Morris, who until last year was attorney-general in the Bond cabinet. The question of religion plays an important part in the political contest. Years ago, when autonomous government was first granted, the majority of the inhabitants of Newfoundland were Catholics, and the early premiers were of that faith. Emigration, however, attracted the Catholics largely to western Canada, and the result of the election, therefore, hinges on the question as to whether a Protestant majority is prepared to accept a Catholic premier.

POLICE CANNOT LOCATE GIRL

Oakland Give Up Search for Edna Clark—Pinkertons Employed.

(United Press Leased Wire.) Oakland, Cal., Nov. 2.—Pinkerton detectives on both sides of San Francisco bay are today seeking the mysterious stranger with whom missing Edna Clark, the 19-year-old art student, was last seen. Recent developments in the case have led to the withdrawal of Attorney B. Wright, a friend of the family from directing the search, and he has placed the girl's uncle, A. E. Yates, in charge. The theory that the men of "The Eye" are working under, is that Edna Clark was persuaded by the stranger to draw her money from a local bank and to meet him. The detectives believe that his motive was robbery. They are also of the belief that the man has secreted or murdered the girl. Investigation by detectives at the bank revealed that Miss Clark took with her only \$300. Since turning the matter over to the private detective agency, one man who was known as a friend of the girl and who has been under suspicion, was exterminated by an investigation. It is believed that Mrs. Louis Mack, Edna's mother, has given the detectives important clues in a statement that she made yesterday to the Pinkertons. The family has refrained from discussing the case with outsiders. They have consulted the police but little in the mysterious affair, and the authorities have abandoned the search.

SICK AND HOMESICK; DRAWS THE RAZOR

Seattle, Nov. 2.—Leo Sederley, a lithographer, attempted suicide by cutting his throat with a razor in the waiting room at the Duwamish station on the Seattle-Tacoma interurban line yesterday. He was brought to Seattle and taken to the hospital, where it is stated he will live. Sederley says sickness caused him to decide that life was no longer worth living. He is 45 years of age and single. He arrived from Akron, Ohio, Saturday. A sister, Mrs. Anna Dole, lives at Edson, N. Y.

UNCLE JOE WILL FIND LOTS OF GOOD COMPANY IN FADEAWAY LAND—FREAKS OF THE ELECTORATE ARE SOMETIMES UNACCOUNTABLE.

Washington, Nov. 2.—The hard fight which is now being waged on "Uncle Joe" Cannon in his own district recalls the story of many another political prophet who has had honors heaped upon his head abroad, only to go down in defeat at home. Sometimes he has failed of re-election, and sometimes it has been a renomination that was wanting; but from one cause or another many a distinguished figure in national politics has been forced to bite the dust of defeat at the hands of his home people. Mr. Cannon himself had a taste of it in 1890, even if he shall not experience it again in 1908. Seneca E. Payne, who can lord it over a minority in a more lordly way than any other man who was ever majority leader of the house, once failed to be given the opportunity to figure even as one of the minority. James H. Sherman, the Republican candidate for vice-president, once trailed his banner in the dust of defeat. Champ Clark, the heir-apparent to the speaker's throne, once failed to be elected on Tuesday, once went down before an onslaught of a man who he says was "a fiddler, but nevertheless a good Indian." "Silver Dick" Bland lost out in one campaign to a horse doctor. And even William McKinley was once defeated by the voters of his own people.

MEAN WHO NEVER CAME BACK.

Usually the man who falls of a renomination is lost to politics forever, and the halls of congress know him no more. A case of this kind is that of General Charles H. Grosvenor, the old war horse of the Republican party in the case of which the Democrats carry the bitter opponent in debate than "Old Dick" Grosvenor. He could give and take as good as he received, and was a political warrior in capable. Yet his bitterness was confined to debate. Personally he was one of the best liked men who ever sat in the house, as shown by the fact that upon his retirement he was accorded an ovation the like of which has never before been accorded a retiring member. His successor is known chiefly as "The man who defeated General Grosvenor."

Another case is that of John Wesley Gaines, of the old Andrew Jackson district in Tennessee. While he has fought a great deal of fun and games during his congressional service, Mr. Gaines has been one of the most useful members of the house in the line of discovering shams and pretenses he is as keen on the scent as a bloodhound. And as for taking care of his constituents, anyone who knows his things are done in Washington will testify that Gaines was one of the best of his people. When the Democrats did many things of far-reaching import, the while adding to the gaiety of politics, failed to get a majority in the hands of the descendants of those who started Andy Jackson on his road to the presidency.

Another instance was the defeat of Representative Bankhead by Richmond Pearson Hobson. Bankhead is not a brilliant man, but he is a plodder. The two most important committees in the house to Alabama are those on rivers and harbors and public buildings and grounds. Bankhead was seldom employed by any member of the house. But notwithstanding this, Hobson won a seat in the Alabama lost its good assignments. However, that was a case of kicking a man upstairs, for Bankhead was promptly chosen alternate for the United States senate, and became a senator upon the death of Senator Morgan.

THOSE WHO BOB UP AGAIN.

Seneca Payne is one of the few men who have survived a defeat for renomination. Many have lost at the polls and won again later, but usually the man who loses at his nominating convention never gets back to congress. It was for the nomination for membership in the Fifty-fifth congress that Payne took another lease on the office that has not yet expired although nearly 20 years have passed. Another prominent figure in the national political arena who once lost out for the nomination for membership in the Fifty-fifth congress was Joseph W. Keifer, formerly speaker of the house, and now famous for his fight for a reduction of southern representation in congress, and for the near-dress suit he wears upon all occasions.
