

MAY YOTE IS OFF FOR A VOYAGE

ONLY KING WHO HAS NEVER HAD A DEBT

Victor Emanuel of Italy Holds That Unique Distinction—As His Income Is \$1,200,000 a Year, However, It May Not Seem Surprising.

Rome, Oct. 22.—King Victor Emanuel stands unique in the world as the only sovereign who has never had a debt. More remarkable still, he was practically free from debt as crown prince, when his finances were anything but florid.

The Italian civil list amounts to the very respectable sum of \$1,200,000 yearly, but the king's expenses are enormous. He hands over every year \$400,000 to his mother, he keeps up from eight to ten palaces and entourage, and he is paying off the debt of an extravagant father, and still more so grandfather.

When he came to the throne he found that there were many large debts, on which very high interest was being paid, of the great Victor Emanuel, a king in the old style, without thought where spending, women, and feasting were concerned, but for courtesy and love of country. King Humbert was more restrained in his pleasures, but thought that as king should be a king all through, and not look at the pennies. Thus when his son came to the throne he found a sad state of financial chaos.

Public Views. Victor Emanuel's public point of view, curiously enough, is that of his subjects, that while the country is poor her sovereign should pay the personal family debts, and his private view is that a sovereign lowers his own dignity and that of his subjects if he runs into any difficulties, and is obliged to pawn his jewels, for example. He, therefore, looked about him for the best way to raise money and came to the conclusion that the bourgeoisie way is the best, i. e. to cut down expenses. What a day that was at court!

When he had expounded his plans to the minister of the royal house, that functionary went about with his eyes half out of his head with astonishment, and is even said to have been seen wringing his hands and praying for a return of the good old days! There was great astonishment not only in Italy but abroad, when the young sovereign, with over a million dollars income, sold nearly a hundred horses which had been eating their heads off at the Quirinal palace, only keeping those strictly necessary for royal use. At the same time two or three cooks were got rid of.

Today the queen's clothing while still of the best quality is not bought regardless of the price, as was the case with Queen Margherita. Furthermore, Queen Elena's gowns and hats are seen quite three times, if not more by the public, and royal dinners at the palace is restricted to two balls a year, the necessary state dinners and such indispensable functions as the house-keeping and foreign sovereigns who have visited the Quirinal declare that they have entertained as well, if not better, than at any other court.

Do Not Thank Him. King Victor Emanuel's subjects do not thank him for his care of the national exchequer. Quite the contrary, they complain of what they call his "parsimony," say he is not a king but a gentleman farmer, so far as to call him to mind, and hint that he is saving his money and putting it safely in English government bonds, so that the day he loses his throne he will at least have his money. This, of course, has come to his ears, but with such a man, gossip makes little impression, and he has merely redoubled his efforts to get the debts paid off and live as he chooses.

Another of his "economies" was to turn the royal stables, here and there, into paying concerns. For instance, Castelnuovo and Castelporziano, near Ostia, on the Tiber, which were magnificent "king" were merely passive shooting places, which required large sums to keep up. The "burgooles" king has, with modern methods, transformed them into money-making properties, which pay from three to five per cent, and the same sum keeps up his preserves at half the cost. The Colano estate, which seemed to be nothing but worthless marshes, has been sold, and now pays something like 10 per cent, and the "miser" has given a large part of it as a gift for the installation of the Marconi wireless.

However, with all his good qualities, it must be confessed that the Italian sovereign carries somewhat of a reputation for parsimony. It is all right to pay off other people's debts, but not at the expense of decorum. It is authoritatively stated that Queen Elena, sells her old clothes, that is the very old ones—the comparatively good ones are sent to her family at Moncalieri—and that her husband thinks twice before opening a bottle of champagne. It is, perhaps, unfortunate that King Victor Emanuel over a nation which does not particularly love and admire the domestic virtues in a ruler if not kept in the background and overshadowed by kingly show.

It all happened at San Francisco, and it was all due to a \$3,000 ermine coat. The once brilliant and chic stage favorite sat in a box at the opera, and every woman in the house had her eyes on that bunch of expensive furs to the discomfort of the actors and the actresses. May fairly acclimated, she was the bright particular star of the evening.

Some one recognized the elegantly dressed woman as May Yote, etc., etc., late of Portland, Or.—May Yote, who is engaged to a lord who resides in British Columbia, and who will soon count her fortune in the millions. A rude reporter approached her and this is what she said:

"Yes, I am registered as Mrs. Bachelor of New York; I am stopping at a local hotel. Bachelor is my mother's maiden name, and I am the former Lady Hope. I didn't wish to be known. I lived so quietly and peacefully in Portland for months till that recent newspaper publicity, and then I left. Was I trying to establish a residence there to secure a divorce from Captain Strong? Well, what of it?"

"I am on my way now for a trip round the world. I was to have sailed from Victoria, but my mother sent this coat out to me, and to save the duty on having it come to Canada, I came down here. So I am going to start from here in a week, go to Honolulu, Yokohama, Shanghai, Hongkong, the South Sea Islands, Auckland and the principal cities of Australia, probably appearing with a vaudeville company from here. I will show if I can; the money, as good to me as to other people, though I have some now. People don't come to hear me sing; just to see the woman that had the Hope jewels."

SOLID STAND ON STATEMENT NO. 1

Continued Controversy But Serves to Further Cause With Legislators.

(Salem Bureau of The Journal.) Salem, Nov. 19.—It is the assertion of the Statement No. 1 members of the legislature in Marion county that the continued wrangling in certain quarters is serving to further attach the Statement No. 1 legislators in their position. It is also declared that though they were once willing to go into a caucus with the other republican members, the people's choice legislators have now all agreed with the members from Multnomah county to refuse to go into the caucus, thus making it possible to organize both houses on strictly Statement No. 1 lines.

It is only widening the breach between the two factions," said Representative Libby, speaking of the attack made upon the Statement No. 1 members, "and the inevitable result will be that the legislature will be organized by Statement No. 1 and independent members."

Representative Hughes of Marion county, who was elected on the Republican voters' pledge, will vote for Calkins as he regards that pledge binding. He does not say, however, that he will continue to vote for Calkins after the first ballot, for he said he will deliver the electors when he took the Republican voters' choice pledge.

That D. Patton, the leading Statement No. 1 legislator in the county, is determined. He says:

"The first principle I learned, and that is taught by the republican party, is to keep one's pledges. The record of President-elect William Howard Taft reveals the fact that the republican party, federal judge, governor of the Philippines or secretary of war, he kept his pledges to his party and to the administration."

Mr. Patton has not given up his campaign for speaker, and in view of the fact that negotiations are under way to organize the legislature so that it may be kept in the hands of the people's choice members, he believes his chances are good for landing the position.

LAWYERS DISCUSS BAR AND BENCH AT BANQUET

Examinations, cross-examinations, demurrers, complaints, arguments and jollifiers, and all the other dry and dusty details and procedures of the law were forgotten for a few hours last night by the members of the Oregon State Bar association when some 200 of them sat down to a banquet at the Commercial club which concluded the eighteenth annual meeting of the organization.

The banquet, in fact, proved the most popular feature of the meeting, for there were four or five times as many guests present last night as had attended any of the regular business associations, a fact on which Toastmaster and ex-President R. W. Montague commented by suggesting that next year it might be well to hold the annual banquet first in the hope that it might induce a larger attendance at the other sessions.

A large number of the attorneys responded to toasts, and the speeches were interesting and witty.

Keep Out of the Rut. Taking as his subject, "The Rut," R. W. Wilbur advised his brother attorneys to avoid it, and suggested as the best course, that making it possible to take up some side line, something

outside of the law, as a diversion. L. W. Humphreys, who has recently elected to renounce newspaper work and study crime instead of criminals, very fittingly spoke on "Law and Modesty." He told a number of good stories and then, before the evening was over, he had a very dry throat in the house when he concluded.

John A. Carson, whose subject was, "Plots and Jettison," objected to the newspapers, accusing them of trying cases before the lawyers have had a chance at them.

The Dog That Came Back. J. B. Kerr took a dig at expert testimony, telling a story illustrative of the well-known value of this kind of evidence. An old farmer, whose wife refused to allow him to strike dynamite in the house buried it in the orchard—or started to do so when it exploded. The question then being, "What part of the dog is that?" an expert at \$50 a day was employed to separate them. And after the funeral the dog came back.

"Higher Ideals," was Judge M. C. George's subject, that there is more in the law than money-making. The law, he said, is an exalted profession, as is attested by the fact that a lawyer will administer the oath of office to the

new president of the United States on March 4, next. Incidentally Judge George called his hearers' attention to the necessity of their paying more attention to such details as reading, grammar and the use of good English.

Judges Too Often Blamed. D. E. Dimick of Oregon City spoke on "The Lawyer Who Indulged Too Freely in Presumption," saying that judges are frequently blamed for errors which are the fault of attorneys who are too lazy or too ignorant of the law to prepare a case properly. A. E. Clark concluded the speech-making with a brief address.

Attacks Initiative. The chief address of the afternoon was made by Judge Charles H. Carey, who spoke on "New Responsibilities of Citizenship." Judge Carey made an attack upon the initiative and referendum, which he characterized as the death of representative government. "Great danger," he said, "lies in the wholesale adoption of ill-considered and hastily prepared bills. The initiative and referendum amendments to the Oregon constitution are subversive of the representative system of a republican form of government. A limit should be placed on the number of constitutional amendments and initiative measures that may be submitted to the voters at any one election."

HENRY A. McLEAN RESIGNS POSITION

SAYS FIGHTING BOB WILL JOIN ANGELS

(United Press Lined Wire.) Los Angeles, Cal., Nov. 19.—W. J. Arkell, assistant to the president of the Los Angeles Harbor company, announces that Rear Admiral Robley D. Evans will come to Los Angeles to make his home. Admiral Evans was yesterday elected chairman of the board of

directors of the Los Angeles Harbor company, which plans extensive improvements about the San Pedro harbor. Arkell says that when he was at Washington ten days ago he saw Admiral Evans, who promised that he would come to Los Angeles this winter and make this city his home. The admiral will be here at the close of a lecture tour he is now planning.

The corporation is headed by A. C. Bird, former traffic manager of the Gould lines, and plans to do much work on the harbor at San Pedro. A railroad between this city and that port is one of the projects of the company.

Naval Architects Meet. (Special Dispatch to The Journal.) New York, Nov. 19.—Recent criticism of the design and construction of the big warships now building for Uncle

Sam's navy will be thoroughly thrashed out at the meeting of the Society of Naval Architects and Marine Engineers, which began its sessions in the Engineering Societies building in West Thirty-ninth street today. The society embraces in its membership practically all of the naval architects and constructors of any prominence in this country. The meeting will continue over tomorrow and will close tomorrow night with a banquet at Delmonico's.

PORT BLAKELY MILLS COLLECT INSURANCE

(United Press Lined Wire.) Tacoma, Wash., Nov. 19.—The officials of the Port Blakely Mill company are

in receipt of approximately \$10,000 insurance paid by the London and Lancashire and the National and Irish Millers Assurance companies of England. The English companies informed the mill owners that they believed the claim a just one and promptly paid the amount of the policies, although they might have taken refuge under a technicality. The mill was insured in English and American companies. The English companies agreed to pay losses on the same basis as the American companies, but the English have not taken advantage of the fact. The mill owners brought suit against the American companies and the supreme court of the state decided recently that the Hartford Insurance company must pay. No suit had been entered against the English companies.

Bids on Coal for Fleets. (United Press Lined Wire.) Washington, Nov. 19.—Bids were opened today for supplying 11,000 tons of coal to Panama, 11,000 tons to Magdalena Bay for the use of the Pacific fleet and 10,000 tons to be delivered at Negro Bay, Morocco, for the use of the Atlantic fleet, to be used on its return voyage after it leaves oriental waters. There were eighteen bidders. The prices ranged from \$5 to \$8.50 a ton for delivery at Panama and Magdalena Bay and from \$4.50 to 4.75 a ton for delivery at Negro Bay.
