

# HERBIANS TO HONOR MARTYRS

### Program Prepared in Memory of Allen, Larkin and O'Brien of Manchester.

Memorial exercises in honor of Allen, Larkin and O'Brien, the "Manchester martyrs," will be held by the Ancient Order of Hibernians next Monday evening, November 23, at W. O. W. hall, 123 Eleventh street. John P. Kavanaugh will be the chairman of the evening, and the principal address will be delivered by Rev. Joseph M. O'Farrell, of Eugene, state chaplain of the order. Good music has been provided for the occasion. It is expected that the hall will be filled.

Allen, Larkin and O'Brien were convicted in 1867 in Manchester, England, of the murder of police sergeant Brett, and were hanged for the crime. But the Irish people hold them guilty of the murder, and every year honor their memory. A number of Irish political prisoners were being held in a van when the three martyrs, with a number of other Irish patriots, endeavored to rescue them. In the melee a pistol shot killed the police sergeant, Allen, Larkin and O'Brien were arrested and tried for the murder and were convicted, and hanged.

"The Boys' and Girls' Aid society is governed by a board of trustees, consisting of: George H. Williams, president; F. E. Beach, secretary; J. C. Ainsworth, treasurer; Miss Helen Spaulding, Charles E. Wolverson, Dr. T. L. Elliot, Judge W. B. Gilbert, Robert S. Farrell and Mrs. Levi White. The executive committee consists of: Dr. Thomas J. "The society secures homeless, neglected and abused children from all parts of the state of Oregon, and cares for them until suitable homes are found for them. Three hundred and seventy-three children were received during the year just past, and out of this number 207 were entirely new cases.

## CONGESTION OF EXPRESS

### New Phase of Rate Cutting Shown at Hearing.

(Salem Bureau of The Journal.)  
Salem, Or., Nov. 19.—While testifying in his own behalf before the Interstate Commerce Commission in the Pacific Express company case yesterday afternoon Auditor J. A. Brewster of St. Louis said that a congestion of the reduction of express rates in the state of Nebraska that the company no longer had facilities to cope with the conditions. Receipts have also increased enormously.

According to Mr. Brewster, large quantities of goods never before handled by the express companies were placed in their hands for shipment because of pure more reasonable rates and quicker service. Likewise there was a falling off in the freight business.

At the hearing yesterday mostly documentary evidence comprising reports of commissions of other states and rates in other states was submitted.

## MOUNTAIN WATER SUPPLY

### Committee Appointed at Salem to Prosecute Matter.

(Salem Bureau of The Journal.)  
Salem, Or., Nov. 19.—Governor Chamberlain has been placed at the head of the committee appointed to secure a mountain supply of water for Salem. The governor believes that the state would be greatly benefited if a pure water supply could be furnished to the state institutions at Salem, and he will urge the legislature to cooperate with the city authorities to that end. It has not been ascertained how far Salem will have to go to get pure water. Both the Little North Fork of the Salmon and the Clatsop rivers are looked upon as favorable. Both are in government preserves. The engineers will go to work at once.

There are at Salem the penitentiary, asylum, reform school, home for the feeble minded, deaf mute school, high school, and the capitol that should be provided with a purer water supply.

She wore lace over white satin, with her veil held in place by a crescent of pearls and sapphires, the gift of the groom.

The groom was attended by Captain H. E. Crosby, Fourteenth cavalry, and best man, Lieutenant Fume and Converse were ushers.

# SECOND ROCKPILE IS RECOMMENDED

### Grand Jury Also Indicts Drs. Atwood for Keeping Tremont Establishment.

Containing few more than 100 words, the final report of the November grand jury, submitted to Presiding Judge Gantenbein in the circuit court yesterday, bears a striking contrast to the voluminous productions of the September and October juries. It is also significant, in view of the criticism offered in some quarters of the preceding juries, particularly the one for October, that the November inquirers were in session just 10 days in all, or less than half the time of each of its predecessors.

There is no sting in the November report. Although the members of the jury visited Kelly butte, they did not follow the example of their predecessors in "roasting" the management or the county court. They declare that the food and kitchen were clean, and recommend the establishment of another rockpile for the benefit of the northern part of the county by the purchase of a part of Wiberger butte.

The report concludes with a recommendation for a merit system for county prisoners and for a mill tax for the purpose of building a new courthouse. H. J. Blesing was the foreman of the jury, the other members being C. F. Clark, H. F. Clark, Gilbert Goodhue, A. A. Gabriel, W. A. Gordon and O. W. Winsford.

## MINISTER IN COURT

### Rev. George Clark Is Fighting for His Liberty.

(Special Dispatch to The Journal.)  
Roseburg, Or., Nov. 19.—The preliminary hearing of Rev. George Clark of Gardiner, who is alleged to be Rev. George C. Burckommon of Texas, on a charge of having obtained money under false pretenses, was begun today in Justice Long's court. On account of the nonappearance of the prosecuting witness only the facts pertaining to his arrest were taken up.

It is alleged by Clark's attorneys that the warrant for his arrest is defective, in that the money obtained, \$100, was merely a loan, and was repaid at any time to the man of whom he obtained it. Clark is fighting extradition. So far it has not been proved that he is the man wanted. Owing to this the case was rested until the sheriff of Throckmorton county and a man named Massey should arrive in the Philippines, and the wife of Rev. Clark's wife. The Texas sheriff and Massey will arrive here in a few days, when the case will be resumed.

## CONSOLIDATION IS DISCUSSED

### Aberdeen and Hoquiam Are Rapidly Growing Together.

Aberdeen, Wash., Nov. 19.—Considerable discussion has been provoked as to the advisability of consolidating the cities of Aberdeen and Hoquiam. The discussion was started by a letter given to the Aberdeen World by Judge J. C. Pearson, in which he advised a plan and gave some of his reasons. Mayor Frary of Hoquiam is opposed to the consolidation.

Aberdeen claims a population of 15,000, Hoquiam 12,000, with the business centers of the two cities but four miles apart. The two are rapidly growing together.

## GRAYS HARBOR APPROPRIATION

### \$100,000 to Be Recommended for Bay and River.

Aberdeen, Wash., Nov. 19.—News was received here from Washington that an appropriation of \$100,000 would be recommended for Grays Harbor. The appropriation will be used in improving the inner channel and the Chehalis river from here to Montesano.

This is exclusive of the jetty appropriation, which is ready for use at any time. The jetty has been extended 7,200 feet this season, with a total of 15,000 feet to be built next year. Work on the jetty for this season will be discontinued at the end of this month.
