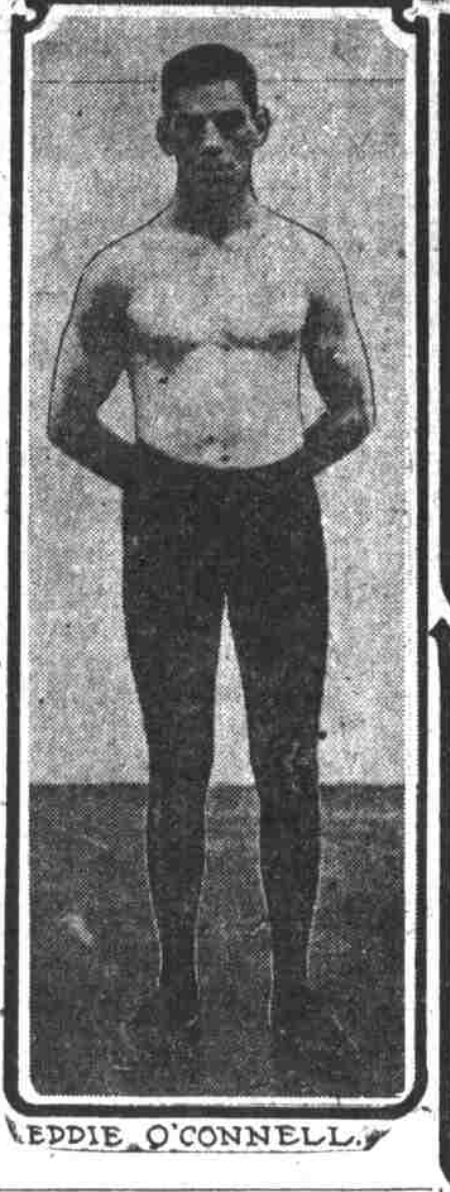
BLACK HAND THREAT TO SEATTLE WOMAN

BETTER CLASS TO GIVE BIG LEAGUE

Plenty of Good Players Are Available for Increasing Circuit Next Season.

(United Press Leased Wire.)
San Francisco, Jan. 7.—The new classification of the Pacific coast league with the added powers conferred upon the organization by the national commission will permit the league to have six clubs during the coming season, according to a well known baseball man here today. Heretofore the league in its desire to expand has been handicapped by the lack of enough good players to make up a strong six or eight club organization.

The new classification will permit the clubs of the Pacific coast league to draft from organizations beneath them and enough good players will become available to permit of a strong six or eight club organization.

Nothing will be done in regard to changing the circuit until President Cal Ewing returns from the east. Two new clubs, probably in Sacramento and Los Angeles, will be added in order to present a stronger front to the outlaw state league.

The drafting privileges are extensive. The "AA" league has first call on all players drafted by the majors who fail to make good in the two big leagues. The Double A league is also permitted to draft territory from the minors under certain conditions. Furthermore the number of players carried in reserve by the major league clubs shall be limited.
