

DOSE MAY GET MORE MONEY

Ways and Means Committee of Council Will Make Annual Appropriations for City Departments Today—Need for New Jail Urged.

The ways and means committee of the city council is in special session this afternoon to make the annual appropriations for the various city departments. In all likelihood the sums allotted to each several weeks ago, will be followed very closely, although it is probable that the police fund will be increased in some manner if it is possible. Mayor Lane said this morning that at least enough money out to be provided for this department to build a new jail on the east side of the city.

Needs of Police.

"We need several more patrol wagons and horses. Gasoline speeders and an automobile are also needed. Without the police force cannot well do without and give efficient service. If a hurry call comes upon the city, the chief is up against it at the present time. Another department that must have a liberal appropriation is that of street cleaning. During the past five years the work of this department has increased and the present appropriation is not sufficient to do the work. We have 300 miles of streets and 400 miles of sidewalks. The force employed by Superintendent Donaldson cannot begin to do satisfactory work. He is only allowed \$1 a day per mile by the last year's appropriation.

"JIM" SHEA UNITED STATES MARSHAL FOR DAKOTA HERE

James P. Shea, United States marshal of North Dakota, an old Indian scout who was discharged from Custer's command just previous to the famous Little Big Horn massacre, an intimate friend of the great Indian chief and medicine man, Sitting Bull, who nicknamed him Te-ton-ke-ona-chin, and a man who knows the Indian country, including President Roosevelt, is in Portland. He is visiting Ormsby McHarg, who is here in the interest of the national Republican league, Dr. Townsend, special assistant to the attorney general, and other North Dakota people now in Portland.

Mr. Shea registered at the Hotel Oregon Saturday, having brought a prisoner from North Dakota, one of the Washington state prisoners. He came down here, as he says himself, just to knock about a bit and see how the boys are getting on in the world. In North Dakota Mr. Shea is "Jim" Shea—and by that name he is known to most all the people in the state. He never had a title of colonel or anything else, and furthermore says he doesn't want any title to the name. He was given him by Sitting Bull in his days, he also used to be known as "Joe Bush" the scout.

"Jim" Shea is a typical plainman of the early days and reminds one of the sort you read about in the magazines. He is a broad, big fellow, with a long straight in the eye, has a slow, easy going manner about him, weighs about 200 pounds and talks like a man who accomplishes whatever he sets his mind to. He wears a mustache and his hair is of the light slouch variety.

He also wears a hat which he carries to his grave as proof of his service for the government in old Indian wars. In his right pocket there is a gun, but this is mere speculation. "Jim" Shea isn't a man who would use a gun unless there was really something going on.

"Jim" Shea was honorably discharged from General Custer's command December 18, 1874, for his part in the Battle of Big Horn, one of the most famous battles by the Indians in American history. Charley Reynolds, known as "Lone-
