Thrilling Experience of a Steamer—Chicago Stores Are Forced to Assist Employes Several Deaths and Many Injured.

Chicago, Jan. 30.—The most thrilling incident of the widespread storm in this section was a battle of the steamer City of Marquette against Lake Michigan, as it fought its way in a sinking condition along the Illinois shore from Chicago to Milwaukee.
With the firemen standing in water up to their waists and shoveling coal into a feeble fire, the boat limped into Waukegan early in the morning and left Chicago. Before it reached its dock the tide had to be broken by the work of the boat which was shattered by the waves that broke over it and it was only by great exertions that it was kept afloat.
