BIRDS OF FELLOW PERIL DAY SPEECH

C. O. Young Springs Surprise on Great Audience in the Armory—Strikes at Evil of Wage Slavery—Mayor Lane Pays Tribute to Martyr President.

More than 2000 persons gathered at the Armory yesterday afternoon to honor the memory of Abraham Lincoln on the occasion of the centennial celebration of the anniversary of his birth. Several addresses descriptive of the life, character and achievements of the martyr president were delivered and interspersed with vocal and band selections. Vigorous applause greeted every mention of the name of Lincoln. Mr. McCamant gave the history of Lincoln's life, both public and private, in detail but with the most part on certain incidents in the public career of the great president. Frequent during the oration, eulogistic allusions were made to the martyr president, the mayor in turn introduced Wallace McCamant, who gave an oration on Abraham Lincoln. Mayor's Address Is Brief. Mayor Harry Lane spoke briefly. He said: "Not in 100 years before or after his birth has this or any other country given rise to so great and good a man, not wise a man, not a man of such grand and noble traits, as Abraham Lincoln."

"Laying aside any reference to his far seeing wisdom, his high character and patient was he through all the trying cares that were his. A sad man, seeing well the terrible distress of his people, with a keen sense of humor, courageous and hopeful, with a charity to his enemies that overcame their spitefulness, the nearest approach to the blessed Nazarene of any man of whom I have ever read."

Young Springs Surprise. C. O. Young, speaking on the subject of "Lincoln and the Laboring Man," sprung a decided surprise by preferring to the Asiatic immigration and labor question. Said the speaker: "Lincoln said this nation could not live half free and half slave. And from digress here for a moment. This nation can not live half Asiatic and half white. When yellow races are placed on the old flag, citizenship is granted to those people who are not entitled to it, then you shall see gradually and surely, by step, the white man going from the west until it will be known no longer as the paradise and beauty spot of the continent. It will be blighted and scourged by a people whose mode of life, habits, religion and traditions are inimicable to Caucasian civilization and development."

The speaker contended that cheap labor meant slavery. "Our organization stand for abolition of all forms of servitude," he said. "In order to attain that we must be free to speak and write as we please, and at times we must speak in criticism of our courts we do not desire the overthrow of that institution; but we do insist that the constitution extend to that of legislation. Lincoln believed in the union and its preservation. We believe in the union and \$1,000,000 of us are pledged to preserve it. Lincoln believed in our kind of union also. "We will persevere, though the organization of employers representing \$30,000,000 may attempt to defeat justice. In spite of that in spite of judge made laws we will fight. We did Lincoln, the battle of the oppressed until victory will be realized and justice be done, cost what it may."

This last is considered a direct reference to the employers' association of Oregon recently organized to replace the Citizens' alliance and is almost positive evidence that the unions do not regard the body as an organization with a peaceful mission. Mr. Young yesterday would make no direct statements for publication. "America" was sung by all those present. Mr. Young and Mr. Bowman leading. Rev. C. E. Cline, himself a civil war veteran, in the absence of Archbishop Christie, pronounced the benediction. "Stars and Stripes Forever" was played by Brown's band as a finale to the exercises.

In his address he took occasion to denounce money greed and the evils of worship and child labor. Dr. John B. Wise delivered an eloquent eulogy. Prophetic chants by male voices responded to by the female voices formed an impressive choral structure.
