

BRANDENBERG IN TROUBLE AGAIN

Admits Kidnaping Cabanne
Boy, but Justifies
the Act.

(United Press Leased Wire.)

San Francisco, April 24.—Broughton Brandenburg, the author, under arrest here as a fugitive from justice in connection with the kidnaping of the famous posthumous Cleveland letter during the last presidential campaign, today related how he abducted James Shepard Cabanne, Jr., a child belonging to one of the most famous families of St. Louis, and brought him with him to San Francisco.

The boy, who is 8 years old, is Brandenburg's stepson, the writer having married the lad's mother after she was divorced from James Shepard Cabanne, Jr. The first James Shepard Cabanne was a multi-millionaire and a leading figure in the St. Louis metropolis. In his later years he lost his money, however, and died almost a pauper.

Brandenburg said he heard the boy was being cruelly mistreated by his father, and he went to the family residence at 5355 Cabanne place, St. Louis, and saw the boy. He says his stepson was ragged and dirty and he was eager to escape from his father.

He had only 15 minutes in which to buy him a new outfit of clothes, said Brandenburg, "but we made it. At Union station the boy climbed into a big wicker hamper marked 'perishable surgical instruments,' and he was carried through the gates. Then he slipped out and got into the berth with me. After that it was easy, and he was very happy. I took the boy with the consent and knowledge of his mother. The boy was in bad shape and having a bad time of it. He was delighted to get away and was happy until they threw us in jail last night. They cannot charge me with kidnapping, because no money was ever appointed for the lad after the divorce proceedings.

While James Shepard Cabanne II still occupies the family mansion, Brandenburg says he is almost entirely without funds and was unable to care for the boy.

Brandenburg today retained Jacob Meyer, an attorney who has a reputation for handling highly technical cases, and placed in Meyer's hands the decision as to whether he will fight extradition.

Local police today, wired the St. Louis police asking if the boy is wanted there and asking what shall be done with him.

A Cleveland letter was sold by Brandenburg to the New York Times, August 30, 1903, for \$500. Its importance in the campaign, as coming from the famous Cleveland, was enhanced greatly by the fact that Cleveland was represented as praising Taft and criticizing Bryan. It caused a great deal of investigation led to the arrest of Brandenburg. After being taken to New York and released under \$1500 bail, Brandenburg left Manhattan, assuming the name of W. Lorimer Leonard.

Says No Chance With Jerome.

He went to Harrington, Del., where he remained in hiding for a time before coming west via Buffalo, St. Louis, Denver and Ogden.

His case was called in New York February 1, when he was again arrested. The New York detectives had since sought him. The first clue was found when the Cabanne boy was abducted from St. Louis, and the investigation led to the arrest of the writer when he reached this city last night.

"I will probably go back without a fight," said Brandenburg, "but it is practically a hopeless move, as no poor man has a chance with District Attorney Jerome. Neither my lawyers ever saw the paper which I am charged with forging, and all we know of it is what the prosecution has made public.

"Jerome has given me the worst of it at every turn. I have no friends and no money. He has lived up to his great interests, and it has been decreed that I shall be punished for a crime which I never committed and know nothing about.

"Cleveland Letters Correct."

"The Cleveland letters were written by the former president, and they were correct and no change whatever was made in them. The three were three of the letters, but the publication of the first started the trouble.

"The boy, who is a little fellow, still claimed his name as 'Billy Leonard' today, not having received any order from his stepfather to change his name. The little fellow said he did not want to go back to St. Louis, and that he was happier with his 'step-dad' than anyone else.

Brandenburg said today that while he was in hiding at Harrington, Delaware, he lived under the name of Dr. Carl Eberhard and pretended to be a German physician. He wrote anonymously for papers and magazines by which he had been employed as a staff writer, and whom he knew intimately wrote him the polite notes that they send to unknown authors and regretted that most of his matter was 'not available for their special purposes.'

paign further. They have not given up, but are thinking deeply.

Liquor Interests Unite.

Today the center of the battle is the excise board petition. The liquor interests' association, the brewers and the backers of the Gothenberg association have all joined hands against it. Under the direct management and direction of Mr. Sinnott, an attorney for the liquor men, a large force is at work checking the petition with demagogues from the city auditor's office, all watched by D. A. Pattullo, Miller Murdoch and S. H. Gruber in behalf of the Municipal Association, and Francis I. McKenna, father of the petition.

Although he denies it, it is the general assumption that Al Crofton, the general of the liquor forces has been brought back to the leadership of the liquor efforts. It is expected that he will be secured. It is expected that this alone will practically invalidate the petition.

In addition to this work the checking so far done this morning has revealed a high percentage of bad signatures. In precinct 32, McKenna's own precinct, as high as 15 and 16 out of each 20 signatures have been thrown out since the work began. In the opinion of attorneys, Sinnott the petition will surely go off the ballot.

The excise board petition has a total of 235 signatures. To be put on the ballot the law requires that it have approximately 200. It will be necessary therefore to throw out some 120 names to invalidate the petition. Mr.

Sinnott says it can be done. Mr. McKenna, on the other hand says the petition is good.

McKenna is Confident.

"The petition was circulated by reputable people," he said this morning. "I do not believe there is anything in the forgery. I have examined and read the signatures as they were brought to me by the men who had secured them. Before I read the signatures, they looked all right to me. The more the thing is stirred up the better it will be for the petition, for I believe if there are any mistakes they will be trifling ones, and the petition will be found to be valid."

Just as confident on the other side is Mr. Sinnott that the petition is bad. "After a page of names are palpable forgeries," he said. "Any one can see it. McKenna before he put his notarial seal on the petition should have noticed if they are plain to any one with half an eye."

City Auditor Barbur will check both the excise board petition and the Gothenberg petition as rapidly as possible. Beginning Monday the work will be carried on night and day until completed. This city auditor is allowed until 20 days before the election in June, or until May 15, to finish his checking. Then if the backers of any petition consider that their petition should be on the ballot, after the city auditor has declared against it, they may bring mandamus action against him and try it out in the courts.

STODDARD, NOTED AUTHOR, IS DEAD

Pacific Grove, Cal., April 24.—Charles Warren Stoddard, the famous western author, died at his home at Monterey at 10 o'clock last night. He was 66 years of age. He had been ill for three months and had been confined to his bed for the past three weeks.

Stoddard was one of the best known writers of the west. He was a member of the Bohemian club of San Francisco in the days of "Coffee John," and gained considerable fame while abroad as manager for Mark Twain.

He was born at Rochester, N. Y., August 7, 1843. He received his early education in the public schools of his native state and of California. His collegiate course at the University of California was interrupted by failing health and he abandoned it to take up a course of travel. For seven years he journeyed abroad, visiting almost every part of the world as a special correspondent for the San Francisco Chronicle.

Upon his return to this country, the degree of L. H. D. was conferred upon him by the Catholic University of America, and that of Ph. D. by Santa Clara college. From 1885 to 1887 he occupied the chair of professor of English literature of Notre Dame university, Indiana, and in 1888 he was named for the same chair in the Catholic University of America.

Among his writings that gained him a national reputation are "The Wonder Worker of Padua," "In the Footprints of Padres," "The Isle of Tranquil Delights," "The Legends of Molokai," and "The Dream Land."

STANFORD ME 'HANG AN EFFIGY

It Is of Kentucky's Governor
for Pardons in the
Goebel Case.

Frankfort, Ky., April 24.—Governor A. E. Wilson was hanged in effigy here today following the announcement that he had pardoned former Governor W. B. Taylor, former secretary of state Charles Finley and others charged with complicity in the murder of Governor William Goebel in 1900.

Bearing aloft the effigy of the governor, a mob of several hundred persons proceeded to a bridge over the Kentucky river. Amid the shouts and jeers of the crowd the figure was swung from a support of the bridge.

Upon the breaking of the figure was fastened a placard denouncing the act of the governor and announcing a determination to show that there is such a thing as mob law.

Besides the two former state officials who were the recipients of the gubernatorial pardon, immunity was granted to John Powers, brother of Caleb Powers, believed to be in Honduras, and to John Davis and Zach Steele, who were also under indictment in regard to the Goebel case.

Those over whom indictments are being hanging are: Wharton Golden, now in Colorado; Frank Cecil, a railroad detective in St. Louis; and William C. Culton, said to have died in the west a few months ago. These cases, with the possible exception of that of Cecil, will be dismissed.

Reiterating the belief he expressed some months ago when he pardoned Caleb Powers and James S. Howard, that no one but Youtsey had part in the murder, and that it was not a conspiracy, Governor Wilson said he believed that to pardon Taylor was "a sacred duty which I must no longer delay to carry into effect."

LA GRANDE AND

INDIAN LANDS NEAR
BAKER CITY FOR SALE

Washington, April 23.—The Indian Bureau will sell to the public 5500 acres of land near Pendleton, mostly near Baker City, which the government gave the Wyandott Indians 15 years ago. 70 tracts of 50 acres each. A quiet offer was made to the government by one Kuckuk of Wisconsin of \$5.50 an acre at Pendleton Chamberlain's suggestion, however, the bureau will probably advertise for highest bidders, as there is some reason to believe the lands are valuable.

SHINN KIDNAPED
BY DETECTIVES

Alleged Fugitive From Justice in Minnesota Falls Into Trap.

Falling into a trap laid for him by the district attorney's office, John Shinn, former county treasurer of Beltrami county, Minn., was released, requested and hurried out of the state to Vancouver yesterday afternoon. Then he was placed on a train for Minnesota, where he is charged with embezzling \$55 of the public funds. Shinn was taken before Judge Gantenbein in the circuit court yesterday afternoon on an application for a writ of habeas corpus. His attorney, John A. Jeffrey, asked for a postponement until today. Deputy District Attorney Vreeland then arose and confessed the writ. Shinn walked out a free man, but when he reached the sidewalk he fell into the hands of Detectives Coleman and Price, who were in waiting with an automobile.

Shinn was at once taken to Vancouver and left there in charge of Sheriff A. B. Hazen, who came from Minnesota for him. Shinn had been working here as a janitor.

PROSSER HIGH
SCHOOL ON LIST

Prosser, Wash., April 24.—Professor Charles Timblin of the State college was a Prosser visitor yesterday, coming for the purpose of inspecting the Prosser high school, which he did with extreme thoroughness.

Prosser high school was placed probationary on the accredited list two years ago, and before making it a permanent proposition the state board felt that they wished to know the exact condition of the school, hence Professor Timblin's visit. In an interview the professor said:

"I am highly pleased with what I saw of the school and its work, and shall most heartily recommend that it remain permanently on the accredited list."

There is an attendance of 60 students at the high school this year, of which seven are expected to graduate at the end of the term.

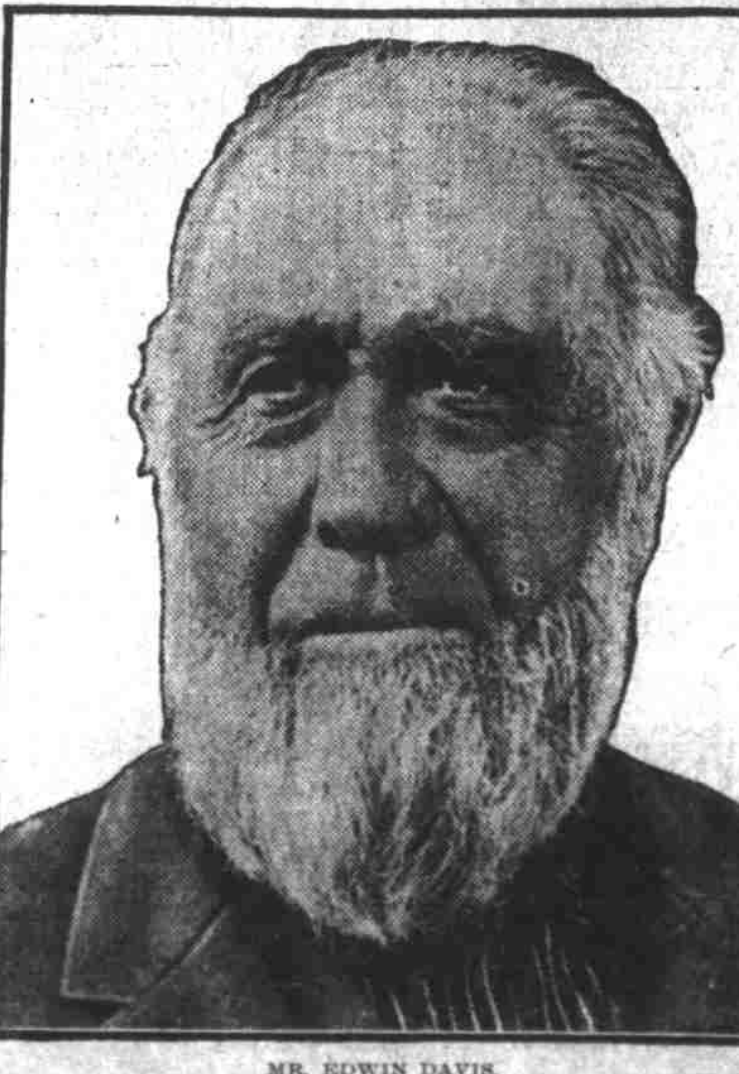
