

FINISHING TOUCH ON NEW SULTAN

Mehemmed VI Is Invested
With Sword of Othman—
Foreigners Excluded.

(United Press Leased Wire.)
Constantinople, May 10.—Mehemmed VI, sultan of Turkey, was invested today with the sword of Othman. This ceremony is the last of those attending the coronation. No foreigners were allowed to witness the ceremony, which took place in the Mosque of Aya Sophia. The only mosque in Constantinople where none but Turks are allowed to go. Foreigners were not even allowed to congregate around the entrance to the mosque. A stand had been erected to block away from the distinguished foreigners and members of the diplomatic corps who wished to see the public procession.

PORTO RICANS MUST BE CURBED

else pull down the whole government. This spirit, which has been growing from year to year in Porto Rico, shows that too great power has been vested in the house of delegates and that its members are not sufficiently alive to their oath of responsibility for the maintenance of the government. To justify congress in further reposing in their absolute power to withhold appropriations necessary for the government's life.

Rule Works in Other Islands.
"For these reasons, I recommend amendment of the Foraker act providing that whenever the legislative assembly shall adjourn without making the appropriations necessary to carry on the government, sums amounting to the appropriations made in the previous year for the respective purposes shall be available from the current revenues and shall be drawn by the warrant of the auditor on the treasurer and countersigned by the governor."
"It is a provision applies to the legislatures of the Philippines and Hawaii and it has prevented in these two coun-

tries any misuse of the power of appropriation.

Plan Suggested to Delegates.

"The house of delegates sent a committee of three to Washington, while the executive council was represented by the secretary and committee consisting of the attorney general and the auditor. I referred both committees to the secretary of the interior, whose report with a letter from Governor Post, and the written statements of both committees, accompany this message.
"I have had one personal interview with the committee representing the house of delegates and suggested to them that if the house of delegates would pass the appropriation bills without insisting upon the passage of the other bills by the executive council, I would send a representative of the government to Porto Rico to make an investigation and report in regard to the proposed appropriation."
Their answer, which the president quoted, showed that the committee was not in a compromising mood.

Porto Ricans' Aboard Complaint.

"The president continuing, enumerates the many advantages secured to the people of Porto Rico under American control, both educational and commercial and combats strenuously the claim of the representatives of the house of delegates that they were subjected to 'political oppression and a much less liberal government than under that of Spain.'"

"It is idle," he says, "to compare the political power of the Porto Ricans under the royal decree of 1897, when their capacity to exercise it with benefit to themselves was never in fact tested, to that which they have under the Foraker act. The question we have before us is whether their course since the adoption of the Foraker act does not show the necessity of withholding from them the absolute power given by that act to the legislative assembly over appropriations, when the house of delegates, as a coordinate branch of that assembly shows itself anxious to use such absolute power, not to support and maintain the government, but to render it useless."

Too "Easy" Harbors.

"If the Porto Ricans desire a change in the form of the Foraker act, this is a matter for congressional consideration, dependent upon the effect of such a change upon the real progress of the island. Such a change should be sought in an orderly way and not brought to the attention of congress by paralyzing the arm of the existing government. I do not doubt that the terms of the existing fundamental act might be improved, certainly in qualifying some of its provisions as to the respective jurisdictions of the executive council and the legislative assembly and I suggest to congress the wisdom of submitting to the appropriations committee this question of revision. But no action of

this kind should be begun until after, by special amendment of the Foraker act, the absolute power of appropriation is taken away from those who have shown themselves to be irresponsible to enjoy it. In the desire of certain of their leaders for political power, Porto Ricans have forgotten the generosity of the United States in its dealings with them. The present development is only an indication that we have gone somewhat too fast in the execution of political power to them for their own good."

No Evidence of Oppression.

"The change recommended may not immediately convince those controlling the house of delegates of the mistake they have made in the extremity to which they have been willing to resort for political purposes, but in the long run it will secure more careful and responsible exercise of the power they have."

"There is not the slightest evidence that there has been on the part of the governor or any member of the executive council a disposition to usurp authority or to withhold appropriations such legislation as was for the best interests of the island, or a lack of sympathy with the best aspirations of the Porto Rican people."

"Wrote" Story For Paper.

"Now, if you want a story, little one," went on the lady with penciled eyebrows and painted lashes, "just read this." As she spoke she handed the reporter a Seattle paper which contains her autobiography in four chapters. At least, she said she wrote it. Anyone who has talked to her would have reason to take her statement with mental reservations. The story reads like a chapter from "Haughty Molliebell." Following is a paragraph of the four chapters "Life":

"At 6 years of age, I was put in a convent by my parents and there under the gentle tutelage of the nuns, I spent the next eight years of my life, growing into girlhood under the influence of the cloister and the veil. Those were golden years, full of peace and contentment, the busy, bustling world seemed far away, remote, almost unreachably. I heard its noise and confusion, of course, but at that time, in

my first years in the convent, it neither beckoned nor called to me. My mind was unfolding under the guidance of the good nuns and I was happy. Life then could be typified by a smiling sky, laughing waters or a shady brook. There was flow nowhere."

The story as told by Mrs. Moore and as it appeared in the Seattle paper, was the same as to facts, but the insouciantly joyous slang of the woman was missing in the written article and it is doubtful if she knew the meaning of half the words on the printed page. If she did she never used any of them in her conversation.

Was Born in Old Kentucky.

Mrs. Moore says she was born in Louisville, Ky., and spent eight years of her life in a convent. Meeting Frank Moore at the age of 14 she eloped with him and, after circling the globe, came back to New York, where they spent some time before starting west. Her little daughter, she says, was born in Italy. This little girl, a child of 6, was brought to Seattle where her husband went into the mining business. Continuing the story of her life she went on to say:

"Mr. Moore went to Fairbanks, Alaska, where he struck it rich in the mines. He came back about two years ago on account of ill health. About this time I met Oris Hamilton, who was associated with my husband in a business way. Oris told me that Mr. Moore gave him some fat commissions. 'My husband found it necessary to go to Mexico to be treated for tuberculosis. Soon after, I went over to Japan and China, leaving my little girl in charge of a friend at Oakland. While I was in the orient I 'sure' had a nice time. Nothing but the best hotels for me, you bet."

Tells of Experience in China.

"From China I went to Vladivostok over the Trans-Siberian railroad and from there to St. Petersburg. I then joined my husband in London and came on home with him to Seattle. I have been around the world twice now in my travels. Gee, but it's fun, traveling."

Mr. Moore was obliged to go to California again for his health last October. He died in December at Riverland, his home, where it was buried. I returned to Seattle in mourning."

Mrs. Moore called special attention to the word, mourning, as if she wished to impress her listeners she knew that mourning was the correct thing.

While she said her late husband's home was in England she hesitated when asked the name of the city or town in England to which the body had been sent and finally said she did not want to tell it. She refused to fix dates or places used in her story and could not name a single person who had ever seen the man to whom she says she was married.
Mrs. Moore said she was leaving Seat-

tle not to escape being called in as a witness in the case of the state against Hamilton, but simply to put her little girl in care of a friend at Oakland, where she will go to school. This friend's name, she would not disclose, but the little girl who talked to the reporter before he saw her mother, said she was going down to visit "grandma and Aunt Bessie."

Mrs. Moore's daughter is 6 years old and a lovely child who bears but faint resemblance to her mother. The little maid has perfect blue eyes and light golden hair. Her mother is a brunette with brown eyes and dark, bronze hued hair.

Shows One Tender Thought.

One thing, and only one, favorably attracts one to the woman who is reputed to have led the Washington guardsman through devious paths and finally out on the broad road which leads to the grim gates of the penitentiary at Walla Walla. When she was asked for a picture of her daughter her eyes turned quickly to her baby, who had gone to school in the chair opposite, and for a moment the lines about her face softened under a tender light from the eyes that had glinted hardily but a minute before.

"Oh, please don't put the kid in the story, mister, leave her out, won't you?" she begged. "Little Margaret can't help being my child, and I don't want her to be mixed up in this publicity."

residence of Mrs. S. Montgomery, 615 Leo avenue, and from there took an umbrella. He then went to the residence of a Mrs. Reed, on Milwaukee street, and left the umbrella stolen at the Montgomery residence. From this place he went to the residence of John Kaufman, 558 Leo avenue, and there took another umbrella and a box of matches. The matches were found on him when arrested.

Then the young porch climber went to the residence of W. C. Williams, 1501 Milwaukee street. Here he took a coat belonging to a son of Mr. Williams and a gold watch belonging to Mrs. Williams. This is the watch which he attempted to get rid of just before his arrest. Leaving the Williams residence, where he had been heard prowling around, he proceeded to the residence of J. C. Locke, 569 Leo avenue, where Mr. Locke heard him and notified the police. Here he took a gold watch, but was evidently frightened and dropped the watch on the window sill. Then he went to the dwelling occupied by Frederick Brown and found a mite box, the property of one of the Brown children, and this he broke open and took from it a number of pennies. Leaving the house, he came almost face to face with the officer, who subsequently captured him.

Entered Through Windows.
