LAWYERS PICK LUCKY'S BONES

Million for Widow; \$150,000 for Daughter; \$600,000 for Themselves.

(United Press Leased Wire.) Los Angeles, May 12.—The alleged inside history of how the distribution of the millions of E. J. ("Lucky") Baldwin was rearranged so as to give the noted horseman's widow \$1,000,000 instead of the bequest of \$150,000 left by her husband, came to light today. Incidentally, it has been admitted that the attorneys who made the settlement with the Baldwin heirs obtained \$600,000, not \$100,000, as hitherto stated, for themselves for their pains—one of the largest legal fees ever paid—in addition to the \$1,000,000 for the widow. Just how this amount will be divided

between Governor Henry T. Gage and Gibson, Trask, Dunn and Crutcher of this city and Garrett McGovern of San Francisco never will be known. This the attorneys have agreed to keep a profound secret. It has been learned that the method said to have been adopted by this formidable array of legal talent to break the famous Baldwin will, without having to ask the intervention of the courts, was to threaten legal proceedings to break the will and get the widow's third, by proving that the turf king was insane when he made the will and unduly influenced by the women with whom he is known to have consorted. When the first steps were taken the attorneys are said to have agreed to undertake what was virtually a gigantic gamble. They are said to have agreed with Mrs. Baldwin that in any case they would pay her at least the \$150,000 left her in the will, and that they also agreed to foot all the expenses of a contest, should one prove to be necessary. As a result they are winners all around. Mrs. Baldwin receives \$1,000,000 instead of \$150,000, and the attorneys divide the rest of \$850,000. Mrs. Rose Eida Robinson Selby, a daughter of Baldwin, who lives in Oakland, made a settlement without the aid of an attorney, by which she receives \$150,000.

HEPBURN KNEW OF SUGAR GRAFT FOR TWENTY YEARS

(United Press Leased Wire.) Washington, May 13.—Former Representative Hiepburn of Iowa today told President Taft that the government had been robbed by means of fraudulent weighing of sugar for the past 20 years, to his knowledge. He stated that 18 years ago he was a member of a committee appointed to investigate the customs bureau at New York and that he discovered flagrant evidence of bribery and corruption. He explained that he had been called to tell the president about this investigation so he might investigate the report by Whitehead, Chance and himself at that time.

Inundation From Kern River.

(United Press Leased Wire.) Bakersfield, Cal., May 12.—Hundreds of farmers about the Kern river who have been working night and day to prevent inundation of their lands today gave up the fight and relinquished to the flood 10,000 acres of wheat and barley lands. A few in desperation are still fighting, but the breaks in the levees grow hourly. Farmers declare the present trouble is traceable to the refusal of large cattle owning firms to permit the farms to repair the levees before the melting mountain snows swelled the river.

Forest Fires in Vera Cruz.

(United Press Leased Wire.) Cordoba, Vera Cruz, Mexico, May 13.—Forest fires sweeping before a prevailing south wind have destroyed ranches, crops and immense tracts of underbrush throughout the state of Vera Cruz, and unless rain falls soon the damage will be incalculable. Many buildings have been destroyed and many families are homeless. The cane crops have suffered severely and there are few cattle which have not sustained heavy loss. Great numbers of cattle have been killed and distress throughout Vera Cruz is becoming keen.

C. & E. ROAD IS MADE DEFENDANT

R. R. C. Starts Suit for Non-Compliance With Order to Build Depot.

(By Journal Leased Salem Wire.) Salem, May 12.—Action has been started against the Corvallis & Eastern railroad by the state for the recovery of the penalty imposed by the railroad commission act for not complying with an order of the railroad commission issued last summer to the effect that the depot be erected at Lyons, a point on the Corvallis & Eastern railroad in Linn county. The penalty for a violation of such an order is a fine of from \$100 to \$1000. The complaint was forwarded to Albany yesterday to be filed in the circuit court for Linn county today. The case will be tried in that county, and the fine will be assessed by the court. Upon a petition of the citizens of Lyons, a year ago the railroad commission held a hearing, at which it was determined that the Corvallis & Eastern should erect a depot for the convenience of the passenger traffic, and for receiving freight. The depot was to have been built within 45 days after the receipt of the order. The order was received in July, 1908. No step toward a compliance with the order has ever been taken by the railroad company.

KLAMATH MAN SAYS HE WAS SHOT AT

(Special Dispatch to The Journal.) Klamath Falls, Or., May 13.—Dave Liskey swore to a complaint alleging that Phillip Oden, one of his neighbors, had fired upon him with a rifle, that the bullet passed through the front of his coat. Oden is a young rancher and it appears that he has had more or less trouble with the Liskey family. He had warned them not to come on his premises. He had stated that in case of trespass he would fire to kill. This is the substance of the story told by Liskey, except that he went to cross the Oden premises last Sunday when he was fired upon by Oden. Oden was arrested and held to await the action of the grand jury in the case of \$500. He gave bond and was released. Liskey, the complaining witness is a brother of Charles Liskey, who was convicted and sentenced to the penitentiary last winter for stock rustling. It is the general opinion that the shooting Sunday is the result of the bad blood occasioned by the stock rustling of recent years.

KELLY AND PAPKE TO FIGHT AS FOES

(United Press Leased Wire.) San Francisco, May 13.—Hammering each other with verbal blows, Hugo Kelly and Billy Papke are engaged in a spirited contest today while they train for their physical encounter at the Mission arena next Saturday afternoon. Papke is particularly bitter against Kelly because the Italian made such a good showing in each of their three battles. Kelly is "sober" because he thinks he was robbed of the decision in his last meeting. Both men look to be in fine trim and the confidently expect Kelly to make the best showing of his career.

BUSINESS MEN FOR M'FATRIDGE

Circulating a Petition to Leupp to Reestablish the Status Quo.

(Special Dispatch to The Journal.) Pendleton, Or., May 12.—Business men of Pendleton have wired the Commissioner of Indian Affairs Leupp, who has been located at Phoenix, Arizona, to come to Pendleton to make a personal investigation of charges against Agent McFatrige. This action has been taken in the hope that Acting Commissioner Valentine, who sent Dr. McCreary here to relieve McFatrige, will be overruled. It is thought Commissioner Leupp is favorable to Agent McFatrige and that if he can be induced to come to Pendleton he can be convinced that it is to the best interests of all parties concerned that McFatrige remain in charge of the Umatilla agency. All of the business men are pulling together and are circulating a petition asking that the action of the acting commissioner be reconsidered. It developed today that the entire number of employees at the Indian school, about 15, have been transferred to other schools by the recent orders and letters of the commissioner. The letter states that this action is taken to entirely remove sources of former friction. Nearly all of the number have been transferred at slightly higher salaries.

BONI SAYS ANNA IS LEAVING DE SAGAIN

(United Press Leased Wire.) Paris, May 12.—The charge that Princess De Sagan, formerly Anna Gould, is about to separate from the prince, whom she married a year ago, was renewed today by Maitre Bonnet, representing Count Boni De Castellane, Anna's former husband. Bonnet appeared in court when the hearing was resumed in connection with Boni's appeal from the verdict by which Anna was given custody of the Castellane children. Anna's counsel denied the allegations, and the old charges of unfitness for parental care were offered on each side.

CHIEF SLEUTH OF RUSSIA CONDEMNED

(United Press Leased Wire.) St. Petersburg, May 12.—M. Loupshin, former director of the secret police, was convicted today of belonging to a criminal association. He was sentenced to five years' imprisonment. This sentence will be passed upon by the czar, whose approval is necessary before it becomes effective.
