

ESTACADA'S 4TH YEAR ELECTIONS ENDS

City Election at Clackamas Town Today Will Determine Strength of Warring Factions—Reed Ticket Expected to Win.

Estacada's Municipal Fight.
January 14, 1904—City officially launched on its career: town is incorporated and J. W. Reed is chosen mayor. Waterworks question arises and causes first dissension among the citizens, one faction supporting J. W. Reed, the other W. A. Heylman, the present mayor.
June, 1904—Estacada votes dry by a majority of 27, under the Heylman administration. Alleged violations of the local option law precipitate bitter fight in courts in which local option people are victorious.
May 15, 1905—Recall election is held and the Heylman administration is defeated, J. W. Reed and his ticket being elected. Mayor Heylman and the city council refuse to canvass the vote. An appeal is taken to force action by the council, but the court takes case under advisement until after the annual city election today.

Estacada, Or., June 8.—Four years of bitter municipal strife and court battles are being settled by the ballot at Estacada today. Vibrating with the intensity of repressed feeling the little city awaits the result of the vote on two rival tickets.
In the city hall, where the balloting is taking place, Sheriff R. B. Beatty of Clackamas county and Deputy Sheriff Edie and Constable W. A. Jones are present. Though no demonstrations have occurred there is a dangerous calm and an outbreak would cause little surprise.
The voting strength of Estacada is placed at between 100 and 120 and every voter as well as many women is at the city hall. It is generally conceded that the Reed ticket will win, though the probable majority is uncertain. Every voter who has not paid his poll tax is being challenged by Heylman partisans. It is believed that this will cut down the vote one half.

Full Vote Is Expected.
Both sides have done all that could be done to arouse interest, and it is likely that when the polls close tonight every man entitled to the franchise will have registered his preference for officials to govern his warring municipality. Settling the question of supremacy will not necessarily settle the dispute, but it will settle the factional strife which has existed and may continue to exist for many years.
When the legislature of Oregon granted to the little city on the Clackamas river the charter of rights four years ago, it was one of the most liberal community struggle, involving every interest of the town and every citizen to some extent. Yet, such was the case, that the day when the franchise was first given, a division has existed, not like the divisions in most towns, but one where bitterness and bickerings were carried almost beyond human endurance.

The Water Controversy.
One of the first public utilities which Estacada needed was water. The city council undertook to provide a city system by purchasing a lot of pipe and having it laid down by a private contractor and for this purpose bonds were voted to the amount of \$10,000. At the time the bonds were voted, the city was indebted to the amount of \$10,000, and the interest against the town and city was not and could not be a claim against the credit of the city.
The improvement was another bone of contention, and when it was proposed to grade the streets and make permanent improvements by issuing bonds against the abutting property, an injunction was issued at the request of W. A. Heylman, and the proposed work was abandoned. The question of expense was the rock upon which the town was divided hopelessly. Since that time planning has been laid in different directions to make the streets available for heavy hauling during the winter months.

W. A. Heylman Chosen Mayor.
About a year ago W. A. Heylman, who operates a bank here, was chosen mayor by the city council when a vacancy in the office occurred. The Heylman administration improved the water system, spending a sum of money still in the hands of the city from the sale of bonds. Elected by the people, Heylman, and N. Johnson, also a member of the Heylman administration in a way, and from the first the two elements for and against the Heylman administration were represented. It was tried that the Heylman administration was to oust Johnson from his office.
At a meeting of the city council, held April 21, Johnson was cited to appear and show cause why he should not be relieved of his office for inefficiency and lack of proper care in his work. Johnson did not appear with a strong defense and the council attempted to remove him by resolution. Johnson appealed to the courts, and Judge Campbell held that an elective officer could not be removed by the council in the manner attempted. This victory braced up the Reed forces for the fight which is being waged today.

Recall Election Is Held.
Following the trouble with Johnson came a call for a recall election, signed by 48 citizens of the town. This election was held May 15, and resulted in the election of Reed as mayor and his councilmen. But the Heylman council refused to meet and canvass the vote.

Malheur Cave One of Greatest Natural Curiosities in Oregon

Mahon's Ranch, May 28.—I have just returned from a visit to one of the greatest natural curiosities in Oregon, the wonderful Malheur cave. I was driven there this morning by Mr. Mahon, and we have spent the day in the trip and the explorations of this underground cavern.

We left the ranch about 7 o'clock in one of Mr. Mahon's rigs and behind one of his best teams. We were well supplied with guns and ammunition, lunch and such other paraphernalia as might be needed. The trip, not forgetting the plenty of lap robes, for the sky was cloudy and threatening rain. Indeed, it rained and hail at intervals during the entire trip, but snugly ensconced in a closed top buggy, well wrapped in coats and blankets, the trip was not at all unpleasant.

This cave lies about seven or eight miles from the main Mahon ranch, the general direction being to the northwest. It is thus in township 27 south, and range 17 east, and is about 15 miles from the Malheur river, and I say that it is located on the map when I say that it is close to the south fork of the Malheur river and just above its confluence with Camp Creek.

There is, however, no road leading to it, and we have to make a wide detour, perhaps 16 or 17 miles, to reach it, which we did about 11 o'clock.

Lava Monument Marks Cave.
The entrance is on level land in a valley, perhaps two miles wide, and until yesterday there was nothing to mark the site to attract attention from a passerby. But before our arrival yesterday, a cowboy working for Mr. Mahon, a chap known as "Tex," who rode down the north fork of the Malheur river, pried up a fine monument of lava rock, said monument being about 10 feet high. "Tex" made a good job of the landmark. It stands firm and solid and unless ruthlessly torn down, it will stand for many a day to attract visitors.

Imagine upon a flat level piece of land a slight depression, like a slight cut from a plow, and you have the entrance to the cave. Let this gouge out side be 40 feet wide, and let it cut deeper and deeper to a depth of 80 or 90 feet, and to a depth of 15 feet. Then let it be terminated, and just at the center and from the center of this heading, imagine a hole from two to seven feet and 30 feet across, and that is the entrance to the great Malheur cave. (Directly over the center of the "Tex" monument now stands.)

Ranch Grass and Sage Brush.
The entrance faces the south. The Malheur river is a couple of hundred yards to the west, and the lava monument is 50 feet to the east, and another half way between the cave and the lava monument is a line of sage brush, and the country around is covered with thick growth of sage brush; the hills are covered with sage brush, and the grass, in patches, and for quite a distance surrounding the cave these rocks are so plentiful that the land is not of much account.

Before attempting to tell about the interior I want to say something about the entrance. The entrance is a hole in the ground, the throat and mouth of this cave, the deductions made from the signs and visible marks left by some prehistoric race.

Going just inside the mouth you find yourself in a broad chamber with arched roof. It is perhaps 20 feet wide and seven or eight feet high in the center, but as you go farther in the floor rises and the ceiling is high and the top of the crescent. Looking around you find on either side of the entrance, remains of stone walls. These walls reached near to the center, leaving a doorway or passageway of perhaps a dozen feet.

Now, let us go out to the surface and make an examination of other signs. There is no rock or stone within miles of the site save the lava mentioned, and sandstone. And yet for a distance of perhaps 200 yards in every direction the ground is thickly strewn with chips of flint, and unfinished, imperfect, and in some cases perfect, arrow heads may be found by the hundreds and wagonloads of the shippings could be there gathered.

Great Workmen Seen a Workshop.
At this time this must have been a great workshop. Some prehistoric race must have used that field as a workshop, and it is easy to imagine them as an enemy approached the owners of the cave could retreat within its first chambers—5000 could easily find safe harbor with their families. A few more stones could be thrown across the entrance, and 50 men could be taken off 1000 or more of a hostile host.

But let us enter the first chamber and go inward a couple of hundred feet to a point where there is a slight turn to the east. Thus far the light is clear and strong. We are in a vast amphitheater, the floor is a smooth, dry, dome is beautifully carved and frescoed, in places moss-covered, sometimes shaded and tinted like Parian marble, with soft shades of pink and salmon fading into something akin to the bluish of the peach; and then again patches of mottled gray and beautiful browns, melting away into the darkness.

CASE HINGES ON SILENT BUT NOT CRIMINAL REASONS

Carl Hogsden, Indian, Accused of Killing Half-Blind Friend.

A small mother-of-pearl shirt button with a bit of black cloth attached is relied upon by the supreme court today as the hinge on which the case of Carl Hogsden, an Indian boy, of murder, hinges. Hogsden's home is on Siletz reservation. He is accused of having shot Grover White, a half blind playmate, with a rifle about a year ago.

The government's theory in the case is that the boys were proceeding to their homes in the early part of the evening after having become intoxicated on some wine for the court. The court quarreled over some trifling thing and White in his blind way grasped Hogsden by the front of the shirt, intending to cut him with a knife. Hogsden wrenched himself free, stepped back a few paces and sent a rifle bullet crashing through the body of his companion.

The button from Hogsden's shirt was found near the body of the dead Indian. Hogsden had been pulled off while he was scuffling with some girls. Howard Graner, another boy, who found the button, testified that he saw Hogsden. His girls that night, and that he had been quarreling with White on his way home.

These points of the prosecution are being brought out by Assistant United States District Attorney Wyatt and Evans, while counsel for the defense, Hains and Wade, expect to prove in the end that Hogsden had not seen White the night White was murdered.

**WILD AUTO BEARS
FOUR TO DEATH**

Backs Into the Sacramento River; Victims Women; One Dead of Fright.

Sacramento, Cal., June 8.—That Miss Julia Dungan, one of the four victims of a wild automobile, was killed today, a town about 10 miles north of this city, died of shock in one awful moment that the falling automobile was poised over the rushing river.
