The publication yesterday of the scores of all contestants credited with 1000 or more votes at the close of business Thursday, was greeted with delight by nearly all who have entered, or are interested in the Journal's \$5000 prize subscription contest. A Few Suggestions to Candidates.

Subscribers should be so informed and where the parties wish their subscriptions to begin at once remittances should be made promptly.

How to Enter the Race.

LIVELY CONTEST ON INCOME TAX

Taft's Corporation Tax Plan
Causes Bitter Struggle
in the Senate.

(Washington Bureau of The Journal.)
Washington, June 19.—Another incident added to the host of others tending to split political parties wide open has come in the form of a struggle over the income tax in the Senate, as proposed by Taft, to substitute therefor a tax on the net incomes of corporations. No compromise is attempted of the fact that the feeling is more intense over this issue than over any other this winter. The significance at this time rests in the serious division in Republican ranks, as Democrats appear to be united for the income tax as originally proposed, though they may support President Taft's Republicanism in the House, and the insurgent Republicans be defeated. Here is Senator Borah, member of the Republican advisory committee in the last national campaign, one of the chief speakers for Taft on the stump, and who supported him, recently declaring that they will fight until the Sahara desert freezes over before they will yield from their insistence on an income tax. Lay right now, Senator Jones of Washington affirms he will vote for it. Senator Piles will do the same. And the attitude of these strong Republican members tends to rend more widely the two parts into which the Republican party has been sundered this winter.

Democratic Party Divided.
While the Democratic party is solid on this issue, that party heretofore has shown itself to be divided, apparently irreconcilably, on other matters. The subject is merely in its initial stages, both sides being busy collecting ammunition for what will probably be a spectacular forensic battle. Lurid claims are made by both contestants.

Bourne, with Curtis and Brown, were the senators who induced the president to send in his special message. This is not disputed here in any informed quarter. Bourne avers that the President forced Aldrich and other reactionary senators to accept the corporation tax against their wishes, and that Taft's plan is salutary and will be to reap the fruits of Roosevelt's sowing. He contends that Taft's proposal is one of the wisest ever laid before Congress.

Bourne Gives Interview.
"This amendment will be strictly an administration measure," he said, "and the attorney general will draft it under the direction of the president. Against this view advocates of the income tax bitterly hurl the accusation that Aldrich is really back of the move; that Wall street really desires it to prevent reform through a personal income tax. They cite that the proposal is to tax no bonds which are the basis of the largest fortunes, such as those of Rockefeller and Carnegie, and that small companies getting no franchise privileges from the government and engaged in ordinary trade would be taxed under it, while bloated bondholders would go free."

"They declare they place no reliance in Aldrich's good faith; that they are suspicious he will 'mess things' so that when the law comes from Congress his mother wouldn't know it, and will not serve the purpose professed for it—namely, that it will force publicity of corporation business, enable enactment of important reforms desired by all progressives. I would guess that the president's proposal will be adopted, as enough of the original income taxers will desire to defeat the enactment of that measure this time."

Chamberlain With President.
Besides Bourne, Brown and Curtis, others will be Guggenheim, and almost surely Clapp and Nelson, with chances that others will go with them. This will be enough to defeat it. Chamberlain is giving close attention to developments, being of course determined to support income tax to the end, although he is disposed to consider the wisdom of voting for the president's proposal if the income tax be defeated. He has no such

optimistic views as to the outcome as Borah and Jones hold. He said: "It seems to me that President Taft's influence will be strong enough to carry the corporation tax through, though of course I would like to see an income law adopted now."

Loupy was the proprietor of the famous Pup restaurant during the days of the Schmitz-Ruef administration and many conferences between the ex-boss and his henchmen were held in his cafe.

ALBANY MAN SUES C. & E. FOR \$10,000

Albany, Or., June 19.—F. L. Robertson of this city yesterday began a \$10,000 damage suit against the Corvallis & Eastern railroad for an alleged injury received November 20, 1908. The complaint states that through the negligence of the company the heavy door of the round house closed inward and caught his foot while he was driving an engine into the building, bruising it to such an extent that he has been compelled to stop work.

Bicyclists and Dogs Under Ban.

Pendleton, Or., June 19.—With three bicycle riders nabbed yesterday as a result of the work of the special police officer appointed by the council, it is believed that the practice of riding wheels on the sidewalk in Pendleton will soon be a forgotten art. The identity of the special officer has not been revealed, and it is the intention of the council to keep it a secret so as to make his work the more effective. In addition to capturing riders of

wheels who use the walk, the "unknown" officer is gathering the names of dog owners who have so far failed to pay license on their canines. It seems that the ordinance provides a license for keeping a dog in town, even though the animal is kept off the streets and the council is determined to collect the amount of the license from every owner of a dog. The number of dogs on the streets has been visibly diminished since the starting of the anti-dog crusade several weeks ago.



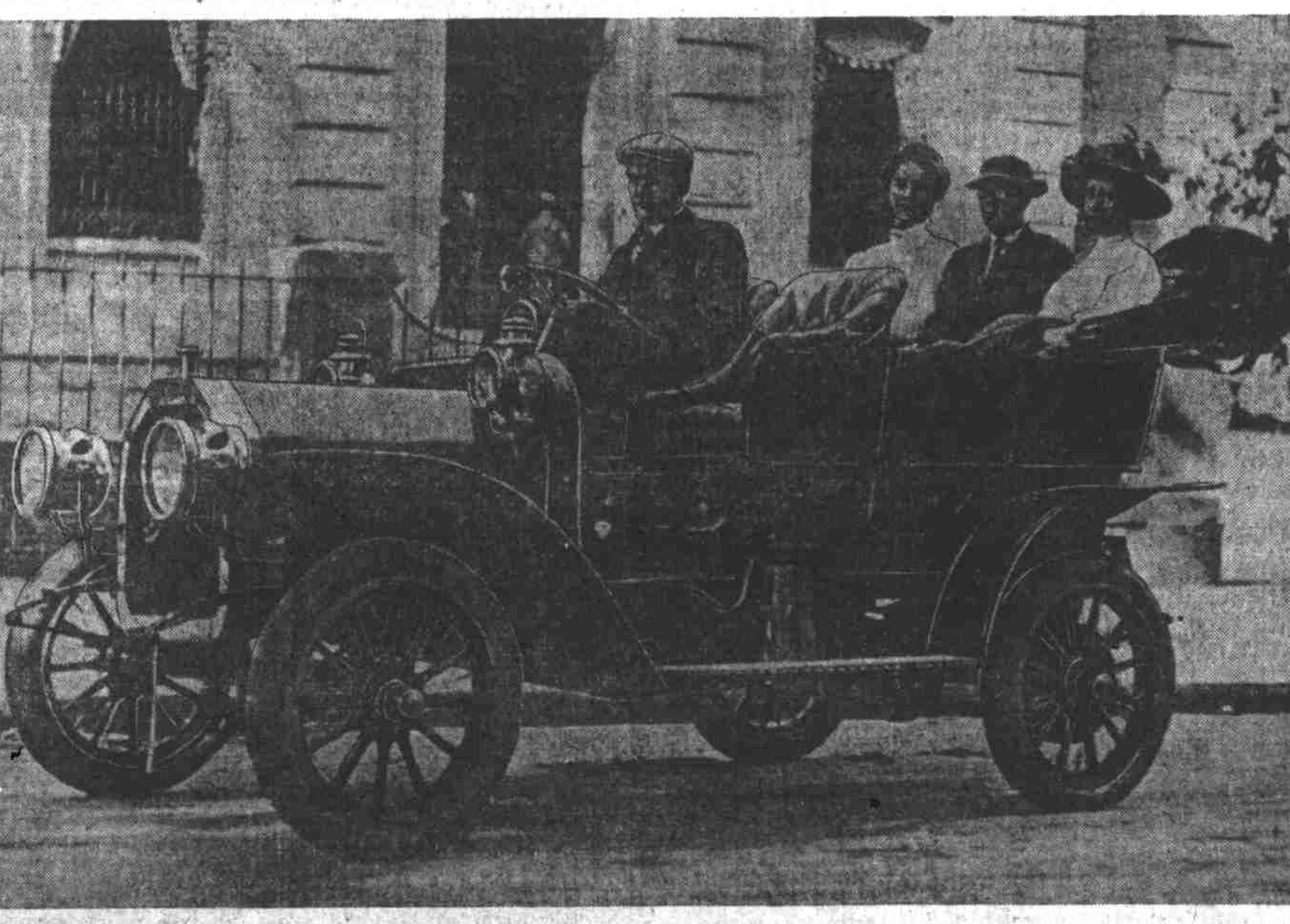
