

FESTS AGING THEAL DUE

Baptist Minister Uses Strong Words in Denouncing Men Who Pray on Sunday and Grind Poor During the Week.

Lights and shades in religious work were presented in remarkable contrast by Northern Baptist convention speakers last night. The ruin and the wreck of lives caused by existing social conditions; the plums and the many horrors of a great city were portrayed by Rev. Herbert S. Johnson of Boston in graphic fashion at the White Temple.

With somber tints predominating, the speaker proceeded to paint the picture of the smug and prosperous deacon who prays long prayers because of his high favor with the Lord and at the same time a cruel taskmaster, overworks and underpays miserable employees.

"I say to the church, go for the man who underpays—go for him with fists or a shotgun," exclaimed Mr. Johnson. "It is such as he who, boasting of righteousness and patronizing God, puts down the wages of working girls, forces them to work under years between a living wage and destitution, that propounds at the same moment the difference between virtue and vice, the wife and the mistress, happiness and misery—heaven and hell."

Conditions Respeak Balm.

"When we expect in a country where 1 per cent of the people own 99 per cent of its wealth? Such a condition uncorrected, such a tendency to wealth robs the churches, deprives them of influence and bespeaks their fall. In my own city of Boston there are four or five great churches, but they are going to the wall because of the lack of money. Ten or 12 years more and the end will be at hand; Boston will be a private cemetery for Baptist churches, and the epitaph will be: 'Died of indifference—Died of individualism.' Organization is the only hope, the only hope and must be accomplished by the Baptists."

Rev. Johnson is the son of John W. Johnson, first president of the University of Oregon. His mother, Mrs. Helen E. Johnson, still lives in Portland, 123 East Thirtieth street.

With a form in height equaling and a countenance in beauty and ruggedness similar to Abraham Lincoln, Dr. W. T. Stackhouse, a Canadian who leads the Laymen's missionary movement of the dominion, came before the convention, and until late in the night held the great audience spellbound with a powerful oration.

More for Gums Than Church.

His was a portrayal, too, of men in the church giving a man's work to do, earnest and thrilling with the consciousness of their mission's importance. There was jubilation in the way he told how contributions to religious endeavor were creeping up toward the sum total each year for the church, and at the present rate of increase may after a few generations equal the vast sums expended on the one hand for the Christian's place in the growth of nations, though he had announced that he would not on the other hand for the Christian's place in the growth of nations.

To illustrate the faith's influence he quoted the words of the apostle: "I live for the one great purpose of bringing the human mind in contact with divine revelation." President Johnson declared that Christianity and its spread is the only hope of modern civilization.

With deep feeling Dr. Stackhouse related the way the laymen's movement in bringing workers in contact with hitherto neglected men and how racial uplift is resulting. He described methods of giving which in generosity and sacrifice were new to American audiences. He closed by declaring that as Great Britain and the United States have locked arms in Christian work they will never lock horns in war.

No speaker of the convention has been received with such fervid applause as was Dr. Stackhouse.

Business Man Talks.

The Northern Baptist convention last night was given the opportunity of hearing a business man talk. He was Senator Francis W. Parker, of Chicago, leader in the Baptist Brotherhood movement, a man typical of religion resolved into its practical elements. His theme announced on the program was "The Brotherhood, Its Purpose and Method."

From an investment in Christian work the church is masculine, not feminine, but it lacks virility," was one of Senator Parker's characteristic utterances. "We need more men in the pew. We want to get the men we have as much as to try and bring others in from outside," he declared, "the church is a man's world. One steady, long-earred mule drawing a plough across the field is much more valuable than 10 wild asses kicking up their heels in a corral. Man's chief occupation is the pursuit of happiness. Seeking happiness, Teddy shoots and plants."

"People are now in such a state that should some one dally a money king as the idol of the masses, followers would be found in every town to become philosophers and worshippers of the superman. Let me say to you that real happiness is in pursuit of service and that greatest service is found in the greatest service of human kind."

"The one great doctrine worthy of being expounded from every pulpit and enthroned in every life is the doctrine of practical service. The Brotherhood aims to bring about this condition—to vitalize the life of the church, to purify the blood of the nation."

WOMEN WIN IN FIGHT WITH CONVENTION

morning when the American Woman's Baptist Home Mission society sought formal incorporation in the body. The women won.

Pleading, cajoling, appealing to the chivalry of the men hundreds of votes were rallied to the cause of the women when for a moment the cause seemed lost. All preliminary statements that a vote on admitting the woman's organization would be peaceful and unanimous proved their inaccuracy when discussions of the issue was put before the convention after Dr. Stillwell of Cleveland, Ohio, had moved to admit the society.

Dr. W. C. Bittling, corresponding secretary of the convention, and one of its most esteemed officers, paid tribute to the women and the value of their work. "But," he declared, "they should preserve their autonomy. They are doing a great work, but it would be legitimate making their organization a part of the convention. It would be a case of the women coming down to become the equals of the men."

Dr. Bittling declared he had no use for the "new woman" or the masculinity which the type represents. He added that he had no reverence for the custom which places woman on a pedestal of admiration and shelters her life from the storms of existence and the wickedness of the world. His inference was that the women in becoming a part of the convention would identify themselves as being among the objectionable "new women."

Mrs. Nuveen Rescues.

Others spoke in the same tenor and their arguments had a price which seemed lost when Mrs. John Nuveen, president of the Women's Home Mission society, came forward and with a flash of inspiration, outlined the reasons why the work of the convention and of the women themselves will be advanced materially by the incorporation.

"We women believe it right as church members to be identified with every movement and every organization of the church," Mrs. Nuveen exclaimed. "We are doing work in addition whose importance every pastor will recognize if he be honest."

With tones of mingled fire and tenderness, Mrs. Nuveen argued for her sex and the endorsement of their plans by the men. The vote when put, sweeping away opposition, was unanimous, and for many minutes the auditorium of the White Temple was noisy with cheers and whistles and handclapping in tribute to Mrs. Nuveen.

The resolution of incorporation proposed that the work of the convention and of the women themselves will be advanced materially by the incorporation.

Two Sections Clash.

Struggle for territory between the Northern and Southern Baptist conventions was evidenced in spectacular fashion before the session. Speakers alleged that the southern convention had violated a "gentlemen's agreement" to let the northern Baptists occupy exclusively the field of California, New Mexico and Arizona, moved that a resolution disapproving of the entrance of the southern convention into the territory occupied by northern Baptists.

The arrangement, if carried out, limits the southern Baptists to 10 states east of the Mississippi and south of that district, more Baptists than in all the territory occupied by northern Baptists.

President Judson of the convention took occasion during the session to voice his resentment because of the announcement made by a local morning paper that his reelection had been accomplished by machine vote.

Judson Makes Denial.

"Had my election been other than unanimous," he declared, "I would not have accepted it. I regret very much that such a cast shadow be given to our proceedings, which I was made to feel sure was the expression of the convention's will." Dr. Judson's comment was roundly applauded.

The work of the day was devoted principally to the American Baptist Missionary union. One of the important questions facing the union is the division of the foreign field among the denominations. The scheme is to allow one denomination to occupy one field, another to occupy another, and so on until the whole territory is covered and evangelistic work proceeding in all parts of the world at once in or the least outlay money and effort. A similar effort to prevent competition between denominations of this kind is gaining favor and its adoption is anticipated.

Dog Attacks Child.

San Francisco, June 30.—A fight for her life with a ferocious shepherd dog, 13-year-old Bess Comer, whose father is a physician, powers recently attracted state wide attention to her home suffering from severe lacerations on her legs and arms. But for the timely assistance of Dr. J. O. Jewell, a neighbor, the little girl would probably have been fatally injured by the infuriated beast. Mrs. Jewell, who owns the dog, was bitten severely when she went to the rescue.

Free Passage for Students.

Sydney, June 30.—Offers made by the Orient Steamship company to furnish annually free passage to three graduates each of the Sydney and Melbourne universities who desire to pursue their studies in European institutions have been accepted by the senators of the Australian senate. The free trip of Sydney students to benefit by the offer will probably sail for England within a month.

HISTORIC TREE YIELDS UP GAVEL

President Judson of Baptist Convention Is Given Unique Token of Office.

President Harry Pratt Judson of the Northern Baptist convention has a new gavel quaintly inscribed—all that is about the office to which he was unanimously re-elected yesterday afternoon. The gavel came from Rev. Mr. Edwards of California, whose brother sent it from near Jonesboro, Tenn. It was carved from a peach tree near Boone's home and forms an attractive substitute for the claw-hammer to which Dr. Judson objected because of its connection with the knucklers.

"You are elected without a vote," declared the chairman of the nominating committee, turning to President Judson, interrupting the wild applause after the statement had been made that the choice of the committee was a man who had presided over the present assembly and added to its success, its dignity and grace. The demonstration that followed Dr. Judson's election was never known before in a Baptist meeting. Handclapping, cheering, waving, feet thumped the floor and the clapping was deafening.

The reelection of Dr. W. C. Bittling as corresponding secretary was only one less enthusiastic. Dr. Bittling has not only won admiration and appreciation by the mastery with which he has conducted his work, but he serves without pay.

A representative from every state, with delegated powers from those he represented, came together as a nominating committee yesterday. CASE OF EVANS MYSTIFIES SLEUTHS

vestment company of Portland, who suddenly dropped from sight after coming to Tacoma a week ago to confer with Hughes on a matter involving the alleged forgery of the name of a prominent Portland citizen by a business associate.

Evans is believed to have been seen in Tacoma about 9 o'clock last Thursday morning, the day following his arrival in Tacoma. A traveling man, whose name has not been learned, saw a photograph of Evans last evening when he was being shown to the clerk at the Donnelly hotel. He at once volunteered the information that he had seen Evans in Tacoma and was dressed in a light gray suit and wearing a brown derby hat.

The traveling man had overheard a few fragments of their conversation, which indicated that the stranger was endeavoring to interest the man supposed to be Evans in South Tacoma real estate and the latter seemed to be on the point of accompanying the other to that section to look at the property. Weight is added to the importance of this clue by the fact that Evans was always in the market for good realty and frequently looked for property in different cities during his trips.

It is also known that when Evans came to Tacoma he had with him in addition to his bankbook and checkbook two deeds to Clatsop county property, which the associate against whom the suspicion of forgery rests, was exceedingly anxious to obtain. These two deeds, together with the documents which were said to establish the associate's guilt, constituted possessions which Evans was guarding zealously and would not permit to leave his hands. They were the exhibits which he expected to lay before the detective and attorneys in Tacoma, and which it was feared there might be an attempt to take from him by force if they could not be gotten by stealth.

"A notorious real estate bargain," says Detective Hughes, "would undoubtedly be the bait used by any one who knew Evans to lure him into a trap. So far we have not been able to establish the fact that Evans actually visited South Tacoma, and which is a stranger. We consider the clue an important one, however."

We have thoroughly covered every possible avenue which might reveal the whereabouts of Evans if his absence were to be explained by another theory than that he has met with an accident or violence without results.

Although the bankers at Portland, because of the Oregon law forbidding giving out information, will not state whether or not Evans had made drafts on them, we are satisfied that if he had done so we would be able to get the information. The fact that they will give out nothing is a further indication that they have nothing to tell which would help us in his search.

A peculiar incident is that he did not register at any of the Tacoma hotels Wednesday night. We have examined all the registers thoroughly.

BIG STRIKE IMPENDS IN STEEL MILLS

Pittsburg, Pa., June 30.—All signs point to the inauguration of a great strike tomorrow, when the "open shop" order of the American Sheet & Tin Plate company is to become effective. More than 10,000 skilled workmen, members of the Amalgamated Association of Iron, Steel and Tin Plate Workers, have decided to quit work rather than abide by the "open shop" order. Many unskilled workmen will also be affected.

The combined plants in which a strike order will be effective total 152 mills in the tin trade and 52 mills in the sheet steel trade. Seventy-six of the mills are located in the Pittsburgh district, 40 in Ohio, 10 in West Virginia and 50 in Indiana.

ROBBINS TAKEN TO DALLAS JAIL

Alleged Slayer of Mrs. Casto Still Avows Innocence; Held Without Bail.

The Dallas, Or., June 30.—G. E. Robbins accused of killing Mrs. Casto at the Robbins farm, near Hood River, last Saturday, was brought to the Wasco county jail last evening by Sheriff Morse of Hood River. Robbins, 27, was held without bail to appear before the next grand jury for Hood River county, which convenes next Monday. When seen at the county jail this morning Robbins refused to make any statement for publication.

Hood River, Or., June 30.—Money still continues to be found in the room of Mrs. Casto, the woman whom George Robbins is accused of murdering. Three dollars more was found on top of a cupboard in a search made last night by Bert Adamson and Matthew Mainard, two of her relatives. It is claimed that the money was only slightly concealed and they wonder at the fact that it was not discovered in former searches.

Under the direction of Sheriff Morse another investigation of the premises is being made today. Robbins is said to be Sheriff Morse, who took him to The Dalles last night, to have conducted himself quietly and calmly.

There was no demonstration of any kind when he left here last night and very few people knew that he had been taken to The Dalles until this morning. While interest in the case is still keen, there is no feeling of a public demonstration against Robbins, and there are many who express great doubt as to whether he did the killing.
