

CHINESE SLAVE GIRL RANSOMED

Her Master Suspected of the
Crime — Accuses Pre-
vious Owner.

(United Press Lined Wire.)
New York, Aug. 16.—Accused of murdering his beautiful slave, Bow Kum, Chin Len, an Americanized Chinese from San Francisco, is imprisoned here. He strenuously denies that he killed the Chinese woman, and accuses Long Dong, another Chinese from the western city, of the gruesome murder at 17 Moti street yesterday.

The police do not believe Chin is telling the truth, and he is under strong suspicion of having committed the deed. Near the doorway leading to the room where the woman was stabbed to death in the bloody imprint of a man's hand. The finger marks coincide with Chin's. Chin declares that Long killed the woman because she refused to return valuable jewelry he gave her when he first imported her from China for the slave traffic. These, according to Chin, Bow Kum took with her when she escaped from San Francisco with Chin to New York. Until her tragic death, the life of Bow, whose name means "purse of gold," was intense and tragic.

She was kidnapped from her home near Canton and held a captive in San Francisco's Chinatown for several years before she was rescued from the opium dens by Miss Donaldina Cameron, superintendent of the Presbyterian rescue mission. There for six months the slave girl remained sheltered until Chin Len arrived, and in spite of Miss Cameron's protests, claimed the purse of gold as his wife. In February he left for New York with the girl, and Long Dong, her previous owner, followed. He sought out Chin Len and demanded \$200 as the price of Bow Kum. According to the oriental now accused, he refused to pay the price, and Long Dong is alleged to have threatened serious harm to Chin Len, Bow Kum or both. Yesterday morning the assassin, armed with a dagger, crept into the room where the woman lay sleeping and stabbed her to death. The sharp steel pierced her heart twice.

When discovered the girl was found on the floor by the side of a richly draped couch, and lying near by was the bloody dagger which had been used to take her life.

On the wall near the door was imprinted a man's hand in blood. The hand print and the dagger are the only clues the police have with which to run down the assassin and solve the mystery of the Asiatic colony, which promises to be as baffling as the identity of the murderer of Elsie Sigel, the white girl who was killed in the Chinese quarter recently.

Death Roll of the Northwest

Rev. Peter Carlson.

Colfax, Wash., Aug. 16.—Messages received last night at Colfax announced the death yesterday morning at the Deacons' home in Omaha, Nebraska, of Rev. Peter Carlson, 87 years old, who next to Whitman, Spaulding and Delia, was the most widely known pioneer protestant missionary in the northwest. Rev. Carlson was born in Sweden and came to America in 1854, and for years traveled over Oregon, Washington and Idaho on horseback and by stage, organizing Swedish Lutheran congregations and Sunday schools. In 1888 he organized a church at Moscow, Idaho, and was pastor there until 1898, and again in 1902. Since 1898 he had been an inmate of the Deacons' home in Omaha.

The body will be shipped to Moscow and the funeral will take place Wednesday from the Swedish church.

B. F. Crow.

Eugene, Ore., Aug. 16.—B. F. Crow, 74 years old, a well known Oregon pioneer, died a few days ago at his home at Lorane, after a long illness. He came across the plains to Oregon from Missouri in 1853 and had resided in the Lorane valley, in Lane county, since. He was unmarried. He was possessed of many sterling qualities and was held in the highest esteem by all who knew him. He was a devoted member of the M. E. church.

Sues for \$11,000 Damages.

Colfax, Wash., Aug. 16.—Adolph Fischer, manager of the Colfax brewery, and his wife, Mrs. Renestine Fischer, yesterday afternoon filed suit in the superior court against the Spokane and Inland Empire Railway company to recover \$11,000 damages for injuries sustained through breaking her leg while alighting from an inland train at Harpole station, five miles west of Colfax on August 23, 1908, the accident being the result, so the complaint alleges, of the failure of the company to provide a railing around the platform at Harpole to prevent passengers from falling off.

Athena Man Sells Property.

Colburn also sold his large ranch north of Athena to the same institution. They have lived in Athena for a number of years.

CRY FOR LABOR IS PROSPERITY SIGN

Appeals of West for Help
Reach Department at
Washington.

Washington, Aug. 16.—Indisputable evidence that the country is rapidly recovering from the effects of the recent financial depression and that it now is approaching a great prosperity wave is furnished by appeals received by the division of information of the department of commerce and labor, particularly from the west. The greatest cry for labor comes from Lincoln, Neb. In a letter received from W. S. Whitman, secretary of the Commercial club of Lincoln, Neb., it is asserted that "there is a great need of labor, both skilled and common, throughout the state, particularly in Lincoln and Omaha, and the smaller cities where more or less manufacturing is done. The development of manufacturing in Nebraska has been retarded in a large measure through the lack of labor, and a scale of wages is submitted, showing that good wages are paid to laborers."

Soon after the panic a La Crosse (Wis.) manufacturing company wrote that they will not have any difficulty in getting all the help we want now, but through Representative Esch, of that state, that concern now writes that it wants "ten or fifteen families of five children each."

"These straws point quite accurately toward prosperous conditions in Nebraska and Wisconsin," said T. V. Powderly, chief of the division of information.

Notes From the Labor World

Boston plasterers, now receiving 80 cents an hour, demand 85 cents.

Men are not working more than half time in the Indiana mining districts.

The wrecking truck drivers of Brownsville, N. Y., have recently formed an organization, which is gaining members.

After considerable agitation the steam engineers and hostlers in Joplin, Mo., have organized a union for both crafts.

The next convention of the Retail Clerks' Protective association will be held in Columbus, Ohio, in the early part of autumn.

The marine engineers now have a

total membership on the coasts, the lakes and the rivers of the United States of more than 11,000.

It has been decided that the eighteenth annual convention of the Theatrical Stage Employees of America, in 1910 will be held in Washington, D. C.

The convention of the Wood, Wire and Metal Lathers' International union will be held this year in Boston, Mass., in the week beginning September 13.

A movement is on foot in the French parliament with a view to obtain an increase in the amount of pensions paid to the employees of railroad companies.

The general officers of the International Seamen's union have decided to petition congress to have the general law so amended as to prevent the undermining of vessels.

A report recently issued from the international office of the cigar makers shows that the organization now numbers 43,000 members and that it has funds on hand amounting to \$700,000.

The International Printing Pressmen's convention appointed a committee to devise a practical and economical plan to provide treatment for tuberculosis, which plan shall be submitted to the referendum.

The executive council of the American Federation of Labor adopted a resolution in favor of the establishment of an international federation of labor. President Gompers will advocate the plan during his trip in Europe.

The French court has ordered the dissolution of the trades union which the postal telegraph and telephone employees have formed during the great strike in Paris last May, holding that the law of 1884 relating to workers' unions does not apply to postal, telegraph and telephone employees who are state employees.

POLITICAL POT SUMMERS EARLY

Removal of Whitman County
Senator to Spokane
Starts Slate Making.

(Special Dispatch to The Journal.)
Colfax, Wash., Aug. 16.—As a rule there is little activity in Whitman county political circles between campaigns. This year seems to be an exception, and there is considerable interest as to who will be next senator from the Ninth district. Already there are several Republican candidates in the field and at least one Democrat.

The removal from Whitman county to Spokane of Senator Peter McGregory has brought about this condition, and there is considerable speculation as to who will fall heir to his toga. It is likely that Oliver Hall of Colfax, who represented the Ninth district from 1898 to 1901, will be the Republican nominee, and Hugh C. Toot of Colfax, present member of the lower house from the seventh district, is out for the Democratic nomination.

The only men mentioned as Republicans who will develop any strength in opposition to Senator Hall are Dr. A. E. Stunt of Colfax and J. R. Rully of Pullman. Dr. Stunt was the personal representative of Albert E. Mead during the late campaign, and was a member of the state board of medical examiners. Mr. Rully is serving his second term as county commissioner from the second district and is chairman of the board.

On account of Hall's activities for a railway commission and his being slain by the railway forces, and in 1902 he was defeated for the nomination. Dr. George Wilson of Pullman being nominated instead. Hall was not a candidate in 1907 when McGregory was nominated. The second factor that aroused the opposition to Senator Hall have passed and the active Republicans in Colfax are of the opinion that he is the man to unite the warring factions in the party in Whitman county. They feel that few if any of the men who have opposed him in the past will fight him now, and there is but little fear but what the "old guard" that stood with him then will line up for him again.

CANADA TO MARK CENTURY OF PEACE

Ottawa, Ont., Aug. 16.—The proposals of the association which is being formed for the celebration for the 100 years of peace following the battle of 1812 have been submitted to and approved by Earl Grey and Sir Wilfrid Laurier. It is proposed that the celebration be national in character and form an object lesson in peace to the older nations where the spirit of militarism predominates.

Dominion and United States governments and the provincial government will be asked to contribute to finance the proposition.

National Fraternal Congress.
Boston, Mass., Aug. 16.—The twenty-third annual meeting of the National Fraternal Congress began in this city today, with headquarters at the Hotel Somerset. The licensing of deputies by state insurance departments, reserves for fraternal societies, and representative form of government as applied to fraternal societies are the principal topics slated for discussion. The medical, fraternal, press and legal sections are holding their annual meetings in conjunction with the congress.

Hotel Men Meet at Omaha.
Omaha, Neb., Aug. 16.—The hotel-keepers of Omaha are entertaining for three days their brethren from Minneapolis, St. Paul, Fargo, Sioux Falls, Cedar Rapids and numerous other cities. The occasion is the annual convention of the Northwestern Hotel Men's association, which meets this year to celebrate a big increase in membership and to discuss ways of increasing the hotel "dead beat" and other questions of mutual interest.

Iowa Woman 100 Years Old.
Burlington, Iowa, Aug. 16.—Mrs. Katherine Lewis, who is believed to be the oldest woman in southeastern Iowa, celebrated her one hundredth birthday today at her home in this city. Mrs. Lewis was born in New York and came west in 1844. She is a native of Burlington, N. Y., to Cincinnati, on a raft, then taking a steamer to St. Louis and thence north to Burlington, the trip occupying nearly a month.

A call has been issued for the holding of the national convention of the Women's Trade Union League in Chicago in the early part of September next.

The organization of the wholesale dry goods clerks in New York city has applied for its admission to the United Hebrew Trades of New York.

BANK MANAGER A FUGITIVE

W. C. Hays Will Be Posted
Before the Police of
the Coast.

San Francisco, Aug. 16.—After searching for four days for W. C. Hays, late manager of the Union State Savings & Commercial bank, Chief of Police Jesse Cook today declared the banker a fugitive from justice. Immediate steps will be taken to post his picture in every police station and sheriff's office on the coast, with a description and an account of his alleged crime. Hays has been missing since Thursday, when he absconded through his attorney, Joseph Gordon, that he would surrender as soon as he could procure the necessary bail to keep him out of prison.

RAID HOUSE BOAT; ARREST GAMBLERS

TWO AT OMAHA DIE OF HEAT

Hot Wave at St. Louis Re-
cedes After Four
Have Died.

Omaha, Aug. 16.—Two persons died of heat here this morning, making a total of 10 deaths from the heat within 40 hours. It was hotter here this morning than on any morning this summer and it is feared that more deaths will be recorded before evening.

St. Louis, Aug. 16.—The first heavy rain this city has seen in a month fell today, and gave great relief after the terrific spell of heat. Four deaths and 13 prostrations were reported yesterday.

HOPE FOR MAN WHO "GOES OUT"

Able Speakers Tell of Places
for Betterment of Prison-
ers' Conditions.

Seattle, Aug. 16.—The second day's session of the American Prison association opened in the Young Men's Christian Association auditorium this morning with the annual address of the president of the association, E. F. Morgan, ex-surgeon of the Virginia penitentiary. He was followed by H. C. Sharp, ex-surgeon of the Indiana reformatory, who spoke on "The Indiana Plan."

"These Men are Going Out Some Time," was the striking title of the address of J. C. Sandora, warden of the Iowa state penitentiary.

A session will be held during the afternoon at which many papers on topics of interest to prison officials and those interested in the welfare of prisoners will be read. The speakers scheduled to make addresses are Rev. F. Emory Lyon, Chicago; Rev. E. A. Pradenhagen, Kansas City, and W. A. Gates, secretary of the California board of state charities, San Francisco.

An evening session will be held at which one of the principal speakers will be Judge Ben S. Lindsay, the famous juvenile court judge of Denver, who will discuss "Prevention and Probation."
