

BOOK PRESIDENT FOR AN ADDRESS

Taft Reception Is Now Practically Planned in Detail.

At a meeting of the Taft reception committee yesterday afternoon in the city hall, tentative arrangements were made and a telegram outlining the program of the two days the president will be here was composed and afterward dispatched to Fred W. Carpenter, private secretary of the president. Of chief interest to the public will be the address in the armory on the afternoon of October 2. This part of the program will be carried out, it is satisfactory to President Taft. It was decided at the meeting to have the president to participate in any public functions October 3, which will be Sunday. Soldiers from Vancouver barracks will act as the president's escort.

Following is the telegram sent to the president's secretary last night: "Fred W. Carpenter, Secretary, Executive Office, Beverly, Mass.: Following program for your approval: Committee will meet president and party at depot and escort with military to hotel for breakfast with committee; after breakfast, show about city in motor; return to hotel for lunch, which may be private if desired; afternoon, public address at armory; reception following; banquet in the evening, about 300 covers. Sunday entirely at president's pleasure, but committee will gladly arrange details and submit if desired."

WHEAT YIELDS WELL NEAR COTTAGE GROVE

(Special Dispatch to The Journal.) Cottage Grove, Or., Aug. 20.—Thrashing is well under way throughout this section and the grain yields are an average and even better than in some cases last year. Wheat is going about 35 to 36 bushels per acre. Corn is 35 to 40. Corn is not far enough advanced to determine the average yield but it is estimated that it will run 40 or more bushels per acre. Sweet corn is coming in now from several localities which produce a strictly first grade product. Felix Curran of Cottage Grove has one variety of corn which has been grown successfully for the past 32 years. It is known as the Mammoth White.

Past Creek valley and the Bagdad districts are making the best fruit showing this year. Among the best fruits are found the Yellow Newtown Pippin, Spitzenberg and Baldwin apples, Bartlett, DuCombes and Winter pears. Apples and pears are being marketed in large quantities. Many new orchards are to be set out this fall tributary to Cottage Grove. It has been fully demonstrated that the variety varieties are the best commercial fruits to cultivate here.

JUBILEE OF INDIANA LABOR FEDERATION

South Bend, Ind., Aug. 20.—The first silver jubilee of a state labor organization will be held in this city next month when the Indiana Federation of Labor will meet to celebrate its twenty-fifth anniversary. The Indiana federation is the oldest in the United States. The celebration will be held in conjunction with the federation's annual convention and will extend over a period of three days.

Such business will be transacted at the meeting, but due attention will be given to the pleasure of the visitors. One of the features of the event will be a banquet, the speakers to include officers of many national and international labor bodies and several prominent members of the state organization. At the opening session the visitors will be welcomed by Mayor E. J. Fox and F. A. Miller, president of the South Bend chapter of commerce.

FUNERAL OF M. D. WISDOM TO BE HELD SUNDAY AFTERNOON

Portland Lodge of Elks Will Attend in a Body.

M. D. Wisdom, who had been seriously ill at his home, 300 East Sixteenth street north, for the past month, died at 4:32 o'clock yesterday afternoon. His life had been despaired of for three days.

Portland lodge of Elks is to have charge of the funeral, which will be held Sunday afternoon at 3 o'clock from St. David's Episcopal church. Rev. W. R. Powell, chaplain of the Bishop Torria Memorial chapel at the Good Samaritan hospital, will conduct the services. Several hundred lodge brothers and friends of the deceased will attend the services in body.

Dr. L. M. Hyde, a close friend of Mr. Wisdom, had been in close attendance upon him since he was taken down at Seattle on Portland day. At times he had been with him continually for day and night and it was due to his attention that Mr. Wisdom rallied from the several sinking spells after his return from Seattle. Dr. Hyde had been with him continually since Sunday, but several days ago abandoned hopes of saving his life.

M. D. Wisdom had long been known as the head of the movement for the betterment of the livestock in the state of Oregon. A farmer from birth, and naturally agriculturally inclined, he studied the fundamental principles of the livestock industry and through the columns of his paper, the Rural Spirit, and through his personal suggestions to the livestock men had done much to bring the livestock industry to the high standard which it now holds.

Gave Time to Study. It was in 1895 that he and J. W. Bailey, now the state dairy and food commissioner, first made their presence felt in the livestock business when they purchased the state dairy farm at Pacific Rural Spirit. Wisdom knew but little of the fine points of the raising of livestock at that time but started out diligently trying to get the fine points at his command and that he got results is shown by the high regard in which his opinion on all subjects pertaining to the livestock was held.

In 1898 Bailey left the paper and since then the state dairy and food commissioner, first made their presence felt in the livestock business when they purchased the state dairy farm at Pacific Rural Spirit. Net only through the columns of his paper has his work been noticed, however, but in the work of the state fair and of the various other fairs throughout the northwest. He was appointed the secretary of the state board of agriculture on December 22, 1899.

He was the head of the livestock department at the state fair and had practically done the work of several men in getting up this fair annually. The livestock department has always been the feature of the Salem fair and it has been through his efforts since that it has maintained this standard.

Given High Honors. His steady work in the state fair brought him two positions of national honor in which he did still greater work. He was first selected the superintendent of the Lewis and Clark fair livestock department and then the unlimited means of the fair behind him organized a livestock show such as had never been seen on the coast before. It was the finest show and the benefits have been felt by livestock men ever since.

This was really the start of the work of uplifting the livestock industry in Oregon. GRAFT PROSECUTOR HAS A ROCKY ROAD

Chicago, Aug. 20.—States Attorney Wayman, who has been gathering evidence to prosecute the police officials alleged to have received bribes to protect vice in the south levee district, has issued a statement denouncing two members of the July grand jury who signed a statement in which it was declared that Wayman had blocked the return of indictments against a certain suspected police officer and had refused to consider evidence asked for by the jury.

Wayman announced that he would continue the crusade against alleged recipients of vice bribes. He then charged that two jurors were being used as catspaws by powerful interests that were trying to stop the crusade.

In reference to the resolutions drawn up by members of the Garfield boulevard church, in which it was demanded that the charges made by the jurors against the state's attorney be investigated, Wayman declared that the prosecutor's office would be run from the criminal court building and not from Garfield boulevard.

He denounced the reformers as "people anxious to run everyone else's business, slinging mud meanwhile."

Down Elevator Shaft; Dead.

(United Press Leased Wire.) San Francisco, Aug. 20.—Albert Armstrong, 19 years old, plunged to instant death down an open elevator shaft yesterday in the Kohler & Chase building. He was wheeling a case of goods on a truck. Thinking, presumably, that the elevator was waiting for him he pushed the truck over the edge and was pulled over with the truck as it fell. Armstrong was the sole support of his widowed mother.

Steamer Grounded; All Safe.

(United Press Leased Wire.) Halifax, N. S., Aug. 20.—The steamer Margaret grounded at Thumb Cape yesterday. The passengers and crew, numbering 35, were all rescued.

CITY WILL WAIT LITTLE LONGER

Street Committee Takes Steps to Bring United Railways to Time.

The street committee of the executive board yesterday afternoon recommended that the city engineer be directed to have Stark street between Second and Third and to write the United Railways company a letter informing the company that the city does not longer intend to delay improvements on streets where the corporation has a franchise, but has not yet laid its tracks.

The city engineer thinks the delay of the company in laying rails on Twelfth street is not excusable, as only 12 men are employed on the work. If the railway makes use of its franchise on Stark street between Second and Third it will have to cut through the pavement to be laid by the city engineer and replace this in just as good condition as it is found.

In explanation of the delay on Twelfth street the company has caused a letter to be written to the city engineer stating that the work is being held back pending the laying of gas and water mains in the street.

SCHOOL DISTRICT HAS FACTIONAL WAR

Pendleton, Or., Aug. 20.—The residents of school district No. 87 are mixed up in a factional war and it is possible that the trouble will result in the creation of a new district. At a meeting of the voters of the district it was voted to levy a 2 mill tax and erect a new school building. Those who are opposed to the new school building now claim that the meeting was not properly advertised and that the meeting and consequent tax levy were illegal. They allege that the school board had entered into a conspiracy to hold the meeting so that the opponents would not know of it.

The people who are opposed to the new building have petitioned the district boundary board to change the boundaries of four districts so as to create a separate district for themselves. The districts affected are 61, 15, 12 and 9.

TWO KILLED IN KENTUCKY FEUD

(United Press Leased Wire.) Danville, Ky., Aug. 19.—With knives buried up to the hilt in their hearts, the bodies of Addison Chapman and Perry Luttrell were found today near Dry Fork church in Casey county. The men were enemies and the battle today was the climax of a feud of long standing.

An investigation this afternoon revealed the fact that John C. Hambley and his wife, who was a daughter of Luttrell, were seriously wounded. Three members of the Luttrell family and two of the Chapmans have been arrested.
