C. W. Anderson Is Arrested at South Bend, Wash., Charged With Cutting 600,000 Feet in Reserve.

South Bend, Wash., Aug. 21.—As a sequel to the announcement in The Journal Tuesday that the United States land office had held adversely to Augusta Anderson, C. W. Anderson and others in their attempt to secure land in the reserve in Coos county as coal land, C. W. Anderson was arrested here this morning by Deputy United States Marshal Ira Davidson on a complaint sworn to by John McCourt, United States district attorney for Oregon, charging him with cutting and removing 600,000 feet of timber from the southwest quarter of sections 28, 32 and 11 in the forest reserve in Coos county.
