

WORK WILL GO ON UPPER CANYON

Hill Attorneys Say Tieup in Lower Part of Disputed Territory Will Not Seriously Delay Completion of Road.

Not until September will the hearing of the Harriman injunction against the Oregon Trunk railroad, as relates to the occupancy of the lower 40 miles of the Deschutes canyon in railroad construction, be heard in the federal court. W. W. Cotton, chief counsel for the Harriman interests in the northwest, has announced that he will wait until much time to make answer to certain allegations filed by Carey & Kerr, counsel for the Oregon Trunk railroad, or, more briefly, the Hill interests.

But we do not concern ourselves with the tie-up of work in the lower part of the Deschutes canyon, said Judge Carey yesterday evening. "We have enough work to do in the upper 60 miles, where our rights will keep us busy for a year or so, and by the time we are ready to go to work in the lower part of the canyon, I am sure the adjustment of the respective rights of the Deschutes Railroad company and the Oregon Trunk will have been accomplished."

Speedy Decision Anticipated. While Judge Bean has given no indication as to when he will return a decision in the application for a preliminary injunction covering the upper 60 miles of the Deschutes canyon and situated by the Oregon Trunk against the Deschutes Railroad company, which was argued in the federal court during most of last week, it is expected that he will accede to a desire on the part of counsel for both sides and give a decision during the early part of the week.

But in going over the evidence and the law expounded last week, he will find an exasperating task on his hands. Practically, the case is very simple, resolving itself into the question of who first got into the upper 60 miles of the Deschutes with rights that will hold. The location of the Oregon Trunk line was made first, but Mr. Cotton, for the Deschutes Railroad company, has contended that the rights were secured by fraudulent means.

To make this issue clear to Judge Bean, and to aid him in arriving at a decision, the attorneys generously argued all phases for some 25 hours altogether, and so plain was the case by that time, to that men who had been the men who attended all the hearings said finally in a bewildered way: "Are they going to build a railroad in Deschutes or in Portland, and is it a railroad or a law book they are talking about?"

CHINESE LAUNDRY MAY GO HENCE

National Body of Laundrymen Proposes to Wipe It Out.

(United Press Leased Wire.) Chicago, Aug. 21.—John Chinaman, the laundryman, is in for it. The laundrymen's National association proposes to wipe him out as a factor in the laundry business of this country, because they regard him as the greatest "yellow peril" of the age.

The laundry association will meet here Monday for its twenty-sixth annual convention and 800 delegates will attend. The principal business of the convention will be the discussion of resolutions denouncing Chinese laundries as a "menace to the morals and hygiene of large cities," and demanding legislation against all such laundries.

According to the men behind the resolutions congress will be asked to pass the following laws: Prohibiting the immigration of Mongolian laundresses, either Chinese or Japanese; prohibiting laundresses from "spraying" clothes with water from their mouths, which the laundrymen regard as a source of danger of infection; preventing Chinese or others from sleeping in the rooms or shops where they laundry clothes.

The laundrymen are in such deep earnest about the "yellow peril" that it is expected that a resolution will be offered empowering the executive committee of the association to employ a staff of "muck-rakers" to expose the alleged evils of the Chinese laundry.

A fight is expected in the convention over a resolution asking congress to prevent the sale of "shoddy" goods. The laundrymen regard such goods as the bane of their lives. They expect that such a measure would be fought by big mercantile institutions and textile manufacturers.

WARNS OF NEW BUNKO GAME

Postoffice Authorities Take Up Spanish Fraud and Expose It.

Look out for Mr. Spaniard of the brand new bunko game! Uncle Sam has written to all his postmasters. He is not the bold buccaner of the bloody Main nor the suave priest of the inquisition. He wants not your life but your money. He wants the people in keeping their money, the postoffice department at Washington has prepared a special article dealing with the new danger the United States has to fear from Spain.

Unaccounted thousands of letters from people in Spain to supposedly gullible individuals in this country, are being sent through the mails. The warning reads: "The writer represents himself to be a Spanish prisoner of state, unjustly incarcerated. He has a fortune in the United States, and it will be held until the prisoner of his representative has satisfied the cost of the trial. He claims distant relationship with the addresser."

Or, as the warning continues, "the scheme in sending letters to certain persons, who have previously been selected by confederates. The foundation of the plot varies somewhat. In some instances the writer represents himself as a dying prisoner in a military fortress. He has a fortune on deposit in the United States, and the certificate of stock is concealed in a secret receptacle of his value which has been seized by the court at Cartagena, and it will be held until the prisoner or his representative has satisfied the cost of the trial. He claims distant relationship with the addresser."

"If the first letter bears fruit it is quickly followed by others in which the prisoner's daughter, bears an important part. She is in Spain without a protector. A proposal is made to send her, accompanied by a priest, to the heavily fortified castle of protection. If the money is sent to release the value containing the secret receptacle and the certificate of deposit. If the relative will accept the trust, he is to receive one fourth of the prisoner's entire fortune of about 120,000 pounds. Of course, the relative never hears from the prisoner again after he has sent the money requested."

The reason for this peculiar condition in Spain is found in the fact that no Spanish law provides punishment for the individual who acquires money under false pretenses. Under the law of that country a felony must be committed before the police may act, and a mere attempt to obtain money by false pretenses does not appear to warrant arrest. The money must have been actually paid over, and the prosecuting witness have gone to Spain to demand the money, or otherwise prosecution would be useless.

At the same time the warning was received from the postoffice department to look out for letters. Walter Kirschner, who has offices in the Board of Trade building, turned a letter of identical nature over to Postmaster Young. This letter related the deplorable condition of the prisoner, and promised as a reward for aid, the sum of 95,000 pounds. The letter, containing several thousand words of explanation, was turned over to the local postoffice inspectors.

GUGGENHEIM WILL LAY CORNERSTONE

(Special Dispatch to The Journal.) Seattle, Wash., Aug. 21.—After two years of earnest effort on his part, Rabbi L. Brooks will witness the first fruits of his labors tomorrow morning when M. Robert Guggenheim, the millionaire, will lay the cornerstone of the new Beth Israel synagogue, which is to be erected at Sixteenth avenue and East Fir street. Two years ago Rabbi Brooks realized the need of a permanent home for a faithful congregation numbering about 40 persons, which since that time has been holding services in tents, and he began a campaign to raise the \$10,000 required to build a magnificent temple.

Standpipe at Prescott. (United Press Leased Wire.) Prescott, Wash., Aug. 21.—Prescott water system is being greatly improved by the construction of a steel standpipe on the hill overlooking the town. Ample fire protection will be provided by gravity pressure.

JUDGE'S NAME BADLY MIXED

Divorce Suit May Have to Be Filed for Third Time.

Charging that his wife is trying to "smuggle" a divorce from him, Albert L. Johnson of South Seattle has filed an affidavit in the circuit court in support of a motion to set aside an attempted service of summons in the suit brought by his wife, Catherine E. Johnson. Another suit by Mrs. Johnson was dismissed a short time ago, after Johnson had complained of the manner of service, the present case being filed soon after the dismissal.

Johnson says his wife has been to the house where he is living in Seattle and knows the street and number. She made affidavit that she did not know his exact address and the envelope containing the summons was addressed to "South Seattle—in Seattle." The summons was published, but a copy attached to his affidavit shows that it was badly mangled by the printer.

Among other mistakes it refers to "Honorable Earl C. Gantenbein," confusing the names of Judges Earl C. Bronaugh and C. U. Gantenbein. Because of the alleged insufficient service Johnson asks that it be set aside. If this is done Mrs. Johnson will have to begin over again. She was married to Johnson in Portland in September, 1908, and alleges that he deserted her in March, 1909.

SMITH'S VISIT PRESAGES ROAD

Conference at Pendleton May Result in Line From Umatilla to Columbia.

(Special Dispatch to The Journal.) Pendleton, Or., Aug. 21.—Dorsey B. Smith, representing the Open River Transportation committee, is here today to confer with local farmers regarding the proposed electric railway across the wheat belt to the Columbia river. The conference is being held behind closed doors, and its full significance can not at present be stated, but it is considered to be indicative of the willingness of the company to cooperate with the farmers in their endeavor to secure lower freight rates to the water.

WOULD LEAVE HUSBY TO TEACH SCHOOL

New York, Aug. 21.—The rule of the board of education that married women must become divorced before they may be reinstated as teachers has provoked a divorce suit in the hitherto happy Reimer family. Mrs. Reimer would be a teacher, as she once was. The Legal Aid society told her the way to do it was to divorce her husband. The Reimers had already parted after a jangle over Mrs. Reimer's sister, a teacher of musical harmony.

SWIMMING HOLES IN LATEST TRUST

Bristow, Okla., Aug. 21.—During the present hot days in Oklahoma the owners of farms with good swimming holes are charging 10 cents admission to persons who desire to take a plunge. The farmers of this locality agreed on a proposition of this kind, and the boys and men from the surrounding towns are finding it difficult to locate a swimming hole unless they pay the admission price.

"No Trespassing" signs aid the farmers materially in keeping swimmers off their places.

LOAFERS MUST KEEP ON MOVE

Police Have Instructions to Clear Down Town Sidewalks.

Word went out at police headquarters last night to the officers on the different downtown beats and the traffic squadmen to keep crowds of loafers from congregating and standing in front of cigar stores and saloons on Washington street and Morrison street. Police Chief A. M. Cox yesterday would not say whether or not he had issued such an order, but it was generally understood that an attempt is to be made to stop the congregating of hoodlums on street corners and in front of saloons and cigar stores.

Numerous complaints have been received at headquarters during the last few days from women who have been accosted and insulted by street loafers, and many have complained that oftentimes remarks have been made to them by men in crowds on the streets.

The rule will not be made too stringent, as such would probably work a hardship on innocent people, but an effort will be made to rout out the known loafers and those of whom complaints have been made.

JUDGE CAN TELL BY GLANCE AT HANDS

Municipal Judge Frank S. Bennett has developed into quite a detective during the seven weeks he has been on the municipal bench. His latest stunt

is to examine the hands of accused vagrants taken before him.

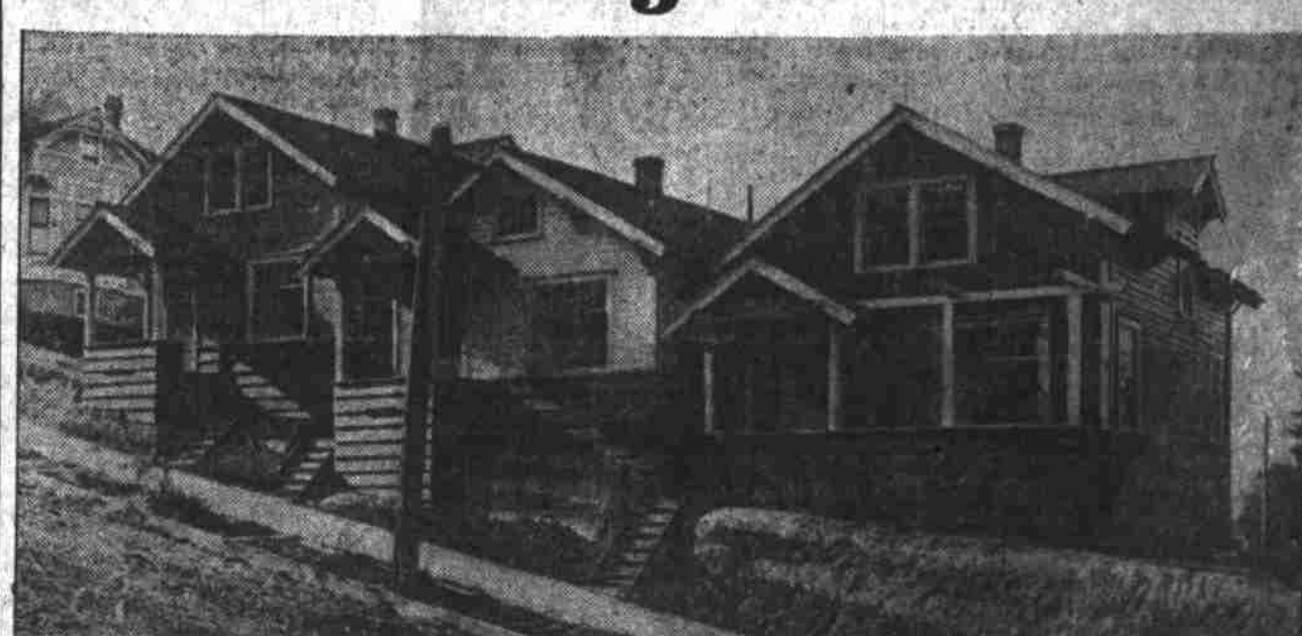

Fumigating Company Organized.

North Yakima, Wash., Aug. 21.—A company is being organized in the Yakima valley, with A. W. Brown of Grandview at the head, for the purpose of fumigating fruit trees. The company will use the formula that has been in use in the older fruit sections, and intend to carry on the work on a large scale. Those interested in fumigating state that it is more effective than spraying. If there is the demand expected the company will be equipped to take care of any number of orchards.
