

Frederick W. Peabody to
Lecture Here This
Evening.

Frederick W. Peabody LL. B., a Boston lawyer, will give a lecture entitled, "Christian Science Exposed," at the White Temple this evening at 8 o'clock. Mr. Peabody is said to handle the subject in plain terms and to present the most scathing arraignment of Christian Science ever made.

"Mr. Peabody has gone deep and far into the history of Mrs. Eddy and of the healing system which, for purposes of brevity, we will call the 'Science of Mrs. Eddy.' Much of this history is familiar to many, but not a little is new to most, and it is all supported by the most convincing and abundant evidence, by the presentation of evidence supplied in the woman's own forgotten letters, poems and articles, by the paralinguals of the 'Science of Mrs. Eddy,' by the publications of the teacher whom she now repudiates, that the whole at least puts upon every 'Christian Scientist' a 'restraining hand' or else to abandon their allegiance to the Concord prophets. There is absolutely no middle ground here. The Concord is in most shameless and uncalumnious, or Mrs. Eddy is the basest of charlatans. And Mr. Peabody presents an evidence so overwhelming that the only alternative is to submit to any test. His charges run the whole gamut from attempted murder to accomplished theft, with emphasis being laid upon the latter. They are not vague, but definite, and every one of them can be settled as true or untrue. Why, then, do the editors of the Concord of Massachusetts are open and until Mr. Peabody is a convicted slanderer no sane and decent person, man or woman, can be a member of the maintenance of Christian Science.
