

COMMITTEE IS SLIGHT QUESTION SOLICITING FUNDS

City Beautiful Movement Well Under Way With Every Prospect of Success—J. C. Ainsworth Chairman of Committee.

Only \$12,000 remains to be subscribed to the city beautiful fund. That amount will be raised by Portland property owners this week before the option on the services of Burnham & Bennett, municipal architects, expires on November 20. The finance committee of the city beautiful movement met yesterday. They listed the property owners, putting opposite the name of each a very reasonable sum which each might be expected to give. Then J. C. Ainsworth was made chairman of a collecting committee of which the other members are A. H. Devers, William McMurray, Marcus Fleishner, John Fleishner.

The work of this latter committee began this morning. It will be continued throughout the week and until the sum necessary to have H. H. Bennett change his plans of spending a year in Europe and come to Portland to help the builders of Greater Portland systematize the scheme of municipal improvements is raised.

Everything Points to Success.

"I foresee success for our plans," said Charles B. Merrick, secretary of the finance committee. "We should more than raise the amount needed from the larger property owners of the city. Whatever amount each may subscribe will be an investment upon which there will be actual money returns in increased valuations. Burnham & Bennett show figures to show that 50 per cent of the money spent for municipal improvements in Chicago during the past quarter of a century have been wasted for lack of a general plan. Portland is in a position to escape this waste by acting promptly, and as secretary of the finance committee I have been given assurance that the amount will be easily forthcoming."

Amount to Be Forthcoming.
The amount necessary to take advantage of the Chicago firm of municipal architects is \$30,000. Already \$6500 has been subscribed. Property owners have signified their willingness to add to this amount whatever might be considered their proper proportion. Mr. Bennett, in communicating with the promoters of the city beautiful plan has advised them that the work will not require less than a year or less than an expenditure of \$30,000. J. C. Ainsworth said this morning:

"We shall have no trouble getting that money. We are just going out and get it. Nearly every property holder believes in the utility of such an investment, and it will not be necessary to ask of any individual a sum which it will cause financial embarrassment in the giving."

SLIGHT QUESTION COMPELS USED STIRS SALEM

Much Criticism Is Directed Against P. R. L. & P. Co. for Alleged Unfairness.

(Salem Bureau of The Journal.)
Salem, Or., Nov. 16.—In a report of the special committee appointed by the council to investigate the lighting monopoly existing in Salem and conditions relating thereto, the Portland Railway, Light & Power company last night came in for a good scoring before the city council, the principal charge being that the Salem patrons of the corporation were not treated with the consideration extended to Portland patrons of the same corporation. Rollin K. Page, local manager for the Portland corporation, also received his share of criticism at the hands of the council committee in its written report. The committee consisted of Councilmen A. N. Moore, W. H. Eldridge and A. T. Moffitt.

The report after stating that the Portland Railway, Light & Power company has not made its charges for lights any lower than its predecessor, though furnishing more than twice as many as the former company, says:

"It is to be regretted that the capital city at the present time has no competition in the lighting business and in this connection, also, we wish to call attention to the general complaint in regard to the inferior quality of gas, gas mantles and electric voltage furnished our citizens."

The report says that the Portland Railway, Light & Power company is making conspicuous in its advertisements in the Portland daily newspapers free renewals of lamps in the endeavor to attract patronage to their company in the city, while "it has not escaped the attention of our constituents that the date of the cancellation on the Salem courtesy of the free exchange of electric lamps was practically coincident with absorption of the Salem Gas Light company by the Portland Railway, Light & Power company."

Alleged Coal Shortage.

Victoria, B. C., Nov. 16.—When the liner Makura arrived from Australia this morning a cable message awaited here with news that there was a big coal strike in Australia and that coal had gone up from 6 shillings a ton to 30 shillings. On this account the Makura is to take all the bunker coal she can carry on her return. Arrivals from Australia say they do not think the strike likely to last, as there is a system of compulsory arbitration in vogue which in the past has been effective in settling strikes in a very short time.

The Makura brought about 150 passengers, among whom were Sir Albert and Lady Spicer and eight of the delegates who attended the meeting of the chambers of commerce of the empire.

U. S. SWALLOWED GROWING GIRLS

Former Federal Judge Says Forced to Humble Himself in School Fight, Leslie M. Shaw Says.

(United Press Leased Wire.)

Los Angeles, Nov. 16.—Eugene V. Debs is coming to Los Angeles to confer with former United States Judge Henry Clay Caldwell. Decisions concerning injunctions given by Judge Caldwell during his service as a federal court judge and their bearing on the present case of Samuel Gompers, John Mitchell and Frank Morrison, who are under sentence for violation of an injunction, undoubtedly will be discussed when the Socialist leader arrives.

During his service on the federal bench, Judge Caldwell gained fame among the supporters of organized labor by recognizing its right to be heard in court through its chosen leaders. He also denied applications for injunctions against organized labor that were concerned in any way with criminal law, on the ground that such injunctions abridged the right of the accused to trial by jury.

When asked the significance of Debs' visit, Caldwell admitted that recent correspondence between himself and Debs indicated the latter's evident interest in certain of the injunction decisions.

"These decisions," said Caldwell, "have a direct bearing on the Gompers case. An injunction was granted against Gompers and others to prevent them from using the word 'unfair' concerning the actions of a certain concern toward organized labor. I ruled that labor might use boycott methods. Gompers should have followed the injunction. Instead, he ignored it. He now finds himself in an embarrassing situation—that of an advocate of the right of a citizen to ignore the rulings of the federal court even though they may be unjust."

It is thought Debs will go from Los Angeles to Spokane to investigate the differences that have arisen there between the Industrial Workers of the World and the municipal authorities over a city ordinance prohibiting street speaking. He is expected to arrive here early this week.

least? Lowitt inquired of his callers this morning. When they assured him that he didn't, he said that he was well and felt in fine spirits, excepting that he did not like the way he had been dragged away from his business in Denver to come out and testify in the bank cases here.

"When the time comes I will show these people that I am not afraid to tell the truth," Lowitt said. "I am a man is innocent he is not afraid and I did nothing but borrow from the bank, which is a legal thing to do, I believe."

"This thing of being famous is great," he said, when he was posed for a photograph at the jailer's desk. "I like to furnish the newspapers sensational copy and lots of it. They have printed so many lies that it doesn't make much difference what they say. Some editorial writers have attacked me from the first, but I don't mind them."

Keeps Away From Details.

Although talkative and apparently in good spirits, Lowitt did not go into many details concerning the indictments that accuse him of the larceny by embezzlement of money from the Oregon Trust. When he was asked to throw some more light on the subject of the Mr. Jackson that he was quoted by Denver correspondents as saying was directly responsible for the crooked loans to his department store, if there had been any crooked loans, Lowitt parried the question.

"I don't know any Mr. Jackson," he said. "I have heard of such a man, but I don't know him myself. And anyway he is not Cooper Morris' brother-in-law. I have never given out any interviews on the subject of Jackson or the Oregon Trust cases."

"I think that I am wanted here because Mr. Cameron believes I will make an important witness," said Lowitt. "All I know is that money was borrowed and I cannot see how that will help him, but I am willing to testify."

Bitter Towards Newspapers.

He seemed to feel bitterly towards some of the newspapers, which he said, had attacked him mercilessly. "While I was in Portland spending money with the newspapers they tried to drive me away," said Lowitt, "but in Denver they try to keep me there and do not say anything about me. Some of the papers there haven't mentioned my name since the case came up."

If Mr. Lowitt secures his bail it is probable he will ask permission to return to Denver between his release and the time for the trial of the Oregon Trust cases which cannot take place until the December term of court. His bonds were fixed at \$10,000 by Judge Bronaugh.

Equalization Board Finishes.

Albany, Or., Nov. 16.—The Linn county board of equalization has completed its work on equalizing the assessments, making its final judgment on complaints received by corporations. There were only three complaints from private individuals. The assessments of the corporations were all sustained, though a few corrections were made in the case of the Northwestern corporation owning suburban property. The board also held that the land assessments and that of the Southern Pacific were not too high, and were in keeping with the other property.

Philadelphia, Pa., Nov. 16.—That the United States was forced to humble itself before Japan at the time anti-Japanese feeling was aroused by the school difficulties in San Francisco, was the startling declaration of former Secretary of the Treasury Leslie M. Shaw, and is causing comment of a varied nature here today.

Before the Neighborhood club last evening Shaw, in advocating the passage of a ship subsidy bill, declared the United States was pitifully unprepared for war and that this country was forced to bow before the Japanese because the government realized its inability to prosecute a successful military campaign in the event of war.

"A short time ago," he said, "we had with us in this city a delegation of Japanese visitors. We told them how much we loved them, and how remote was the possibility of a war between our people and theirs. They took it and smiled. But at the same time their great men at home are declaring that the Japanese are the rightful masters of the Pacific, and they are hinting at their willingness to defend this attitude with arms."

"I'm not trying to tell you that we are going to war with the Japanese, but you can't overlook one fact. Japan has 500 ships of her merchant marine on the water and 50 more on the ways. Every one is under contract to quit commerce and start another line of marine activity at the call of the government."

"There was a deep seated alarm in Washington at the time of San Francisco's outbreak against the Japanese. You don't know how near we were in order to avert it we had to knock down to every condition they demanded. Had we been in condition for war and been possessed of a merchant marine, we never would have had to swallow that bitter pill."

ALLEGED PETTY THIEF BROUGHT TO JUSTICE

Albany, Or., Nov. 16.—The local police are busy these days tracing the theft of bicycles, harness, and other articles. The petty robberies are being laid to Fred Hartman, an erratic young man, who is thought to be at Jefferson today and for whom a warrant has been sworn out. A harness stolen from the barn of W. F. Holman, who lives just across the river, was found and taken charge of by Chief of Police Deas. One of the bicycles stolen was located yesterday and had been sold to Rollin Laubach, a news carrier, for \$5. The wheel had been stolen from Rev. W. P. White of the United Presbyterian church. Thefts of other bicycles being laid against Hartman are those of Dave Patterson and Charles Serffing, postoffice employees, who had left their wheels in the postoffice lobby. Patterson's was sold for \$7.50 and has been located.

NEW BANK TO USE SPRECKELS CAPITAL

San Francisco, Nov. 16.—Permission to use the funds of the estate of the late Claus Spreckels, the millionaire sugar king, in organizing a new bank, has been granted to Rudolph and Claus A. Spreckels as executors of the estate by Superior Judge Coffey. The new institution will be known as the Mercantile National company and is to be operated in conjunction with the Mercantile Trust company, in which the Spreckels have large holdings.

According to the court proceedings the Spreckels plan is to decrease the capital of the Mercantile Trust to \$1,000,000 and then turn a part of the withdrawn capital into the projected institution.

It will be first necessary to secure the permission of the other stockholders in the trust company before they will be in position to consummate the scheme.
