Scattle, Nov. 30.-John Bennett Rogers, whose name and address were on letters and documents found in the pockets of a man arrested at San Francisco last night for attempted burglary. is not known in this city, no such name appearing in the city directory. The address given in the letters and papers, however, proves to be the place of business of the Kentucky Liquor company,

and it is stated by persons there that a man named John R. Rogers formerly owned the husiness, but that he sold out his interests eight years ago and left the city, since which time nothing has been heard of him. San Francisco, Nov. 30 .- After a des


