

MURDERER WALKS 36 MILES, TELLS SHERIFF OF DEED

James McGuire Fires Rifle
Bullet Into Agnes Knappe's
Heart, Then Telephones to
Grants Pass.

(Special Dispatch to The Journal.)
Grants Pass, Or., Jan. 12.—At 11 o'clock yesterday morning James McGuire shot and killed Agnes Knappe in a little mining district called 36 miles from this city.

Immediately after the shooting, McGuire telephoned to Sheriff Joe Russell here, telling what he had done and that he was on his way to Grants Pass to give himself up.

McGuire arrived at the sheriff's house at 6 o'clock this morning and is now in the county jail. There were no witnesses to the shooting.

McGuire says he met Knappe on the trail, that Knappe shot at him and that in self defense he killed Knappe, shooting him three times with a 25-30 Winchester rifle. McGuire then left his victim where he fell and came to this city to give himself up to the sheriff.

Criminals Old Quarry.
The two men were miners and were about 60 years of age. The shooting yesterday culminated a quarrel of several months' standing, bad blood having existed between Knappe and McGuire over mining matters.

McGuire had been persecuting Knappe in numerous ways and that among other things Knappe had killed his dogs. Sheriff Russell, the prosecuting attorney, the attorney for McGuire and Coroner Stricker left this morning for the scene of the shooting. Two men sent back this morning are watching the body of the murdered man until the coroner's arrival. An inquest will be held on the trail.

McGuire, as also was Knappe, is unmarried. Neither has relatives here so far as known.

About 10 years ago McGuire was implicated in a shooting scrape at Oak Flat, near the place of the present trouble, but in that encounter he was the one to receive the bullet. He was shot through the breast by Joe Connor and dangerously wounded, the bullet passing out over the heart.

When seen this morning McGuire was pale and haggard and hollow-eyed as a result of the hard travel of last night and the heavy strain of the position in which he is placed by taking the life of a fellow being.

STAGE MONEY NOT FOR ADVERTISING

Uncle Sam showed his hidden hand today when Steve Connell, superintendent of the northwestern division of the United States secret service, confiscated 50 photographic reproductions of a United States treasury check, to have been used for advertising purposes.

Some time ago the government bought a vacuum cleaner to be used in the general postoffice building. In payment, a check for \$130 was sent to the manufacturers of the cleaner by the assistant secretary of the treasury.

Thinking reproductions of the check, an excellent advertisement, the company had a photograph made of the check, and 50 prints were made. As soon as Mr. Connell heard of the company's intention of circulating the reproductions, he ordered the confiscation of all the prints and the negative.

Federal laws strictly prohibit the reproducing of government obligations of any kind for advertising purposes.

DETECTIVE DAY LOSES PRISONER

Goes to Philadelphia to Get Growth of City Requires About
Man and Woman, but Re-
turns With One.

Joe Day, city detective, who was sent to Philadelphia, Pa., to bring two prisoners to Portland, has notified Chief of Police Cox that he is returning with only one. The two people whom he was to bring back are Samuel Levine and Miss Minnie Kesten. They are wanted upon an indictment in this county for committing burglary in the home of M. Himmelfarb, 630 1/2 First street.

The word sent by Detective Day is that the man was turned over to him after a hearing in the Philadelphia court, but that the court claimed there was a lack of evidence to connect the man with the alleged deal. Another statement of the affair from Philadelphia is to the effect that Detective Day failed to make known to the court that he wanted the woman, and she was turned loose. She was also given the \$1500 found in her pocket when arrested.

Day Testifies.
The same information states that Detective Day and the detectives who made the arrest went on the stand and testified in regard to both prisoners. Levine and Miss Kesten were brought together in a fashionable rooming house, and part of the goods they were alleged to have taken from the Himmelfarb home were found in their possession.

The records also show that the Philadelphia authorities located the couple, got the evidence and notified the Portland police. The eastern authorities said they had sufficient evidence for an indictment, which was returned here in due time. Detectives Day and Hyde were sent after the two prisoners. Governor Benson had issued requisition papers for the couple, and these with the evidence and statements of the case were presented to Governor Stuart of Pennsylvania. He passed upon the matter, and in so doing held the two people had committed a crime and that they should go back to Portland.

The preliminary hearing before Magistrate Scott in Philadelphia, the case was again gone over. The report states he held the man should return, but discharged the woman.

Geary Not at Fault.
When Magistrate Scott was asked why he did not hold the woman for her return to Portland, he explained that he did not know she was wanted. It appears that he had not been informed that the necessary papers had been secured for her arrest.

The woman was given the money found in her purse. When she was wanted a few minutes later she could not be found.

Levine and Miss Kesten came to Portland last summer. They became acquainted with the Himmelfarb family and made several calls. Himmelfarb stated he missed jewelry valued at \$1200. This was on November 24.

Chief Cox immediately telegraphed the descriptions of the stolen jewelry, and on January 10, this morning, the police arrested the couple. When they were arrested they had \$2700 in money and about \$1000 worth of jewelry.

WIDOW AND CHILDREN OBJECT TO BIG FEES

County Judge Webster this morning heard argument on the objections of Emily J. Noon, widow of the late W. C. Noon, to the allowance of \$2900 attorney fees and \$1800 executor fees asked by W. J. Armstrong and W. C. Noon Jr., the executors, who say these further allowances should be made because of the long litigation in construing the will of W. C. Noon.

Thomas G. Greene, arguing for the objectors, said that the doubt as to the meaning of the will existed only in the minds of the executors and their attorneys. The heirs and the court agreed, he said, but it was necessary for a legal fight, extending to the supreme court in one case and afterward through the circuit court.

Cyrus A. Dolph, representing the executors, contended that the objections based on such grounds should be stricken out. The court will not doubt exist as to what the will meant, he said, and the supreme court of the state took two guesses at it. On the first guess the court held that the income from the shares of the W. C. Noon Bag company should be paid to the heirs, and on the second guess the court held that the income should be paid to the executors.

ATTEMPT TO QUASH JURY INDICTMENTS

Attorneys C. W. Fulton and S. B. Huston commenced proceedings in United States court yesterday which may lead to the quashing of all indictments returned by the November grand jury. The attorneys appear for J. Thorburn Ross and Frank E. Holbrook, two of whom was indicted in connection with the failure of the Title Guarantee & Trust company, and the latter for fraud in the acquisition of government land for the Oregon Land & Water company.

Attempts are being made by the attorneys to show that the November grand jury was not properly constituted, in that five of the jurors were not taxpayers in the state of Oregon, as is required. If all indictments returned by the grand jury are quashed, S. V. Davidor, the real estate swindler, against whom a true bill was brought in, may be permitted to return from Canada a free man.

THUGS WILL WORK ON CITY ROCKPILE

Jose Sanchez was given 90 days on the rockpile today in municipal court for robbing a man in a north end saloon. Andrew Hendrickson was given 30 days, and Daniel Atlantes was given 30 days. The two latter were charged with taking \$18 from Richard Brown while he was asleep in a north end rooming house.

Soldier Overcoats Stolen.

Vancouver, Wash., Jan. 12.—William Hoffman, of M. Company, Vancouver, reported to the police that three olive drab overcoats had been stolen last night from the Vancouver skating rink. A soldier is alleged to have been seen in front of the Log Cabin saloon with three coats answering the description of those stolen. No arrest has been made.

CHIEF COX ASKS FOR MORE HELP

The rapid growth of the city is shown in the annual report of Chief of Police Cox to the mayor and city council, in which he asks that 40 new policemen be given him to handle the outbursts of the city. The past year, the police department has been called upon to stretch its protection to the suburban residents, and these have grown to such a number that the new men are absolutely necessary.

"The east side, as well as the west, is growing by leaps and bounds, and we cannot patrol it with the men we have. The mounted policemen are busy from night until morning, and we are in great need of at least 40 new men. I could easily handle 50, and next year we shall need them for the outskirts of the city keep building," said the chief.

There are now 123 patrolmen, four captains, 11 detectives and the chief. A fund for the provision of medals for policemen who do some meritorious work is the further recommendation Chief Cox has made.

The recommendation is also made that the city provide thimbles to be set in the sidewalks on certain downtown streets that are generally roped off during crowded days. Posts are to be inserted in these sidewalk thimbles, and ropes swung on the posts. Heretofore the ropes have been attached to the telephone poles.

IRVINGTON CLUB HOLDS MEETING

The annual meeting of the recently reorganized Irvington club was held last night at 8 o'clock at the clubhouse, corner of East Twenty-second and Thompson streets. That the new organization is flourishing was shown by the reports read by outgoing officers and trustees.

The following trustees, selected to serve one, two and three years, were elected: W. F. Woodward, Walter M. Cook, E. F. Owen, L. M. Starr, P. E. Harrison, Walter Goss, R. W. Wilbur, F. S. Fields and H. M. Haller.

Within a few days a meeting of the trustees will be held and officers elected. Arrangements for enlarged quarters will also be made. Some action may be taken looking toward the improvement of the city courts and the playground on the club's property.

LITIGATION ARISES FROM TINY ESTATE

Probably the smallest trust estate ever involved in litigation in the circuit court gained entrance today when Alma E. Barker, as guardian for her children, Letha, Leone, and Doris Barker, sued L. C. Jameson to compel him to turn over \$45 to supply their needs of clothing and support. The petition recites that Mrs. Barker and her husband, William Barker, owned real estate near Hillsboro, that he deserted her, and that before he left she joined in a sale of the land on condition that any sum above incumbrance should be held by Jameson in trust for the children. She says \$45 was realized above the debt and that Jameson refuses to turn over the money to supply urgent needs.

SOUTHERN PACIFIC EMPLOYEES PROMOTED

C. H. Dexter, who was recently appointed general agent of the freight department of the Southern Pacific, today announced his office force, the list meaning a general promotion of the old employees.

Frank H. Hocken will be contracting freight agent, J. W. Platts will be chief clerk and W. P. Mott will be rate clerk. Mr. Dexter was promoted to the position vacated through the promotion of H. E. Lounsbury to the position of district freight agent for the Southern Pacific lines in Oregon.

BROADWAY BRIDGE PLANS APPROVED

City Attorney Kavanaugh this morning drafted an ordinance formally approving the plans and specifications for the new Broadway bridge. The ordinance will be submitted to the council this afternoon at a continuation of this morning's adjourned session. The formal approval of the city is in no wise necessary, but it was desired by the administration, to lend weight to the request that will be made upon the war department for its consent to the construction of the big span.

SAYS HOUSE NOT BUILT FOR FUEL

Alleging that Matthew A. Shanklin and his wife, caught woodless by the cold snap, are tearing up his house for fire wood, Albert E. Lindgren and his wife have brought suit in the circuit court to foreclose on property they sold Shanklin and to enjoin Shanklin and his wife from cutting the house into stove wood. The purchase price was \$600 for a lot and house in Queens Ave. and a portion of the interest is unpaid.

FRANK E. RODMAN NO LONGER HELD FOR DEATH OF MRS. REAL

If Frank E. Rodman is ever brought to trial on the charge connecting him with the death of Mrs. Clara May Real, who was killed by joy riders on the Linnton road last August, the case will have to be taken up anew. The siding Judge Bronaugh in the circuit court this morning granted a motion for judgment after the case had been remitted because of a defective indictment.

Opinion is divided as to the likelihood that Rodman will ever face a jury. It is certain that if the district attorney can secure no more evidence than was brought out at the trial of Mrs. Maddux, he will deem it useless to bring in a new indictment. As Mrs. Maddux has been acquitted, no testimony connecting her with the affair would be permitted and the state theory of the case in that she and Rodman were together in the automobile that ran over Mrs. Real.

Rodman was at the trial of Mrs. Maddux and identified as having been at the Claremont tavern with an unidentified woman before the hour Mrs. Real met her death, and Mrs. Maddux was identified as the woman who accompanied an unidentified man proceeding toward the Linnton road, but with Mrs. Maddux cut out of the equation and no additional evidence concerning Rodman the state would be helpless.

RETAIL GROCERS ELECT OFFICERS

J. C. Mann Is President and
Emil Gunther Vice President
—Association Grows.

The annual meeting of the Portland Retail Grocers' association was held last evening in the association's rooms in the Commercial building, with a large attendance. The report of the auditing committee showed that the association is in better financial condition than ever, and that the membership during the year increased by 75.

The chief business transacted was the election of officers, which resulted as follows: President, J. C. Mann; vice president, Emil Gunther; secretary, George Hocken; treasurer, Dan Kellaher; directors, C. W. Stubbs, Emil Wommelsdorf and B. J. Dresser. Charles B. Merrick, acting secretary for the past four years, but who is now in charge of the United States land office, was elected an honorary member.

Arrangements were made for a special car for delegates from Portland to the state convention in Eugene, January 24 and 25, and it was reported that 34 delegates would go from this city. No appointment has yet been made to fill the vacancy caused by Mr. Merrick's resignation as assistant secretary and it is understood that none will be made for some time, as the office force that has worked under Mr. Merrick is able to take care of the work. Because of his appointment to the land office, Mr. Merrick has declined to accept the office of secretary of the Oregon Retail Merchants' association which had been tendered him.

COUNCILMAN WILL REPORT ON BURNER

Gay Lombard Says He Is Opposed to Lewis-Kitchen Type of Plant.

Councilman Gay Lombard will tomorrow make public a report made by him to the health board on the result of his recent tour of inspection over the Lewis-Kitchen plant for the purpose of gaining information as to the best type of crematories now in use.

"My report is adverse to the Lewis-Kitchen plant," said Mr. Lombard today, "and because the company offering that type of incinerator is endeavoring to force it on the city, I deem it advisable to let the public know what I learned about garbage burners on my trip. I will say no more at this time except to reiterate my opposition to the Lewis-Kitchen incinerator. It is a low grade burner and the city would make a great mistake if such a plant should be selected."

MRS. HUTTON TAKES ON EQUALITY

WANTS ENDOWMENT
TO REACH \$500,000

Mrs. Mary Atkewright Hutton, wife of the Spokane, Wash., capitalist, president of the Washington Political Equality league, made several sensational statements regarding women's suffrage in an interview today. Mrs. Hutton said that the women of California, going later to Washington, D. C. They are guests at the Hotel Portland.

"Women who do not take their full share of the responsibilities of life are little short of criminals," was Mrs. Hutton's opening statement.

"I have no fight against men, nor do I condemn womanhood. In fact, one of my strongest arguments for suffrage is that it would broaden women and cause them to be more tolerant of their sex."

"Another argument for suffrage is that it would be the best solution of the divorce evil. With suffrage, men and women would better understand one another, and the little frivolities and extravagances that characterize so many would be eliminated."

"Gossiping would soon become a thing unknown of we had suffrage. Women would then think of the big things of life and not the little ones as they do now. Women need broadening."

"I believe the ballot would make women more womanly. Why shouldn't it? It would tend to widen their knowledge and would naturally make them more tolerant and thoughtful."

"My private belief is that such measures as are employed by English women suffragettes are but a result to American manhood. And I think American manhood the finest in the world."

"We want equality above all other things. I would compel every child attending school to wear a uniform so there would be no inequality in dress."

Mrs. Hutton declared that under present conditions, a militant movement of the suffragists would not be necessary in the United States. "I predict a great victory," she said.

WOULD-BE FOOTPADS LOSE THEIR NERVE

WANTS ENDOWMENT TO REACH \$500,000

President Homan of Willamette
Recommends Campaign
for That Amount.

In accordance with the recommendations in Dr. Fletcher Homan's report at the semi-annual business meeting of the board of trustees of Willamette university it is likely that a campaign will be started to secure an increased endowment for the university. In his address at the banquet last night Dr. Homan again emphasized the need of a greater endowment, and although he placed great stress upon the value of their new buildings, he pointed out the fact that it was necessary to maintain these buildings, and he said he hoped to see the day when the endowment fund would reach \$500,000.

By-Laws Amended.
At the afternoon meeting of the board of trustees the by-laws were so amended that the board may now annually elect six trustees-at-large. The first trustees will be elected by the board under the new ruling at Salem next June. The remainder of the meeting was devoted to an informal discussion of finances.
