Her parents in this city announced today that their daughter was wedded last week to Charles A. Comstock, a wealthy coal man of Chicago.
The couple will live at Evanston, Ill., a suburb of Chicago, for Mrs. Comstock has firmly decided that the spotlight shall seek her out no more.

side of the recent disastrous one in Hocking, and he is a master of all the tricks in stock juggling. Some years ago he operated a pool in Reading and at one time he managed a campaign in American Sugar. He is not a member of the stock exchange, and therefore is not amenable to its rules and regulations.
Keene is very reticent and does not like to make public the ways and means of his financial operations.
Much as the Hughes Wall street investigation committee was anxious to have Keene give it pointers regarding stock manipulation, he evaded, being served with a subpoena, as the committee was obliged to write its report without having had the benefit of listening to Keene's own story of remarkable practices in the financial world.
After Keene read in the newspapers that he was described as having evaded service of a subpoena, he telephoned to Ralph Wolf, counsel for the receiver, that he would be willing to receive the process servers at his apartments at the Waldorf-Astoria, New York. Two of Wolfe's men hurried to the hotel and made haste to reach the twelfth floor. There the manipulator awaited them and when the papers were handed to him, he said:

clot and former Governor Farabee of California. I went over the entire situation. Mr. Pinchot thought, after I had finished that I should present such a serious matter to the president. He gave me letters of introduction to various people and the next night I left for the east.
"Then, before leaving I thought that Mr. Shaw (referring to A. W. Shaw, former assistant law clerk of the forestry service, and one of the officials charged with the Pinchot) might have additional information and it was as a result of that that Mr. Pinchot said he would have Shaw meet me in Chicago.
"When I got there I met Shaw and he explained the difficulty encountered in Washington in getting some of the records. He said at first they refused to show any of the Cunningham papers.
"Goes to Taft at Beverly.
"The next day Shaw went with me over my report, suggesting some changes both in form and substance. I did make some changes in the form of it but the substance remained just as it had. Then I went to Beverly, Mass. I met the president and presented my report.
"The president asked me then about waterpower sites. There had been some newspaper talk about this and I wired Shaw to bring to Boston some information regarding waterpower sites. This he did.
"Well, while I was in Boston, Secretary Carpenter advised me that the president had sent a copy of my report to Secretary Ballinger and said for me to go back to Seattle. This I did. Then, two weeks later, or thereabouts, I was dismissed."
Thought Dennett Crooked.
Glavis charges against Dennett came during an interval of calm after there had been the monotonous reading of evidence. The witness had said that Dennett had stated that no admissions had been made to him by the Cunningham claimants of the proposed agreement to consolidate. Glavis said, however, that examination of some of the claimants had tended to arouse his suspicions.
"It was then that I first began to think Dennett crooked," he said.
During Glavis' testimony there were a number of interesting episodes. "Do you think that Ballinger and Dennett were in league to secure fraudulent coal lands?" asked Representative Jenby.
"Well," answered Glavis, slowly, "I had some evidence to lead me to believe that Mr. Dennett needed the support of all the influential people to be reappointed commissioner of the land office, and on that ground, I thought perhaps he might go farther than he might originally. Judge Ballinger, I don't know. It's pretty hard to tell just what he was going to get out of it, or whether he was going to get anything out of it."
Representative Denby: "Did he take

any action on these coal cases while he was secretary?"
Glavis: "He did take active part in the conduct of the Alaskan situation."
"Then you don't place any reliance on his statement to the contrary?"
"No, I don't."
A long discussion then ensued as to the legality and propriety of Ballinger's connection with one of the Cunningham group of claimants during the period between his resignation as commissioner and his appointment as secretary of the interior.
There was a good laugh when Attorney Brandeis read a letter from Commissioner Dennett to Chief Schwartz of the field service division. Referring to Glavis, it said:

Preparations are being made by members of the Portland Musical Festival chorus to make the spring musical festival the most notable in the history of the organization.
Working to this end, members of the chorus are holding rehearsals on Tuesday evening of each week in Ellers recital hall, under the direction of W. H. Boyer, director. Great success is predicted by all interested.
Dates for the holding of the spring festival have not been fixed, and will depend upon the time of completion of the new Hellig theatre, now being built at the corner of Seventh and Taylor streets.
And for the reason that the dates are

T. J. Kirk.

Athens, Or., Jan. 29.—T. J. Kirk, a prominent Athens farmer, former member of the legislature and president of the First National bank of Athens, died at his home in Athens. Death was the result of chronic liver trouble combined with a severe case of grip.
T. J. Kirk was 70 years of age. He crossed the plains from Missouri and settled in Linn county, Oregon, in 1848. He moved to Umatilla county in 1871 and took up a homestead claim where Athens now stands. He served two terms as a representative in the Oregon legislature and three years ago was candidate for state senator against Dr. C. J. Smith. He was defeated in that race.
He is survived by his wife and three daughters: Mrs. Ed Koonz of Athens; Mrs. Eli Ackles of Portland; the third lives at White Salmon.

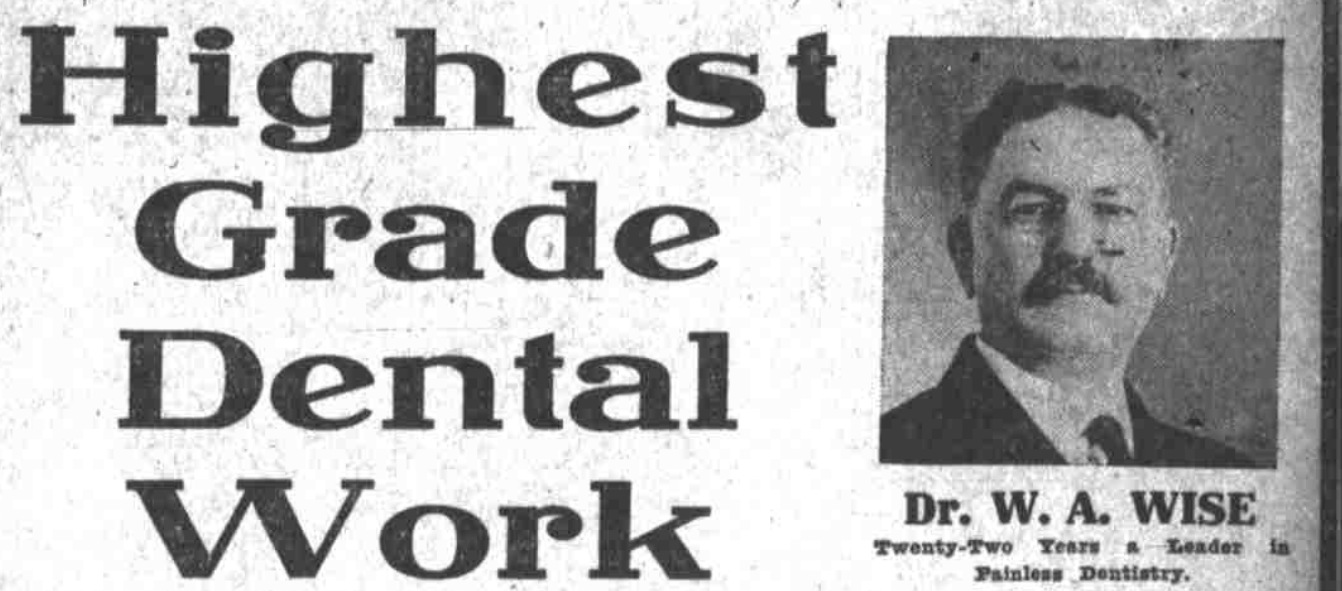

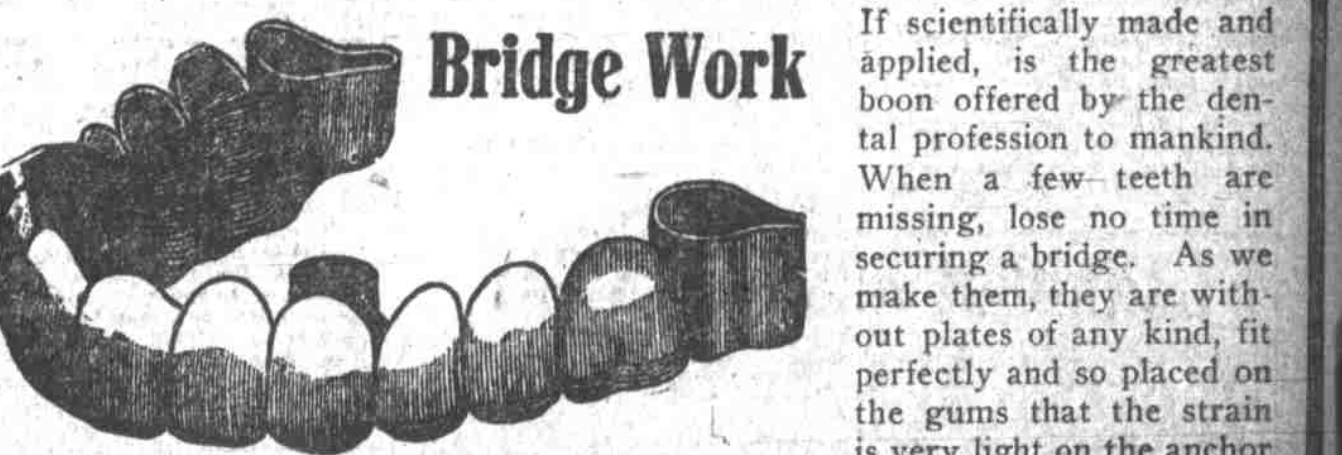
