DECIDES RATE CASE AGAINST O. R. & N. CO.

Judge Wolvorton Hands Down Important Decision Holding Rates to Points East of The Dalles Prohibitive.

Federal Judge C. E. Wolvorton this morning handed down an opinion in the Oregon distributive rate case, sustaining the demurrer of the Oregon railroad commission and dismissing the amended bill of complaint of the O. R. & N. Co.

As his first action the O. R. & N. filed in 1907 a bill attacking generally the whole commission act for alleged conflict with both the federal and state constitutions.

On September 28, 1908, Judge Wolvorton filed the opinion of the court, in which he discussed at length the question sought to be raised by the bill.

No Interference. This commission act was held to contravene none of the provisions of the federal or state constitution, and was held not to amount to a constitutional interference with interstate commerce.

(Continued From Page One.) seems just as the motorman, unconscious and probably dying, had been dragged to a lamp post, over which the end of the rope had been thrown.

Charging the crowd, Sykes drove his horse to the motorman, seized him by the collar of his coat and dragged him through a lane of cursing, fighting men for several hundred feet into the shelter of a cigar store.

The mob profited by the temporary police bewilderment to beat and trample the conductor into unconsciousness. He was rescued by the mounted men and sent to the hospital in a dying condition.

The mob before the cigar store made a concerted effort to enter the place. Revolvers flashed in the hands of many of the attackers, and at this the police charged full tilt at the rioters.

Men were beaten down by the police and trampled under the feet of their horses, becoming alarmed at the determined onslaught of the bluecoats, the crowd ran for shelter, and the police were able to disperse the throng gathered about the stalled car which had been smashed to splinters and broken glass.

Twenty arrests of ringleaders were made by the police in addition to those whose injuries compelled hospital attention.

The hospitals of the city are becoming overcrowded with injured men, many of whom are under arrest charged with rioting, assault and other crimes. The rioters succeeded in accomplishing their object of preventing the company from operating its cars from the Frankfort car barn.

Nearly every car that left that barn today was wrecked and its crew of strikebreakers and police protectors dispersed. Every car that left the barn was attended by special police of the company and regular patrolmen, but these were practically helpless against the overwhelming odds they faced.

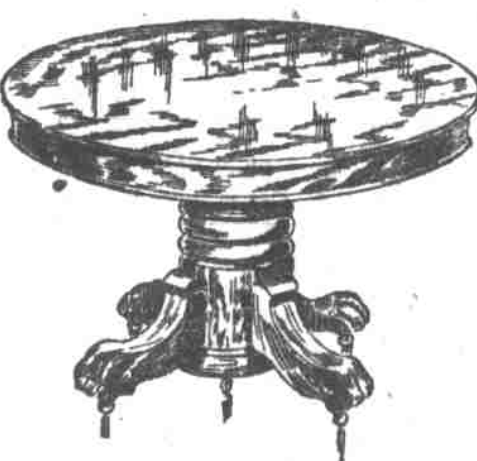
