HOLIDAY FEATURE IS ANNUAL BALL BY PORTLAND'S BEST

Washington's birthday is being observed at the police station in an unusually quiet manner. The most activity shown is by the policemen preparing for the annual ball to be given this evening at the Army.

Only 12 men were arrested last night for being drunk, six were taken in for being disorderly, and one for assault. Until 1 o'clock there had not been an arrest. Patrolmen over the city had reported a large number of persons and horses slipping on the sidewalks and pavements. Some were sufficiently serious to need medical attention.

At noon the police band gave a parade on the downtown streets, in honor of the ball this evening. Promptly at 7:30 this evening the day and second night of the annual ball, a raffle organization, the Portland Railway, Light & Power company, will put on special service to the grounds, while the Oregon Railroad & Navigation company has promised that should it be necessary they will put on 100 coaches between the union depot and the fair grounds out in Rose City Park. Special rates are to be made into the city, advertising is to be hurriedly sent out all over the state.

STATE TROOPS WITH BAYONETS DISPERSE MOB

In the hope that the carmen's strike may be broken, Union men threaten both criminal and civil actions against those responsible for his arrest and detention.

While the specific cause leading to the arrest of the national organizer is kept a secret, it is understood to have resulted from an attack on a car by a mob which Fratt had previously addressed on the street.

The Philadelphia Rapid Transit company today issued a statement that the company was operating 725 cars out of a normal 2000 and that it could put 300 more cars in operation as soon as it was afforded police protection.

The strikers assert that the company is operating only 125 cars and these are running so irregularly as to be of no benefit to the company.

No Compromise, Says Krueger.
President Krueger today set at rest all rumors of a compromise of the question at issue by announcing that the company would consider no proposition from striking men save unconditional surrender to the dictation of the corporation.

Few cars are being operated today and each of these is accompanied by a guard of from four to six policemen. Drivers of automobiles are reaping a harvest, as are striking motormen and conductors who have manned drags fitted with seats in which all classes ride. Many of the striking platform men are eking out a subsistence by selling newspapers.

Rioting Resumed.
With the appearance of the first car today rioting was resumed by sympathizers with the strikers. A mob of about 100 persons gathered in the Kensington district, which has been the principal scene of disorder, and attacked the first car that came along. An unusually strong detail of police managed to protect the strikebreakers who manned the car and to disperse the mob after a brisk clash.

A few minutes later a car was stalled at Germantown and Lehigh avenues in the Kensington district and in the riot which followed Frank Kalb and Walter Stein, both boys, were seriously injured.

Kalb was taken to a hospital suffering from wounds which the doctors pronounced mortal. A magistrate was called to take the lad's statement.

Rain was falling in the morning and this tended to decrease the disorder.

Four hundred additional special policemen were sworn in today. This brings the forces at the disposal of the city up to 3500 regular police, 3400 special police, 50 members of the Philadelphia Firebirds, a rifle organization, several hundred city employees and occasional fire companies which are called out when riots occur adjacent to the fire houses.

LAND CASE HEARING DRAWS TO CLOSE
(Special Dispatch to The Journal.)

La Grande, Or., Feb. 22.—In the case of the government against the Northwestern Lumber company of Spokane and 26 other defendants, which the government alleges are dummy entrymen and men who entered into a conspiracy with the Spokane concern to defraud the government out of land near Heppner, the government testimony was concluded here yesterday with Special Agent Fred Hupp handling the government case.

David Wilson, president of the Northwestern concern, and several attorneys were here to handle the defense. Two weeks hence Geary and possibly Simon of Portland will come here to introduce testimony for the 27 defendants. The suits were filed by the government about a year ago, and Agn B. Thompson, then receiver of the land office here, and J. W. Scriber, cashier of the Farmers and Traders National bank, are implicated in minor ways with the defense.

SEATTLE SUICIDE WAS A FUGITIVE

Seattle, Feb. 22.—It became more evident today that Thomas A. Brooks, who knelt before a streetcar and was killed here last Wednesday, tried suicide to escape the police. A special dispatch from Joplin, Mo., says:

"Told that her husband, Thomas Brooks, had been killed in Seattle, where he was being sought on a charge of having attempted to murder her, Mrs. Brooks, employed at the Turner hotel in Webb City, fainted. On reviving she declared: 'Well, he tried to kill me. I'd never have lived with him again.'"

SHASTA LIMITED IS DELAYED AT MARION
(Salem Bureau of The Journal.)

Salem, Or., Feb. 22.—Northbound Shasta limited, due at Salem at 7:33 o'clock last night, was wrecked near Marion this county. Spreading rails was the cause of the accident. There was no casualties. Only the engine left the track. After a delay of about 6 hours the train was gotten under way for Portland at about 5 o'clock this morning.

THIRD MAN DIES ON THE WASHINGTON
(United Press Leased Wire.)

Port Townsend, Wash., Feb. 22.—The third smallpox victim on the cruiser Washington was buried at the detention camp today. The man was Michael Ropinski, a coal passer, 22 years of age, a native of Wisconsin. A strong effort is being made to have the Washington released from quarantine that she may proceed to Bremerton for overhauling. The cable ship Burnside is still at the quarantine station, but will probably be released in a few days, no new smallpox cases having developed.

TILLMAN'S CONDITION EXTREMELY HOPEFUL
(United Press Leased Wire.)

Washington, Feb. 22.—A bulletin indicating that Senator Ben Tillman is experiencing the best day since he was stricken with paralysis was issued this afternoon by Dr. Tickford. The bulletin read:

"The patient's condition is very favorable. Paralysis and aphasia are disappearing unusually fast. Barring unforeseen complications, the danger is over."

Phone Company Incorporates.
Vale, Or., Feb. 22.—Articles of incorporation of the Riverside Rural Telephone & Telegraph company have been recorded. The incorporators are: S. W. French, W. G. Thomas and Charles Johnson. The charter empowers the company to build, construct and maintain telephone and telegraph lines and electrical devices. The principal office of the company will be at the house of Myron Hatch, on Riverside flat, Malheur county. The capital stock is \$1500, divided into 150 shares of \$10 each.

Franz Josef Fears for Greece.
Vienna, Feb. 22.—Emperor Franz Josef today ordered the Austrian minister at Athens to urge King George of Greece not to abdicate. The emperor fears the downfall of the present dynasty and a period of anarchy in Greece as the result of the internal difficulties caused by the army-navy embargo. Bulgaria is concentrating her troops along the frontier. This move is believed to mean that she may attempt to seize Macedonia in the event of further trouble in Greece; Turkey might also become involved.

ORTIS HAMILTON READY FOR TRIP TO PENITENTIARY

"Entrance Fee" of \$5 Paid by Parties Who Refuse to Divulge Identity, and Appeal Is Dismissed.

Olympia, Wash., Feb. 22.—Ortis Hamilton, former adjutant general of Washington, convicted of embezzlement, is ready for his trip to the penitentiary at Walla Walla. He may be taken to-night. The \$5 fee which the state demanded of Hamilton literally for the privilege of going to prison, has been paid but all parties concerned refuse to state who advanced it. Hamilton's appeal was dismissed last night following the payment of the money.

PLANT ROSE BUSHES DESPITE SNOW AND COLD

(Continued from Page One.)

I have been requested to tender to the city of Portland 170 Japanese roses as a token of their friendly respect and genuine good will. What we offer you may be a rather poor symbol of our friendly sentiments, but we know you will receive it as an indication of our unalloyed esteem and friendship.

Travel 3000 Miles.

To say nothing of the intrinsic value of the roses, which traveled on water over 2000 miles, the fragrant scent and charming color, which will delight the citizens of Portland in the blooming season, seem to be the most appropriate tribute from their sincere friends on the other shores of the Pacific ocean, this ocean which, instead of separating America and Japan, bring the two neighboring nations into closer and friendlier relations by the maritime trade and intercourse; and therefore the expression of our respect and affection has taken this artistic and at the same time most natural and lasting form.

"It is a most appropriate and happy idea that these roses will be planted on the 22d of February, the birthday of George Washington, whose memory is revered not only in America but even in Japan."

Washington's Greatness.
"Although nothing that I could utter would add one jot or tittle to his greatness, I may say with impunity that his character and actions, as a patriot, a statesman and a true man are taught to the Japanese pupils in all the primary schools of Japan."

"I sincerely hope that these roses planted on the marvellously fertile soil of Oregon and under the benign weather of the sunny Willamette valley, will grow as steadily as the city of Portland is growing and also that they will flourish in full bloom year after year with their renewed vigor and beauty, in keeping with the wonderful prosperity and development of this city in the future as in the past, and will further crystallize the friendly sentiment existing between your great republic and our country."

Presents Bushes.
"As such an emblem, these roses are presented to you, gentlemen, and along with them the sincerest wishes of the citizens of Yokohama for health, happiness and prosperity to you all."

One of the interesting features of the exercises was the planting of the "old Mission Rose." This variety is

perhaps the oldest known to Oregon people, having sprung from a slip brought to the northwest in the early days when the Hudson Bay held dominion here.

George H. Himes, secretary of the Oregon Historical society, was asked some time ago to tell something of the origin of the rose, and in answer sent the following letter to President R. W. Hoyt of the Rose Festival association:

History of Rose.
"The history of the 'Mission Rose,' which I sent you today to be planted by the city of Portland tomorrow in the name of the Oregon Pioneer association, is contributed by Mrs. C. M. Cartwright, an honored pioneer lady of Portland, who came from Illinois to Oregon in 1845."

The history of this fragrant rose is involved in obscurity in a great degree. My own theory about it is that it was brought overland from Canada by authority of Dr. John McLoughlin between the years 1825 and 1830, and that it was first set out at the Hudson's Bay post of Fort Vancouver by the old Scotch gardener Bruce. The first time I saw it was in the summer of 1854 in Thurston county, Washington, when my mother got a slip or root from Dr. William Fraser Tolmie, the chief factor of the Puget Sound Agricultural company, a branch of the Hudson Bay company, the headquarters of which were at Fort Nisqually, built in 1833, about 12 or 15 miles from the present city of Tacoma.

From Fort Vancouver.
"It was the understanding then that the rose came originally from Fort Vancouver. At the time my mother got her rosebush from Dr. Tolmie she learned that a neighbor, Mrs. David Chambers, a pioneer of 1845, had a rosebush of the same kind which she claimed to have obtained at Fort Vancouver in 1847 or 1848."

John Minto, a pioneer of 1844, and one who is deeply interested in matters of this kind, when asked some time ago to state what he knew about the 'Mission rose' and how it came by its name, said:

"I have no knowledge of its history beyond finding the bush near some six or eight peach trees, and also near a bed of rhubarb or plant in what had been the first garden formed by Rev. Jason Lee and his nephew, Rev. Daniel Lee, in 1824-5."

Planted at Same Time.
"All the fences and fields and garden had been washed off by the flood of the Willamette in December 1843, which had left its marks four to 30 inches upon window frames on the inside of the mission house. I purchased the property late in August, 1845, from David Carter, who was a volunteer assistant to the mission, and who purchased the claim from Rev. George Gary, the agent of the mission board in New York, but had never used the building or garden subsequent to the flood."

"Said appearance indicated that the trees, the rose bush and the rhubarb had been planted at the same time, nine or 10 years before, as the trees were too old to remove without great and especial care. I took an early walk with Mrs. Carter, at the new home, making it mine by arrangement with Mr. Carter till forming a home of my own."

Removed Rosebush.
"Then I removed my part of the rosebush and rhubarb to my chosen garden spot, and from both divided with neighbors as they settled around us. It thus became natural for me to speak of it as the 'old Mission Rose,' as I had got it from what was spoken of as the 'old Mission Farm.' Starting a little nursery in the early 50s, I sent slips of the rose, to Jacksonville, south, and to Olympia, north, under the name of the 'old Mission Rose.' The 'old Mission Farm' was in Marion county, near the town of Wheatland."

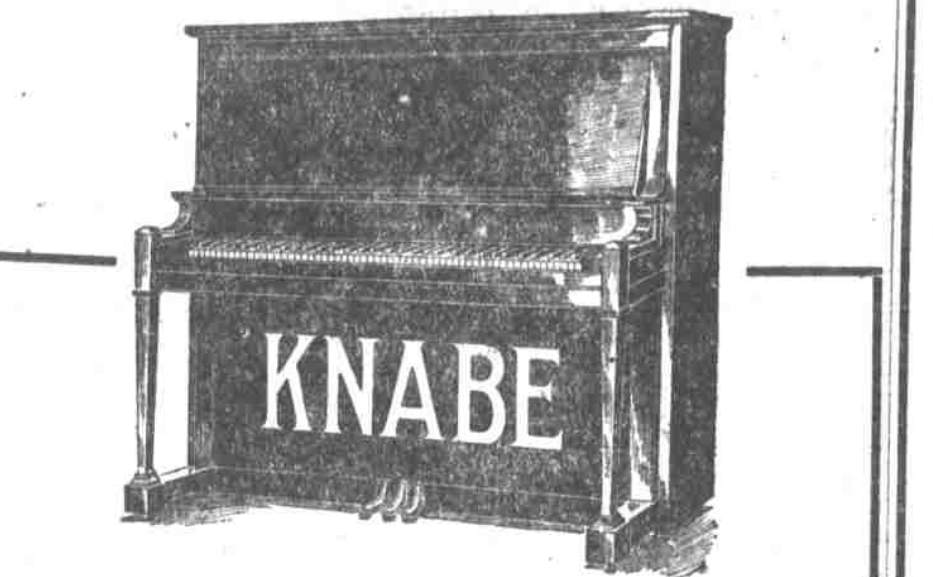
A number of years ago a statement was made by some one that the name 'Mission Rose' was applied because it originally came from the early Spanish missions in California. I have made a partial investigation of this phase of the question, but so far have not found any evidence to support that conclusion. Very truly yours,

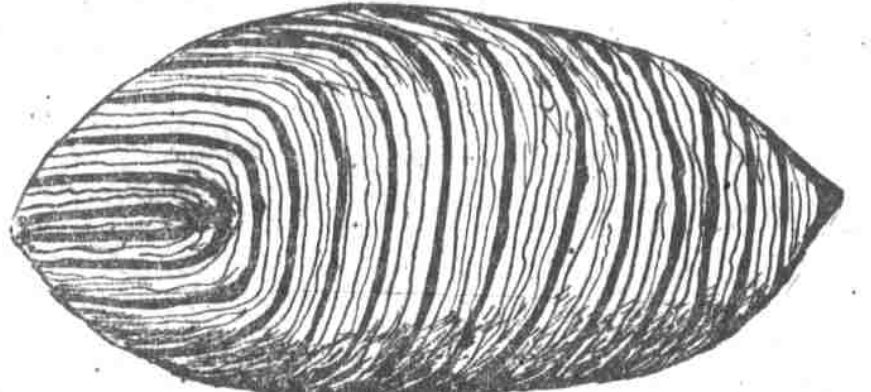

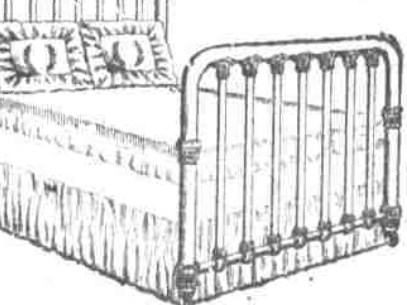
