

RACK PROSPECTS BOTHER WHITMAN

Lack of Experienced Men Worries Whitman Coaches—Baseball Men at Work.

Walla Walla, March 12.—With basketball over for this year, and track and diamond in idea shape by the opening of spring this week, spring athletics have opened up in good shape, and a host of candidates are on the field at Whitman college trying out for the various positions on the track and baseball teams.

In track Whitman has suffered an irreparable loss in Billy Martin, who has gone east, and will run this year with Notre Dame. Martin won the 100 yard dash in the games at the exposition last summer, and was counted one of the speediest men in the United States. Will Whitman, vault and jumper, has graduated, and the loss of these two men have crippled the college team seriously.

Captain Foster Is Star.
Foster, captain of this year's team, will probably win the vault over all comers in the northwest this year. Cox will run close up in the quarter and half, but further than these two, the team is entirely problematical.

Dresser, a local high school graduate, is speedy in the hurdles, and with Fee as running mate the two should get their share of the points in the grass-hopper events. In the weights, Neddi of Vancouver is the hope of the team, and is big enough to deliver the goods. McCoy of Walla Walla, Blomquist of Weller, Idaho, Lewis of Spokane and Morrow of Walla Walla will add in the heavy events.

In the sprints Wilson of Pocatello, Barnes of Spokane and Blomquist will try out. In the middle distances Cox, Simpson of this city and Woods will try. In the mile and two mile Woods of this city, Washburn, Yates, Engdahl and Campbell will be among the squad.

No coach has yet been secured, and although there has been much talk and several propositions, no definite action has been taken. With the team composed practically of green men, and with two new events on the program, Whitman will have to depend a great deal on coaching to put out a good team.

In baseball Captain Shubert at first, Belt at short, Borleske at third and Perlinger in the field, with Dunbar, a last year's sub, compose the leftovers. Among the new men to try out are Johnson, Stult, Hill, Ralstad, Gibson and Greenwell.

ROYAL ROMANCE THRILLS AUSTRIA

Betrothal of Archduchess Ella to Archduke Charles Francis Joseph Expected.

Vienna, March 12.—Vienna is taking a keen interest in a royal romance which may result in a grandchild of the aged emperor Francis Joseph coming in due time to the throne of Austria-Hungary. The principals in this romance are the Archduke Charles Francis Joseph, heir presumptive to the throne and the young Archduchess Elizabeth Frances, known familiarly in the imperial family as Ella. Her mother was the Archduchess Maria Valeria, the youngest and favorite daughter of the emperor. The Archduchess Ella is thought to resemble closely the late Empress Elizabeth, after whom she is named.

Contrary to the original arrangements at the recent court ball the archduchess partner with the Archduke Charles Francis Joseph. The news of this spread rapidly, and it is thought to portend that the Austrian people's dearest wish may be fulfilled. The archduchess is 18 and the archduke 23.

They are said to be devotedly in love with each other, and the emperor is said to strongly favor the match.

Vienna's Marriage Record.

A thousand weddings in one city in one day should come near breaking the record, yet the reports show that there was slightly in excess of this number in Vienna on the Sunday before Lent. The reason for this is that marriages are prohibited during Lent in the Austrian capital, and this great number of young couples decided they simply could not wait the 40 days for the consummation of their happiness. In one of the poorer quarters 20 couples were married simultaneously.

LAWYER BRINGS AN INSULT UPON HIMSELF

New York, March 12.—"Why don't you look at me?" shouted Charles E. Le Harber, of counsel for the defense in the trial of "Poppe the Wolf" and seven others in the United States circuit court before Judge Ray for counterfeiting.

He addressed the question to Antonio Comito, the Calabrian printer, who has turned state's evidence against the alleged counterfeiters. "I don't look at you," calmly replied the witness, "because every time I see your face you remind me of the Sicilian thugs who held me prisoner on that farm near Highlands where they were making me do the work."

Judge Ray cut the witness short from further remarks of this kind.

After Assistant District Attorney Abell Smith, who has charge of the prosecution for the government, had had several mixups with Mr. Le Harber, he exclaimed:

"Oh, let him rave!"

"I do not know that I am a maniac," good naturedly replied Le Harber, "though I may become one quickly."

Judge Ray admonishing the prosecuting officer not to use such language, added, nodding his head at Le Harber:

"No, you are not a maniac. Now that you are far from being a maniac. Now that you have a judicial pronouncement to that effect, let us proceed in good order with the trial."

MUSTER GRANT AS CIVIL WAR SOLDIER

Chicago, March 12.—Major General Henry Grant, commander of the department at the lakes, will be mustered into the United States army as a Civil War soldier April 25, the anniversary of the battle of Grand Gulf, in 1863, and will be mustered out July 4, years after the surrender of Vicksburg.

Although he saw long service in the war in eight battles and was twice injured on the firing line, the son of General U. S. Grant was not a United States soldier. He was a boy 12 years old, accompanying his father from the camp at Young's Point, La., in March, 1863, to the evacuation of Vicksburg, in July of the same year.

"I want to become a member of the Grand Army for purely sentimental reasons," said General Grant, "but it is necessary to be mustered out of the army before I can be accepted. It will require a special act of congress to do this, but my position as an active member of the army will not be impaired."

KING EDWARD TO MAKE NO STATE VISITS THIS YEAR

Britain's Monarch Leaves for Spring Vacation on Continent Where His Occasional Meetings Will Be Informal.

London, March 12.—The king starts on his spring vacation today. Contrary to what was understood some time ago, King Edward has decided to pay no state visits to any foreign courts this year. With the exception of Portugal, he has a very cordial invitation to King Edward to pay a state visit to Lisbon this spring, and his majesty promised to give this his consideration. He has visited these shores last November he now decided, however, that, acting upon the advice of his physicians, he had better postpone this visit for another 12 months, and content himself this spring with a quiet rest at Biarritz.

Intimation to this effect has consequently been conveyed to the courts at Lisbon and Madrid, both of which looked for a visit from his majesty. As he passes through Paris on his way to the south, his majesty will have a meeting with the president, who will dine in the king's company at the British embassy, but this will be a purely private meeting, as well as the one that is to take place between his majesty and the king of Italy at one of the Italian ports while the king is cruising with the queen and Princess Victoria in his royal yacht. Later in the year, when the king goes to Madeira, he may halt at Berlin to have a meeting with the kaiser, but this will likewise be of a purely private nature.

It is understood that the king is very anxious to create Prince Arthur of Connaught a peer in his own right, and this step is likely to be taken very shortly. The offer of a peerage to the young prince was formerly made by the king—following the usual precedent—when he came of age a few years ago. It was then, however, declined by the duke of Connaught on behalf of his son, who, he desired, should remain merely the heir to his own dukedom. It has been found, however, at state functions that the prince's present rank is rather unsatisfactory, so he is now to be given a dukedom of his own. What his title shall be has not yet been determined, but there are reasons for believing that the king favors the revival of the time honored royal title of the duke of Kent, and this is what will probably be done. This last duke of Kent was the grandfather of his present majesty and the duke of Connaught, and it was the first title suggested for the present Prince of Wales. It was, however, then overruled by the late Queen Victoria, and the duke of York was selected by her in its place. So keen as this title is viewed upon the young prince, which will probably be upon the occasion of the official celebration of the king's birthday next June, he will take his seat in the house of lords.

Lord Lansdowne, the Unionist leader in the house of lords, has a real friend in his charming wife, who is a most gifted woman. She is a keen politician and such an excellent diplomatist that Bismarck, the Iron Chancellor, once said of her that she was too clever for most of his ambassadors. When Lord Lansdowne was viceroy of India, Lady Lansdowne managed to acquire a wonderful knowledge of native life and affairs.

Her information was not merely gained second-hand, for, disguised as a native, she used to visit the poorest quarters of Calcutta. She often ran considerable risks, but she has plenty of courage, and the information she gained was sometimes valuable.

For instance, she was once able to save an innocent man from being hanged for murder. The judge who was trying the case was dining at the viceregal lodge. During the evening Lady Lansdowne took him aside and said: "The man who is charged with this murder is innocent. If you will send me a detective, I will show the house where the murderer lives."

Thanks to Lady Lansdowne, the real culprit was caught and the innocent man set free, but she would not reveal how she gained her knowledge of the actual facts of the case. The incident made her very popular with the natives of Calcutta.

The Fortune of War, at Pye-corner, West of Smithfield, E. C., an old city inn having associations with the great fire of London, and famous for the remarkable figure of a gilded fat boy on the side of the building facing Giltspur street, has finally closed its doors, and will shortly pass into the hands of the housebreaker.

An inscription let into the wall of the tavern facing Cock lane proclaims that "This is Pye-corner, where the Great Fire of London ended after burning night and day from the 2d to the 10th of September, 1666."

The story surrounding the origin of the fat boy is told by W. J. Roberts in "Some Old London Memories."

"Facing east," he writes, "is a gilded figure of a very fat boy, naked save for the conventional vine leaf. It was on this spot, then known as Pye-corner, that the great fire ceased in one direction."

"Superstitious folk seized on the curious coincidence that the fire originated at Pudding-lane and terminated at Pye-corner as being a divine warning against the sin of gluttony. They, therefore, erected this overgrown youngster, painted him in colors and inscribed beneath, 'The boy is in memory put up by the late city of London, occasioned by the sin of gluttony, 1666.'"

The building is to be demolished in connection with the improvement which the city corporation proposes to carry out at West Smithfield.

The fat boy, together with some old mural paintings in the bar and other relics, will, it is hoped, find a resting place in the Guildhall museum.

FINDS HUSBAND AFTER FORTY-SEVEN YEARS

Wabash, Ind., March 12.—In a wood-chopper, at work near her home, Mrs. Albert Holly recognized her husband whom she had not seen since he married away to the "Civil War," 47 years ago. She believed he was killed in battle, and sold her home and moved away. He could not find her when he returned from the south, and became a wandering carpenter.

Mrs. Holly married James Stull, a few years after the war. For forty years they lived happily together. Stull was a motorman here. Ten months ago he was thrown from his car and killed. Holly and his wife will now remarry.

AL PARS PLANS FOR GREAT VISIT

Coming of Colonel Roosevelt to Be Marked by Unprecedented Hospitality.

Paris, March 12.—Theodore Roosevelt, former president of the United States, litterateur, soldier, big game hunter and faunal naturalist, will reach Paris April 14 according to the present program, and while he will only be here a few days, he will be a pretty busy man during his stay. At the express wish of the distinguished visitor his reception here will be diverted of anything in the spectacular line, but Paris and France do not propose to be balked in their desire to greet him in what high esteem he is held here.

President Fallieres will entertain Mr. Roosevelt at a state dinner at the Elysee palace. Mr. Bacon, the United States ambassador, will give a banquet in his honor and the University of Paris will entertain him after his address at the Sorbonne, with a reception, at which all the noted men of letters and science in the capital will be present. It is not known if Mr. Roosevelt will appear in the uniform of the Academy of Political and Moral Sciences, to which he recently was elected. Probably not. Other plans for the entertainment of the noted guest have also been arranged.

Lynch Law in Paris.
Paris can now sympathize with those people in America who find it necessary to call in the aid of Judge Lynch in the administration of justice. During the recent floods it was found necessary to administer justice without the formality of trial to the Apaches who engaged in pillaging, and this summary justice was administered in true back-wood's style.

The crowd lynched four ruffians at Issy, hanging them from signposts, and a patrol fired volleys at fugitive scoundrels at Boulogne-sur-Seine, and killed two. Another pillager had the misfortune to be caught by a civilian boat patrol at Ivry. To punish him for showing fight, his captors threw him into the water with a noose under his armpits and dragged him behind the boat to the police station. He was unconscious when he ended the trip, which lasted three quarters of an hour.

BULGARIAN KING'S VISIT SIGNIFICANT

Russia May Be Invited to Act With Balkans When the Necessity Arises.

St. Petersburg, March 12.—The coming visit of King Ferdinand of Bulgaria to the czar is regarded as a particularly significant in view of the situation in the Balkans. This time he comes for the first time as an independent monarch, and will be received with due honors. A short time ago, when the Grand Duke Michael died, he informed the czar of his desire to attend the funeral services, and received a cordial invitation. That visit, if it had taken place, would not have been a state visit, as this will be. Last year King Ferdinand came about the same time, and was received, much to his delight and surprise, with military honors, and when soldiers cried out "We wish you health, your majesty," King Ferdinand's face beamed and he exclaimed "C'est délicieux." This year he is a full fledged king and no restriction will be placed on the royal honors due to him.

There is no doubt felt here that a thorough understanding has been reached between Bulgaria, Servia, Roumania, Montenegro, Greece and the czar when the Bulgarian monarch and the czar meet, Russia will be fully informed as to the situation and will be invited to act with the Balkan states when the necessity arises.

A telegram published in the Novoe Vremia confirms the fact that the secret Graco-Bulgarian committee has decided to undertake terrorist action. In Constantinople it is noted that the situation in Macedonia is becoming daily more and more serious. In spite of the orders of the central government, the local administration continues to treat the inhabitants in such a fashion that they only desire to be led by the Graco-Bulgarian committee. The aim of the latter organization is to revive the insurrection in Macedonia.

Among the representatives present at the recent conference of the Slav union, held in St. Petersburg, was M. George Kalinkoff, who represented Bulgaria. He declared that Bulgarians and Servians will never cease to agitate until they obtain the political emancipation of Macedonia.

Czarina Grows Worse.
The condition of the czarina I am informed is steadily growing worse, and hope of her majesty's complete recovery is being abandoned. The only possibility is that the rapid progress of her neurasthenia may be checked. There are hours, and even days, when the empress's mental state must be considered abnormal. She is haunted by an inexplicable fear bordering on the

condition known as the mania of persecution. Every noise makes her tremble. Windows and doors have to be bolted and she needs nobody. The czar is very depressed at the state of his wife's health.

From Dresden it is reported that the czar will shortly arrive there to stay at the famous Lahmann sanatorium at Weller Hirsch for the cure. It is stated that a Dresden medical professor and specialist in nervous diseases who has recently been to Russia, was summoned by the czar to confer about this sanatorium, which has been frequently visited by the czar's sister, Princess Heinrich, whose eldest son is delicate. This report, however, cannot be verified here.

To Sing Gorky's Songs.
It is announced from Kieff that M. Brilkin, impresario of the opera there is organizing a company of singers who will visit various American and European countries, and sing the songs, chants and marches of the Russian condition. The words and music have been collected by M. Hartevel, a foreigner, who last year was allowed to visit many of the convict establishments in Siberia. One of the most dramatic features of the songs is that several of them have an accompaniment of fetters. The Kieff branch of the Union of the Russian People are indignant over M. Brilkin's project, declaring it to be unpatriotic. They have decided to petition the local authorities to prohibit the proposed tour.

The largest wooden vessel ever built in the United States, a six-masted schooner of 370 gross tons and 80 feet long over all, recently was launched at a Maine shipyard.

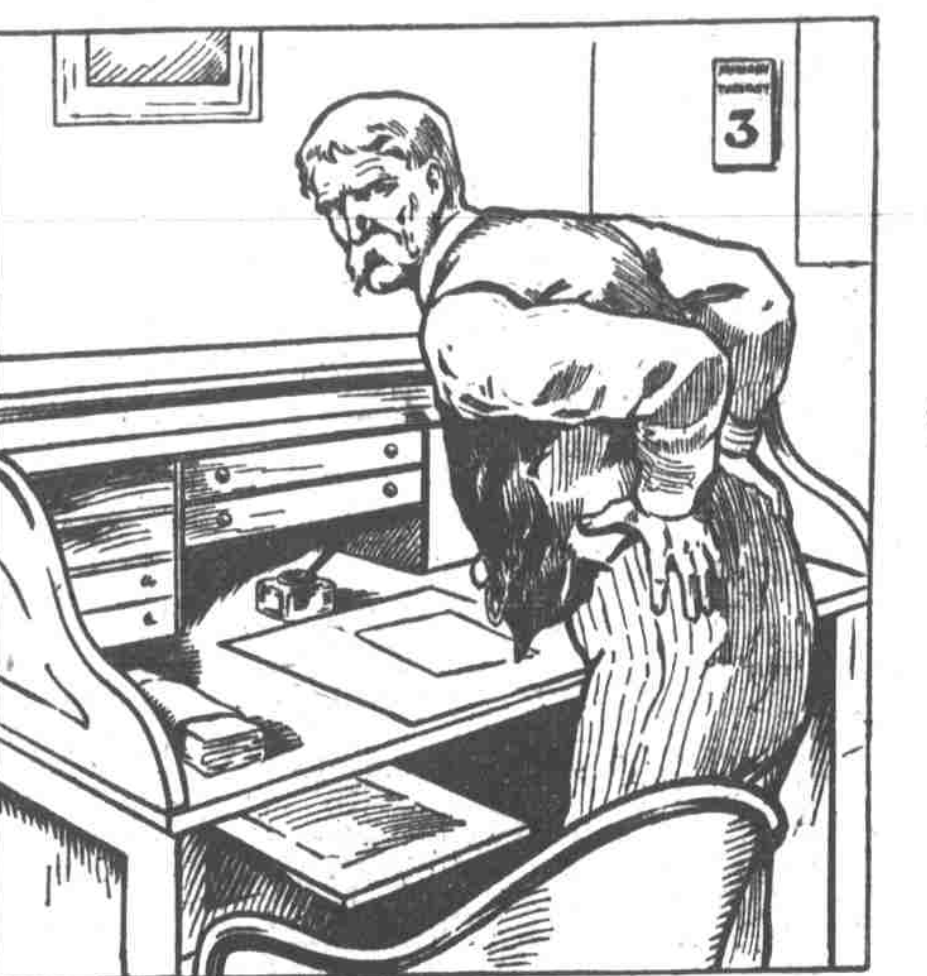
