MORE PROTECTION BY PATROLMEN IS NOW GUARANTEED

Attack Upon Woman on 12th Street Bridge Causes Rout of Hoboes From Camps in Sullivan's Gulch.

More police protection is to be given to the Twelfth street bridge and Sullivan gulch, and all hobo camps in that vicinity are to be routed out this afternoon. This is today's action of Chief of Police Cox and comes close upon the attack last Thursday evening upon Miss E. Pearl Luckey, a teacher, by some member of the undesirable colony that has congregated in the gulch to live without working.

This point is near the O. R. & N. tracks, and tramps upon dropping off the trains can easily find shelter in the gulch. The police have made several raids on these camps during the past winter, but of late a new crowd of men has settled there, to find lodging on the ground and to steal from the nearby residents.

EXPERT TIMBERMAN ANSWERS LAST CALL

J. H. Stutz, well known as a timberman, died at St. Vincent's hospital Friday night at the age of 49 years. He was very prominent in timber circles of the Pacific northwest and among milling interests was considered one of the most expert in his line in the country. He was born in Illinois 46 years ago and came to Oregon in 1890, settling at Toledo, in Lincoln county, where he became prominent in Democratic politics. In 1896 he was elected county assessor and in 1898 clerk of Lincoln county. He served four years as county clerk and in 1904 was again elected assessor. He resigned his office as assessor in 1908 and came to Portland, where he resided until his death. He had been ill about two months.

REGRET DEATH OF BISHOP SPELLMYER

Methodist Ministers Pass Resolutions Expressing Sorrow; Life Was Useful.

Bishop Henry Spellmyer, who was found dead in bed Saturday morning in Trenton, N. J., was the subject of eulogy this morning at the Methodist ministers' meeting.

A number who knew the bishop personally spoke of his useful life, his strength and simplicity, and his faithfulness to work. Dr. Clarence True Wilson was in the same conference with him for several years in New Jersey and spoke of his love for his work.

Dr. Young, who had accompanied him to a convention in the northwest, at one time spoke of his lovable personality. Dr. H. C. Jennings, of Clatsop, senior agent of the Methodist Book Concern, told of his knowledge of the bishop, who for four years had an office in Cincinnati, over the book company's offices. He said the bishop never shirked any of his work and gave the impression of a chronic condition of being out of breath with work. His expressed wish was that he might die in the harness suddenly and escape long, inactive illness.

Dr. Jennings spoke of Bishop Spellmyer as "a man of sorrows," for he lost all but one of his children within a week with scarlet fever. The one survivor married and lost her baby, and straightway went insane. Through many years the bishop had kept her in an asylum, an imbecile who doesn't know her parents. A resolution of sympathy and expression of loss was drafted by the association on Bishop Spellmyer's death.

W. A. Everett, secretary of the Laymen's Missionary Movement, presented the appeal of ministers throughout the state who are anxious to attend the movement here, but are unable to stand the traveling and living expenses. The ministers are being asked to provide entertainment for the poorer brethren of their denomination. A request is also made that all the ministers devote a certain service, preferably next Sunday, to the presentation of the Laymen's Missionary Movement, and material for information is supplied. The paper of the day was on the subject, "The Holy Spirit as a Preserver of the Christian Faith."

LOVE AND THRILLS IN MELODRAMA

New Play at Baker Theatre Also Affords Opportunity for Laughter.

By A. L. Melodrama seems to be the order of the day at the Baker just now, and "The House of a Thousand Candles," which follows "As the Sun Went Down," is no exception, although of a different variety from the latter play.

The play is a dramatization of the well known book of the same name, and retains much of the thrilling interest of the story which deals with the queer whim of old John Glenarm in pretending to be dead and leaving his estate to his nephew under the terms of a most extraordinary will. A treasure is hid in the house and there is a villain who knows it and makes things interesting.

Bates, the inscrutable butler of gentle birth and breeding, who knows Glenarm's secret and is sworn to keep it; the nephew and his Irish friend; the villain and his assistant, to say nothing of the contingent of henchmen, become deeper and deeper involved in the mystery until, at a crucial point of an intense scene, the old man comes out of hiding and they all live happily ever after—except the villains, who receive their just deserts.

The scenery is worthy of mention and the company as a whole has been well chosen. Bates, the most interesting part in the piece, was played by Hugo Koch, under whose direction the play was staged. Mr. Koch possesses a beautiful voice and is an unusually striking type of masculine good looks. His performance is notably smooth, but when it is all over it leaves the impression that one could carry away if he had been listening to a monotonous which does not mean to imply that Mr. Koch was not sufficient for the demands of the part and was not very popular with his audiences.

W. P. Richmond, as the nephew, was handicapped by a light voice and a choppy method of reading his lines. Arthur Scribner was a comfortable and satisfactory villain, and Philip Lord was his assistant, of the cringing sort. Gus Arthur furnished many laughs with his happy Irish diction. The brief glimpses of J. F. Comerford, as John Glenarm, were more than pleasing.

It would be unfair to say which was the most charming of the two women in the cast. Louise Glaum was a delightful type of frivolous school girl, with pretty dresses and good looks to spare, and Lillian Dyer was thoroughly satisfying in the slightly heavier part of the girl who helps complicate the plot.

"The House of a Thousand Candles," with its tale of love, thrills and laughs, will be at the Baker all week, with the usual matinees on Wednesday and Saturday.

READY TO LAUNCH CAMPAIGN FOR BETTER HIGHWAYS

Ex-Judge Webster Says Work Cannot Be Successful Without Cooperation of People—Meeting at Hood River.

A meeting tomorrow at Hood River will launch the statewide campaign for better built highways which Judge Lionel R. Webster will conduct in behalf of the Oregon Good Roads association. The Hood River meeting is to be held under the auspices of the commercial club there. It will be followed by another meeting at Woodburn, March 19. Judge Webster will deliver addresses at these and other meetings of the same kind which are to be held in all Oregon counties.

Judge Webster advocated the institution of a state highway commission in an address before the Woodburn meeting Saturday night. Arguments in favor of the commission and setting forth its utility will be features of the campaign for good roads.

Competent Commission Needed. Judge Webster believes that only by the appointment of a competent commission can the roads of Oregon be brought to a due standard of service. He is opposed, however, to the idea that a highway commissioner should necessarily be an engineer.

"I think," said Judge Webster, "that the man for the place is one of broad mind and great zeal in the cause. He should have the direction of the work, leaving engineering details to those trained for the work. I intend that a technician is not the great necessity."

We must first of all arouse public sentiment and create a public opinion by educating the people to their practical value. We obtain cooperation between land owners and county governments; between county governments and the state government. If the people are not brought into the cause it can never be a success. There must be common understanding that good roads constitute a more vital factor in development than any other one thing.

Good Roads Necessary. "Oregon will never be developed without the construction of good roads. Development will be tremendously accelerated by the building of good roads and by provision for their maintenance. As to this latter it should be arranged that the cost of construction and maintenance be divided equally among land owners, county governments and the state. We need new legislation to reach such an arrangement. It is the logical and practical outcome of present plans."

Judge Webster will be active during his tour of the state in organizing branches of the Oregon Good Roads association in every county. The membership of these branch associations will be made up from citizens who use the highways, the membership of commercial clubs, fruit growers' associations, the granges, and all other organizations that are concerned in the advancement of plans for Oregon's development.

"Dutch Market" at Oakland.

(Special Dispatch to The Journal) Oakland, Or., March 14.—The women's auxiliary to the Commercial club will give an entertainment, consisting of a "Dutch market," at the Orchestra hall, on St. Patrick's day, March 17. The funds will be devoted to beautifying the town and station grounds as soon as the new station is completed.

Police Charge That Attempt Is Being Made to Evade the Closing Order.

What the police consider an attempt of dance hall promoters to evade the recent order from the district attorney's office to stop all public dances on Sunday, has been taken up by Chief of Police and Deputy District Attorney Hennessy and warrants issued for managers of a dance given Sunday in Arion hall, Second and Oak streets. The hall is directly across the street from the police station was patronized yesterday by practically the same crowd that attended the notorious Maple dance hall at Sixteenth and Washington streets. The Workman's Circle, No. 263, was the organization under which the dance was given Sunday, and J. Nard was advertised as chairman of the dance committee. D. W. Robinson was floor manager. Patrolmen Montgomery and Long visited the dance last evening, and procured tickets announcing the price of admission to be 25 cents. It was also learned the dance was open to all.

Previously to the dance, a committee from the organization took the matter up with the chief of police, and informed that official that the affair was strictly for the society and not for the public.

A recent order was given the chief of police, sheriff and constable to close all public dances on Sunday. This order was the result of numerous complaints to the district attorney about girls who had started immoral lives, which was directly caused by the Sunday dances.

Justice, it was easily ascertained there that the department does not look upon the introduction of the "foundation" bill at this time as a mere coincidence. The dissolution suit involves the entire Rockefeller concern, and its scope covers the history of the oil business in this country from its inception up to the present day.

The record of the case forms a good sized library and contains an enormous amount of data, records and statements in relation to the history, growth and development of the Rockefeller concern. The manner by which the enormous profits of the concern were made, the systematic method by which the business was enlarged, how it dealt with competitors, and the whole history of the oil trust, so far as obtainable by the government experts, is told.

While the senate and the house will be considering a proposal for the distribution of the Rockefeller millions, the supreme court will be deliberating upon the manner in which the fortune was amassed.

In this manner the judicial and legislative branches of the government will be devoting their time to the origin and the proposed disposal of the oil profits while sooner or later the disposal feature, if passed, will demand the attention of the chief executive.

YOUNG THEODORE TO SAN FRANCISCO

Home There After Marriage—Will Remain in Employ of Carpet Company.

(United Press Leased Wire.) New York, March 14.—Theodore Roosevelt, Jr., will become a resident of San Francisco after his marriage with Miss Eleanor Butler Alexander, which will take place probably next June.

George Perkins, treasurer of the Hartford Carpet Corporation, in whose work young Roosevelt has been employed, announced today that Roosevelt would be given a responsible position with the San Francisco branch of the concern. When asked if Roosevelt would be manager, Perkins said: "No, at least not at the outset." "Will he get a big increase of salary?" was asked. "That concerns only the young man and the company," was the reply, "but you know raises of salary frequently come with marriage."

MAIL DELIVERY FOR NORTH IRVINGTON

Postmaster John C. Young received word today from the postmaster general at Washington, D. C., authorizing the extension of the city delivery limits between Knott and Stanton streets and East Twentieth and East Twenty-fourth streets, a district in the north end of Irvington.

The order, however, provides the mail shall be delivered to residents of the district only after proper receptacles have been provided, either letter boxes or letter slots in the doors. The order says the extension shall be contingent upon the provision of receptacles by residents.

Orders for the beginning of the delivery service in the district which the extension includes, have been issued. Within a few days, or as soon as residents provide receptacles, the service will be commenced.
