NEW COMPANY TO PUT UP SAWMILL ALONG COLUMBIA

A. W. Clark and J. B. Robinson Incorporators; Site 75 Miles From Portland, Embracing Seven Hundred Acres.

A. W. Clark, of the O. K. Logging company, and J. B. Robinson, builder and former manager of the Butte County railroad in California and at one time civil engineer for the Southern Pacific, will form the core of a company soon to be organized here for the purpose of building and operating a large sawmill and lumber manufacturing plant on the Lower Columbia river.

A site has been bought on the Oregon side of the river about 75 miles below Portland and it is so located that the mill will have exceptionally fine facilities for water and rail shipments, the land being touched on one side by the A. & C. railroad and the other side bordering on the river with sufficient depth at the shore line to float the largest vessels that come to these parts. The water frontage extends for a distance of 700 feet, giving ample space for two large trunks, steamers to be accommodated at one time.

The site contains 700 acres, which it is figured, will give plenty of room for the various plants intended to be erected thereon in addition to space for yards and sheds. The mill will cut approximately 150,000 feet of fir a day and a shingle mill with large capacity will trim into shingles cedar lumber not available for the manufacture of window sashes and other mill work.

Other accessories for the manufacturing of the mill cut in building material will be a planing mill, a sash and door factory and a furniture factory, the intention being to refine as much as possible of the total output of the mill. This will leave little but the surplus common lumber for shipment.

The company is in no way connected with the O. K. Logging company, although it will probably buy most of its logs from that concern because of Mr. Clark's interests in both, but it is understood that the intention is to eventually add timber to the new company's holdings so that it will be able to work uninterruptedly from the forest to the finished article.

Messrs. Clark and Robinson have not yet decided upon a name for the new company, but offices have been established and the work of organization is progressing rapidly. Permanent offices will be established in the Spaulding building immediately upon its completion. The several plants will furnish employment to several hundred men.

MEDICINE MAN TAKES HIS DOSE

It Is 12 Pellets and Administered by Relatives of Deceased Patients.

San Bernardino, Cal., May 10.—Old Blumark, aged 65, a Plutonian, and four young bucks are in jail following the killing of Harry York, the tribal medicine man, who had failed to save Blumark's four daughters from a fatal illness.

The young women were stricken with some disease unknown to the Indians and in spite of the medicine man's draughts and incantations they died. Three bucks also fell victims to the strange disease.

According to reports from the Plutonian village, near the Nevada state line, Blumark enlisted five of his friends, and on horseback pursued York, who fled into the desert. York offered no resistance when he was overtaken. His captors forced him to stand against a rock, and shot him. According to the story from the reservation, the medicine man's body stood upright after a dozen bullets had been shot into it.

The following night there was a general powwow and celebration in the village, after which the old man's body was buried.

Florida State Primary.

Jacksonville, Fla., May 10.—The Democratic state primary is being held throughout Florida today on nominations for state and county offices to be filled at the next election. A United States senator is to be chosen as successor to James P. Tallaferra, whose term expires next March. Senator Tallaferra is a candidate for reelection and his chief opponent is former Governor Napoleon B. Broward. A third candidate in the person of M. L. Eagle is also in the field for senator, making the campaign one of the most exciting in the history of the state. Congressmen are to be chosen from each of the seven districts. Today's primary is equivalent to an election, but if a second primary is necessary, it will be held on June 10.

Mrs. Reicher Dies at Forest Grove.

Forest Grove, Or., May 10.—Mrs. J. R. Reicher, aged 68 years, died at her home in this city Sunday evening. Mrs. Reicher was born in Erie county, Pa., April 24, 1841. She was married on March 4, 1868 in Brach county, Mich., to Stephen D. Reicher and to them were born six children, four of whom are living: Charles E. Reicher, Seattle; Frank of Tillamook; John of Florence, Or.; Mrs. Charles Stokes of this city. Mr. Reicher died in 1892 and 12 years ago Mrs. Reicher was married to J. R. Reicher at Tillamook. Funeral services were held Monday and the remains shipped to Tillamook for interment.

PRESBYTERIANS PROTEST FIGHT

Oakland Church Says Undesirables Will Come and Town Will Be Insulted.

Oakland, Cal., May 10.—Resolutions alleging that many bad characters of both the white and black races will be attracted by the Jeffries-Johnson fight on Independence day, and that their presence will be an insult to the citizens of Oakland, were adopted by the men of the First Presbyterian church here, and copies were today forwarded to Governor Gillett, Attorney General Webb and the district attorney and sheriff of Alameda county.

This action was taken independently of other organizations and churches, but the previous action of other protestants was "indorsed." The resolutions further point out that the place where the fight is to be held is within a short distance of the state university. The resolutions also allege that the people that will come from far and wide to attend the fight will be a menace to the welfare and safety of the good citizens of Oakland.

COAST AND NEW YORK FAIR BOOSTERS MEET

New York, May 10.—The California exposition delegation left today for Washington, to appear before President Taft and congress tomorrow, to make the formal request for a world's fair at San Francisco to celebrate the completion of the Panama canal.

The delegation attended a banquet held at the Hotel Astor, given by New York's leading men to launch the movement for a world's exposition in 1915 to commemorate the three hundredth anniversary of the founding by the Dutch of New Amsterdam.

Mayor Gaynor was one of the speakers.

Forest Grove Soon to Get Water.

Forest Grove, Or., May 10.—Work on the city water system is being pushed with dispatch by City Engineer Richardson, who states that the laying of the pipe line will be completed in about 12 days if good weather continues. The city will then be supplied with water direct from Clear creek, nine miles northwest of town.

ROOSEVELT GUEST OF GERMAN RULER

Escort Late to Train and William Is Chagrined; Informal Entertainment.

Berlin, May 10.—Theodore Roosevelt reached the railway station in Berlin today thirty minutes ahead of the Kaiser's gorgeous imperial guard. When the escort of honor reached the station, the Roosevelt party had already taken taxicabs for the American embassy.

The Kaiser was angry at Baron Von Schoen, minister of foreign affairs, because of the miscarriage of the reception plans. The result was that an enthusiastic but somewhat subdued crowd welcomed Colonel Roosevelt to the German capital. Roosevelt's special train arrived on time after it had been reported thirty minutes late. It was for this reason that the imperial guards were late at the station.

The virtual retirement of the Kaiser, in mourning for his uncle, King Edward of England, robbed the people of the promised interesting spectacle, the formal public meeting of "the Kaiser of America" and the "Roosevelt of Europe."

Under the changed plans of the visit here, Roosevelt and the emperor will meet only a few times and all the meetings will be informal. They met today for the first time. Roosevelt dined at the Potsdam palace. The Kaiser's reception was very cordial.

Roosevelt was allowed to see the Hohenzollern family albums, which are exhibited only on very rare occasions.

STRIKE AT SANTA CRUZ OVER REVIVAL BANNER

Santa Cruz, Cal., May 10.—In his determination to prevent the Methodist church from strutting a banner across the street to advertise a revival meeting, City Attorney Osburn has already caused the arrest of Councilmen W. R. Springer and Frank Stikeman, who voted to permit the church people to string the sign, and threatens the arrest of others.

A week ago Osburn warned the city council not to grant the church people's request, but the council did so. The banner was put up Saturday and Osburn personally tore it down. It was again

hoisted and Osburn decided to try another method, so he caused the arrest of the councilmen. In this way he expects to test the law prohibiting such signs in Santa Cruz.

ESPEE MUST PAY FOR LAND THAT IT BOUGHT

San Francisco, May 10.—By order of Superior Judge Murasky, the Southern Pacific company must carry out a repudiated contract for the purchase of lots on the North beach for the aggregate sum of \$722,925. Before the fire of 1906 the company brought condemnation suits for the purchase of this land for terminal purposes, but later arbitration was agreed upon. Three arbitrators fixed the value of the land at \$722,925, but the company, considering this exorbitant, refused to stand by its arbitration agreement, with the result that the property owners took the matter into court.

The company's line of defense was that the owners could not give them clear titles to the land, as they were destroyed in the fire. Judge Murasky pointed out that the agreement to arbitrate was entered into before the fire, hence the defense would not hold.
