

PORTLAND GOES ON RECORD AS OPPOSED TO PROFESSIONAL OBSTRUCTIONISTS

COURT DISMISSES CONTEMPT CHARGE AGAINST JOURNAL

Presiding Judge Morrow Decides That Paper's Comment on Broadway Bridge Suit Were Legitimate and Proper

NO ATTEMPT MADE TO INFLUENCE COURT

Charge Brought by Kiernan Falls Flat When Facts Are Presented.

Bond Suit Next Week.
Judge Morrow has promised me that he will have the Kiernan suit to invalidate the Broadway bridge bond issue set down for the coming week in the circuit court," said Mayor Simon this morning. "I am hopeful now," continued the mayor, "that the city will be able to reach an agreement with the Northern Pacific Terminal company concerning the reciprocal concessions asked by the municipality and the corporation. But whether the council committee is successful or not in the negotiations which it has been carrying on for the past month it will not be discharged by the city council next Wednesday. If no agreement has been entered into by that time we will have to resort to condemnation proceedings."

Presiding Judge Morrow last night decided The Journal was not in contempt of court for publishing editorial and news matter advocating the Broadway bridge and criticizing the obstructive suit of Frank Kiernan, brought by Kiernan with the admitted purpose of defeating the construction of the bridge, if possible. "I do not feel that anything The Journal has said is an attack upon me personally," said Judge Morrow, "and I have not felt that"

CITIZENS AT BIG MASS MEETING VOICE DISGUST AT DELAY OF BRIDGE

Condemnation of Kiernan, Kiernanism and the dilatory tactics that delay building of the Broadway bridge gave sensational import to a mass meeting of east side citizens held on Russell street last night. Disregarding the presence of two court reporters, sent to the session by Kiernan and Dunway, and the further fact that policemen and plain clothes men were stationed across the street to quell disturbance caused by the unwelcome presence of the stenographers, leading citizens spoke with words that flamed with passion against the spirit that they affirmed is obstructing the development of the city and opposing the welfare of the people.

The meeting abounded in dramatic periods. Delegates from improvement leagues announced that they had been sent "to raise Cain," and the frankness of their expressions attested their willingness to obey orders. **Journal Indorsed.** Resolutions approving and indorsing the fight of The Journal against the obstructors of the Broadway bridge and expressing sympathy with the newspaper because of the contempt proceedings in which it had become involved, were adopted with cheers and with a unanimity that was repeated when the session was closed with the passage of a resolution condemning the spirit shown by Kiernan and his attorney in sending to the meeting stenographers for the purpose of intimidating those present by making them feel that their words would be construed as in violation of the law.

CHAMP CLARK DENOUNCES USURPATION BY EXECUTIVE AND PREDICTS G. O. P. DEFEAT

Washington, May 21.—Declaring the proposed tariff commission is a plan to postpone the people's verdict on the Payne-Aldrich tariff measure, and denouncing the encroachment of the executive on the legislative branches of the government, Champ Clark today in the house sounded the Democratic keynote of the coming congressional campaign. "The proposed appropriation of a quarter of a million annually to support the tariff commission," he said, "should be titled a 'motion to postpone the people's verdict on the Payne-Aldrich tariff bill' to a session more convenient to the standpat leaders."

BONDS ORDINANCE MAY BE ADOPTED OVER SIMON'S VETO

Demand for Public Docks Is Growing So Strong That Steps Being Taken to Introduce Measure Again.

VIGOROUS FIGHT FOR DOCKS JUST STARTING

Great Mass Meeting of Citizens Declares Public Vote for Wharves Any Time.

Appearances indicate that Mayor Simon's veto of the public docks bonds ordinance, instead of defeating the effort to obtain municipal control of the water front, has only fairly commenced the fight. Arrangements are being made to bring the ordinance for passage over the mayor's veto at the council meeting next Wednesday. While it is questioned whether council will sustain the measure in the face of the chief executive's disfavor, it is yet desired that the regular procedure be followed before inaugurating an effort tending toward more definite results than have yet been obtained.

In addition to the vigorous disapproval expressed by commercial and shipping interests of the mayor's action in vetoing a measure voted for by the people and adopted by council, much resentment has been aroused among the masses of the voters. Their construction of the situation is that Mayor Simon has given the laugh to popular elections and has attempted to establish the instructions of the electorate need not be carried out by officials.

People Favor Docks. HALLEY'S COMET IS SEEN BY WATCHERS ON COUNCIL CREST

Many Catch Sight of Elusive Wanderer of Skies but Expect Better View Monday Night.

May 21.—Halley's comet sets today at 9:23 p. m.; tomorrow 10:06 p. m. Sun sets 7:20. Comet's speed today about 1613 miles per minute. Comet passes close to star Gamma Gemini, where it was October 1. Halley's comet, serenely unaffected by earthly wondering as to "what and where it is," showed up bright against the western sky last night. Its head was pointed toward the sunset and its tail toward the moon. Thus stationed the erratic wanderer of space was clearly perceived by Professor J. W. Daniels on Council Crest, and by Professor Edgar B. Van Odel in charge of the McMinnville college observatory. "We obtained one of the best views yet secured last night," said Professor Van Odel, who was in Portland this morning. "There was a little haze, yet not enough to obscure the comet. HALLEY'S COMET AT OLD STAND

Ann Arbor Astronomer Gets a Glimpse of It—Says It is on Schedule.

Ann Arbor, Mich., May 21.—The "got away" journey of Halley's comet will take place according to the astronomical schedule made public several days ago. Professor Huxsey of the University of Michigan announced today that the comet would be visible to the naked eye for several evenings on the western horizon. The professor sighted the comet last evening near the sun but the bright moonlight prevented him from seeing more than a faint outline of the tail. The head appeared the same as it did before it passed the sun.

HARRIMAN FORCES FIGHTING HILL IN TILLAMOOK FIELD

Having Lost to Enemy in Deschutes Canyon War, Now Plan Line to Coast Where Hill People Want U. R.

WILSON RIVER CANYON SCENE OF NEW BATTLE

Second Harriman Road Will Parallel Hill Line to Harass Latter.

Hardly has declaration of peace been announced and the smoke of battle blown away from the Deschutes river canyon before it has become evident that another and perhaps more bitter encounter is about to begin between the Harriman and Hill forces in Oregon. This time northwestern Oregon is to be the scene of conflict with Wilson river canyon as the field of battle. Having met defeat to a certain extent in the Deschutes river canyon, inasmuch as they failed to bar the Oregon Trunk from entering central Oregon, the Harriman generals are now preparing for another siege, this time in hope of retaining for their own field the rich domain of the Tillamook country. The announcement of the opening of hostilities does not come in the form of an open challenge, but stands out prominently in the statement authorized this morning by President E. E. Lytle that the Pacific Railroad & Navigation company is to build a second line into Tillamook to form an important strand in the network of roads that his company plans spreading over the counties of Columbia, Clatsop, Tillamook and Washington. ROOSEVELT CENTER OF BUZZING SWARM OF QUIZZING KINGS

Makes Hit of His Grand Tour at Post-Funeral Luncheon Given by King George—Royalties in Tilt With Him.

London, May 21.—The spectacle of the royalty of Europe, Asia and Africa, who had not yet been presented to Theodore Roosevelt, crowding about the American at the luncheon at Windsor castle, following Edward's funeral, is described by newspapers here as a "wonderful personal triumph for Colonel Roosevelt." The American was the dominating figure at the luncheon. He was the particular guest of King George and was assigned a place of honor with Emperor William of Germany. The luncheon was marked by keen passages of wit and Roosevelt came off first best. The monarchs of Europe plied him with questions for an hour concerning his views on politics both in America and Europe. The colonel countered with questions concerning the duties of kingship as understood by his host and his host's guests. The guests at the luncheon were so interested in Roosevelt that, for the first time, the sorrow over the passing of Edward was lost to sight. Roosevelt's personality swept aside all other thoughts.
