

KING EDWARD IS A PEACEMAKER EVEN AFTER HIS DEATH

Visit of Kaiser William to Late
Ruler's Funeral Does Much
to Soothe Feeling Between
Countries.

London, May 21.—King Edward was the peacemaker, even in death. The incidents of the splendid pageant which marked the progress of his body from Westminster to the grave, and the deep feeling and tact which has been shared by Kaiser Wilhelm during his visit here, has done more to soothe the feeling between Germany and England than could have been accomplished by the wisest statesmanship. There are those who declare that the Kaiser has acted grief-stricken and sympathetic for a purpose, and they point to the fact that there was always a feeling of veiled antagonism between the Kaiser and his uncle, the late king.

It Acting, It Was Perfect.
If his sympathy was acting for the purpose of winning the public, it was perfect, and it has accomplished its purpose.

With the Kaiser, former President Roosevelt has been the figure in the ceremonies attending the royal funeral which has been attracting the greatest interest.

Mr. Roosevelt has shown great tact and has shown no disposition to put himself forward, but wherever he has been the masses have been anxious to see him. Another interesting figure has been King Alfonso of Spain. The news of the premature death of his third son and the serious illness of Queen Victoria, has created sympathy for him.

Queen Mother Recovers.
Queen Mother Alexandra received all the visiting kings, princes and special envoys at Buckingham palace this morning and formally thanked them for their sympathy. Her majesty, while showing traces of her deep grief, was calm and collected during the audience and was very gracious in her expressions of thanks.

Immediately after the conclusion of the audience King Alfonso hurried off to Spain to be with his stricken queen.

The Roosevelt went to West Park, the house of Ambassador Field, where they will remain until Monday. The Kaiser will stay at Buckingham until Monday afternoon and Tuesday.

The other royals and envoys are leaving London. There has been some comment on the fact that at the ceremony at Westminster hall, Tuesday, Queen Alexandra was accompanied by her sister, the dowager empress of Russia, instead of by Queen Mary.

Alexandra properly took the first place as the chief lady mourner, but she should have been accompanied by Queen Mary, who is entitled to precedence over everybody except the king. But Alexandra, who has an imperious, willful way of her own, held out against the queen and king, finally getting her wish that Empress Marie sit beside her. The result was that Queen Mary played a second part in her first appearance of the new reign.

Political enmity has not been laid in the grave with Edward, the pacificator, and the hatchet has not been buried. Though the events of the last fortnight have drawn attention away from the tactics of the party leaders, there has been an abatement of public interest over the controversy raging.

Competent forecasters predict that soon partisan excitement will blaze forth even more furiously than before.

UNITE AGENCIES FOR GOOD ROADS

Rose Festival Association Is
Eager to Aid Campaign for
Better State Highways.

The plan to unify all possible agencies in the state-wide campaign for good roads will be expounded at a meeting which has been called to meet next Saturday evening in the Masonic Temple, Yamhill and West Park streets. Addresses will be made by Professor Eldredge, representing the national good roads movement, and Judge Lionel R. Webster, of the Oregon Good Roads association. Professor Eldredge's address will be illustrated by views which he has obtained in almost a lifetime's traveling over the nation as an advocate of better built highways. Judge Webster has announced that he will speak to Oregon's necessity for immediate and practical work in the matter of constructing and maintaining roads that will extend into every part of the state and thus give development of Oregon resources an impetus that it could not otherwise receive.

Address by Officials.
Addresses will also be made by officials from the state grants and the state federation of labor. J. H. Albert, president of the State Automobile association, living at Salem, has been invited to address the meeting.

It is planned to make the meeting representative of all classes of citizens, and as such the greatest demonstration in advocacy of good roads known in the history of the state.

Arrangements for this state good roads convention synchronously with the Rose Festival, June 6-11, are being made. Manager George Hutchins, of the Rose show, asserted yesterday that such an arrangement would please him extremely.

"The most important thing before all the people of Oregon is this matter of building good roads," said Mr. Hutchins.

Favors Good Roads.
"I cannot conceive of anything that will give greater impetus to the state's development than the early construction of roads. All great developers who have done big things for any country have preceded their work by the construction of roads that would bear the burden of heavy traffic and frequent use at any time.

"By all means let the Rose Festival and the good roads convention work together. We are all in the same business of making this state better known, richer, and a better place to live in."

Professor Eldredge and Judge Webster will return to Portland after a successful series of meetings along the line of the O. R. & N. some time this week.

SAN FRANCISCANS FIGHT BALLINGER

Delegation at Washington to
Resist the Holding Up of
Hetch Hetchy Rights

(Washington Bureau of The Journal.)
Washington, May 21.—A delegation of San Franciscans are here charging that Ballinger and Lawler acted in the interests of the Spring Valley Water company against the interests of the people of San Francisco in giving notice that permits in connection with the Hetch Hetchy water supply would be revoked. Ballinger served notice on the city of San Francisco to show cause why permits should not be revoked for part of the water needed for San Francisco's supply. The hearing was dated for May 18, but complaints to Taft caused postponement to May 25. Taft ordered an array of army engineers—Lieutenant Colonel Biddle of San Francisco, Major Crosby, district engineer, who succeeded Morrow, now at Portland, and Porter of New London, Conn., to appear in the case.

Mayor McCarthy of San Francisco heads the delegation. The San Francisco papers charge Ballinger with acting as the tool of the Spring Valley company, and that naturalists, such as John Muir, had the wool pulled over their eyes by the Spring Valley company and objected to the utilization of the Hetch Hetchy waters against the public interest. The Spring Valley company is a private company, which supplies San Francisco with water. Possession of Hetch Hetchy would enable San Francisco to free itself from the monopoly, which has long been burdensome.

FIRST STATE BANK OF YACOLT INCORPORATED

Vancover, Wash., May 21.—Articles of incorporation of the First State Bank of Yacolt were filed yesterday with the county auditor. The capital stock of the bank is placed at \$10,000 and is divided into 100 shares of \$100 each. The incorporators are O. Jorgen Olson, of Yacolt; C. O. Steberg of Buckley, Wash., and C. F. Hendrickson of Portland. The bank has recently installed a municipal water system and electric lighting plant.

HOQUIAM ELKS DEDICATE NEW HOME

Notification to Committeemen,
of Meeting to Be Held Prob-
ably at Salem.

Oregon City, Or., May 21.—Secretary W. A. Sheehan of the Willamette Open River and Freight Rate association, under authority of the association, has sent the following notification to each of the committeemen concerned:
"At the meeting of the Willamette Open River and Freight Rate association held at Eugene May 16, a resolution was passed authorizing President H. H. Hewitt to appoint a committee to devise plans for cooperation among shippers, who are situated so as to be able to employ water transportation, said committee to report at the next session of the association. You will herewith find appended a list of that committee so appointed, and I wish to urge upon you the necessity of your committee being present at the next session, which in all probability will be held at the city of Salem at an early date. Every member of this committee should make an extra effort to be present at the coming meeting, and be able to report some plan for the better cooperation of the shippers as indicated in the resolution.

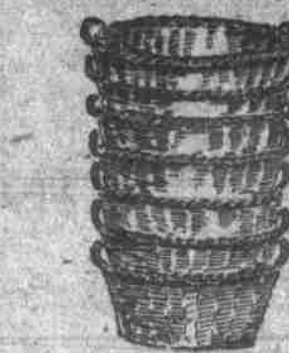

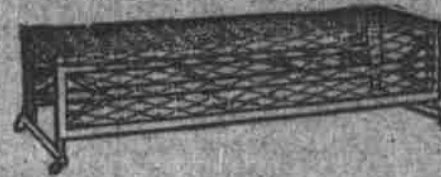

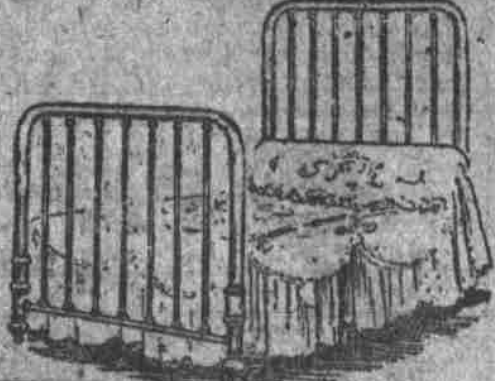
