

TURKISH PRINCE IS ACCUSED OF BEING A RANK IMPOSTOR

Self Proclaimed Nobleman of
Far Off Turkey Leaves San
Francisco After Leading a
Dashing Career.

(Special Dispatch to The Journal.)
San Francisco, June 1.—Coming to San Francisco to rest from the arduous duties of fighting Turks on his native beach of Albania, his royal highness, Prince Sheban Bey Gotscha, self-proclaimed patriot, soldier and liberator, has devoted his spare time to the wooing of Mrs. M. Buck, the city's most fashionable dressmaker, and though the latter makes a half-hearted denial, the common understanding is that the two are to marry in New York in July. The prince left San Francisco two weeks ago after a year's stay here. He sails for Europe in July, and so does Mrs. Buck.

Branded as Impostor.
But while the romance does encompass them round and about, a jarring note enters their love song in the shape of an emphatic denial of the claims of the alleged Albanian princelet from the Turkish consul, George Hall, who declared today that in his opinion his royal highness was a most royal impostor and that several complaints about him, and his peculiar attitude toward women, had been received. Mrs. Buck maintains that his royal highness is all that he claims to be and very much more. The Turkish consulate emphatically holds out that he is a royal humbug, is no more a prince than he is a "boy" and that he is no more a boy than he is a mountain torrent. While the story rages, H. R. H. Gotscha is in New York awaiting the coming of Mrs. Buck. As the case stands now it is too up whether the fashionable mantua maker is soon to be a princess or be fooled.

An Eccentric Party.
"The prince was an eccentric man," said Madame Buck. "He decorated his cottage with Egyptian and Turkish hangings and it was as comfortable and cozy as one could imagine."
"The prince truly was an eccentric character," laughed Consul Hall. "No sooner did he arrive than we heard a complaint of him absent-mindedly leaving Los Angeles with a bracelet belonging to some woman down there. I don't know how the matter was fixed up, but my understanding was that the woman did not care to press her charges on account of the notoriety which would follow."

"Turkish" prince, nothing. Why, there are no princes in Turkey. They are boys. This man is both. His title is ridiculous on the face of it. One might as well refer to Count Smith Baron as to Prince Sheban Bey."

Woman's Questions.
"He was the most gifted talker I ever met," said Mrs. Buck. "Of course he had his enemies; most great men have. He told me he had given up everything for his country's freedom. Here in San Francisco he secured his much needed rest. Often he said how quiet and peaceful it was here after the hard fighting he had been passing through. He is a patriot of the highest type—Oh, that Los Angeles affair! Well, that was just an affair, and nothing more. The woman seemed to become very interested in him and for what reason I cannot say, for he did not bother his head about them to any extent."

"For some time past my friends have had me engaged to marry him, but it is all women's talk. The prince left two weeks ago and before he left he told me that the political situation in his country made it necessary for him to go to New York. I expect a letter from him in a day or two. I am going to Europe in July and the probabilities are that the prince will sail in the same boat. Of course he will not leave the United States unless it is safe for him to return to Europe."

Mrs. Buck said the prince had a private income of his own and labored not except in the cause of his country. Many of her friends have systematically opposed the prince, declaring him a humbug and his sole aim that of marrying her for her money.

Thinks to Name Portland Postmaster by Fixing Insurgent Stigma Upon Senator.

Washington, June 1.—Although maintaining absolute silence, Senator Bourne, it is believed, has had a frank conversation with President Taft relative to the Portland postmastership. Although no intimations have been given, it has been a fair inference that Bourne's independent attitude on the

railroad bill and other measures has angered the regulars and caused them to desire to list Bourne among the progressives, which listing has not been resented by Bourne. Last night, during the thick of the fight over the railroad bill, when La Follette was leading the fray right up to the embattled Aldrich regulars ranks, Bourne was often sitting beside the Wisconsin member, counseling and aiding with his vote all moves by the progressives who were fighting to improve the bill. At other times it has been the same. It is therefore guessed that his independence has stored up for him some measure of opposition from the administration to the full extent to which Postmaster-General Hitchcock can control such things.

Tonight it looks as if it would be Bourne against Hitchcock. The latter it was who sent Ormsby McHarg to Oregon to defeat Chamberlain, which proves that the stronger will dictate Portland's postmaster.

CARNEGIE WOULD HAVE PEACE IF IT COSTS BLOODSHED

In Address at Guildhall, London, He Argues for League of Peace and Would Carry Reform by Force.

London, June 1.—Why is it that I never attend a peace meeting without becoming blasé? The cause of peace is one of the holiest in the world. I have devoted many years of my life to its advocacy in many lands. Yet I never listen to the speeches at conventional peace meetings without feeling stirred up into fierce revolt against peace societies and peace orators. The peace meeting at the Guildhall, one of the highest ever held in London, is a point in the case. The Bishop of Hereford was in the chair and your Andrew Carnegie was the chief speaker. The Guildhall was crowded. It is a famous hall built by citizens who thought the best way to show their love of peace was to adorn it with monuments to the honor of the Duke of Wellington and Lord Nelson. Over the door hung the flag of the city of London volunteers, who went out to Africa to fight the Boers.

Mr. Carnegie, who was in his usual gleeful mood, bade us all be of good cheer, for the day was coming when the killing of man by man would be regarded as barbarism incompatible with civilization. To settle disputes by slaughter was worthy only of wild beasts and savages, etc., etc., sentiments which were beautifully applauded by his sympathetic audience.

Would Fight for Peace.
But by a curious inconsistency, Mr. Carnegie devoted the only practical part of his speech to an argument in favor of the formation of a league of peace, the members of which were to prevent any nations going to war by force if necessary. He looked forward to the day when the 13 American republics would band themselves together to compel any two of their number to abstain from war.

I longed to stand up and ask Mr. Carnegie whether if independent sovereign states are to be compelled by force to keep peace, how the necessary force was to be applied except by the use of those methods of slaughter which he had just been denouncing as incompatible with civilization and worthy only of wild beasts and savages.

But I refrained, not wishing to convert a peace meeting into a bear garden.

SAY OREGON FIRE INSURANCE LAW IS BEING VIOLATED

Local Agents Angry Because
San Francisco Board Cuts
Commission From 20 to 15
Per Cent.

Fire insurance men of Portland are angry. They say that the state insurance law is being violated by the San Francisco board of fire underwriters; that the state insurance commissioner is allowing this board to violate the law, and that because of that they are about to be put out of business. The last straw came a few days ago in the shape of a resolution passed by the San Francisco board of fire underwriters declaring that all agents should receive a 15 per cent commission instead of 20 per cent on all policies written in the state of Oregon.

The state insurance code, enacted at the last session of the legislature, provides that the insurance companies in the state shall not maintain any board for fixing rates or regulating the business, or premiums of the companies. In other words, the law provides and intends that each company shall carry on its business independently, as in other business lines.

It is charged by the agents in Portland who are much excited over the latest development, that the San Francisco board is clearly without the pale of the law. In spite of this it has issued orders that no general agents shall live in Oregon. It has fixed the rates, has enforced these rates after the board has decided upon them, has set the date of collections and enforced compliance with that date. In short, it is charged that the San Francisco board runs the Oregon fire insurance situation just as much now as it did before the passage of the law by the legislature.

The agents are so aroused that they are discussing the feasibility of holding a mass meeting and asking that the state insurance commissioner take steps to cut off the power of the San Francisco board in regard to the conduct of Oregon business, as they contend that the action of the board is contrary to the law. They contend that to top five per cent off the commission, made by them on policies written in to draw the line between profit and loss, and that if the ruling is insisted upon they will suffer financially.
