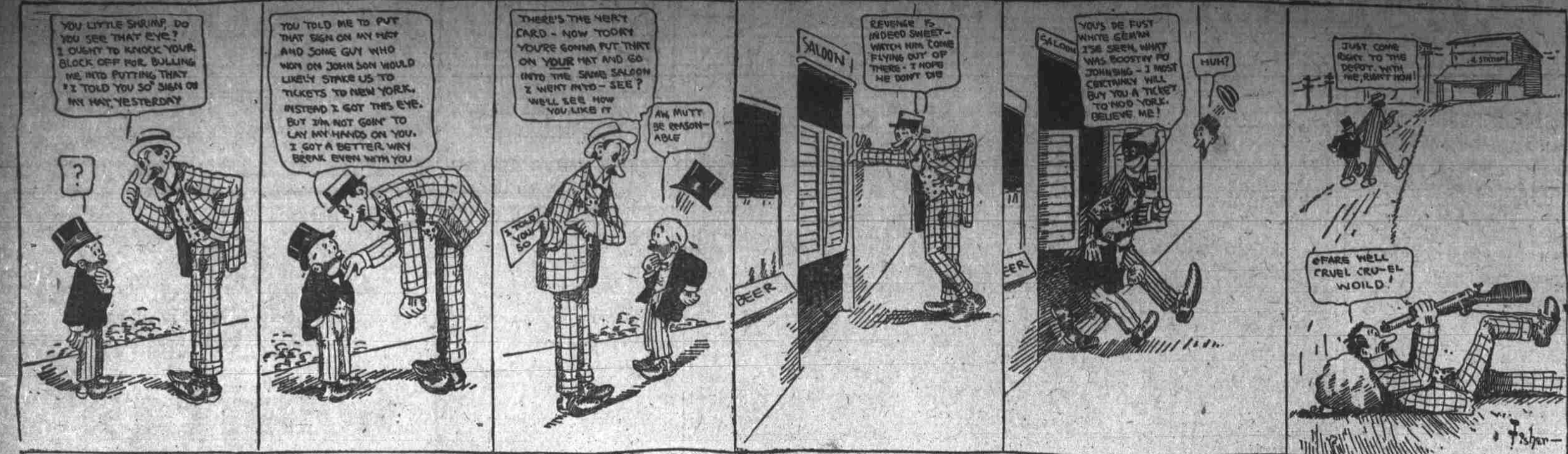

TEX RICKARD GOES AFTER JEFF AGAIN

Jack Gleason Gets Even Split on Gate Receipts at the Reno Fight.

San Francisco, July 13.—Tex Rickard, happy, smiling and jingling some of the coin he gathered out of the Jeffries-Johnson fight, has gone to Los Angeles, where he will have a talk with Jeffries over a return match with the negro Rickard is confident that big Jim will reenter the ring.

"Jeffries was not right on the fourth," said Tex, "and I feel sure that should he meet Johnson again his showing will be far better. Although I have no positive assurance from Jeffries that he will fight, something tells me that he wants another crack at his conqueror. In fact, I feel so sure of it that I have found a battle ground, and it is not at Reno, nor is it Juarez, Mexico. It is in the United States, and is so located that I will have many people to drive up, and I cannot name the place just yet, as it might spoil my plan."

Waits on Jeff's Say.

"If Jeffries says the word I will go ahead and complete my plans for a battle on Labor Day. That will not be too soon for Jeffries to fight again, as I believe a couple of weeks of rest and three or four weeks of training will put him in shape. His physical condition is good right now and with the great worry that overwhelmed him in his last fight off his mind he will be a different Jeffries."

"I don't think he has been treated fairly by some of the critics, especially those who have insinuated that he quit at Reno. If he wanted to quit he could have done so after the first knockout, when he knew deep down in his heart that the stuff was off."

"There was one thing about the fight that was particularly pleasing to me, and that was that Jeffries was not knocked flat on his back, as I had predicted he would not be. Weeks before the fight, while discussing the matter with a number of friends, I declared that if Jeffries were knocked out it would not be a complete knockout with the white man on his back unconscious."

Contrary to general belief, Jack Gleason got an even split on everything. Few believed that he had anything more than a picture interest, but Rickard, who ought to know, declares that Jack got one half of everything, including \$15,000 of the \$25,000 paid by a tobacco concern for the privilege of setting up three immense advertising canvases within the arena.

Although the anti-picture agitation will cut deeply into the profits of the moving picture people, Gleason will not be affected. His contract calls for the payment to him of \$33,000 out of the first \$66,000 taken in by the exhibitors, and when \$250,000 shall have been taken in he will receive one sixth of all profits thereafter.

If Rickard fails to land a return Jeffries-Johnson match it is hardly likely that he will stage a Langford-Burns fight at Reno on Labor Day, because he does not think it would draw.

WILLIS TOO GOOD AND LOCALS LOSE

Krapp Soars and Oakland Gets Only Runs in First Game of Series.

When the other pitcher has everything on the ball and stays on good old terra firma while your own slabsider takes a short but spectacular aerial flight, how can you expect to win? That's just what happened yesterday and that's why Portland failed to take the lead in the Coast League, for San Francisco lost again.

Krapp worked unsteadily all through the game and in only one inning were the Oaks retired in order. For his part he had an even dozen men left on bases. In the seventh inning he grew so wild that after Swander had doubled, four men were walked in succession, forcing in two runs, a veritable gift to the Commuters. Try as he would Gene could not get the ball over the plate. Some of them looked close enough, but Umpire Finney could not see it that way.

Single Most Every Inning.

In every inning but the eighth, the Oaks blinged off Krapp, a pair of them being two-baggers. By dint of good fielding, Portland kept the Oaks from scoring in the earlier frames. Once Ryan pulled off a great running catch that saved a couple runs, and again Fisher and Krapp outguessed Cuthaw and killed him dead as he was trying to steal home.

In the fourth round Ryan was robbed of an extra base hit by Maggart, while Carroll killed a three-bagger for Ort in the sixth.

Swander led off in the seventh with a two-bagger to left field, but Krapp promptly whiffed Wolverton and Maggart. He purposely walked Cameron, who ambled three times during the game, and then filled the bases by issuing a free pass to Carroll. With two strikes and three balls on Cuthaw, Krapp shot a straight one toward the plate. Cuthaw made no attempt to strike it. Umpire Finney ruled it was inside and this forced in the first run.

Krapp grew hot under the collar and tried to fan Swander but could not get it near the oblong and another was forced in. Fisher retired the side by gathering in Mitze's slider.

Casey got to first in the fifth on a walk. Fisher got there by a hit in the seventh and Helling also by a hit in the ninth. Score:

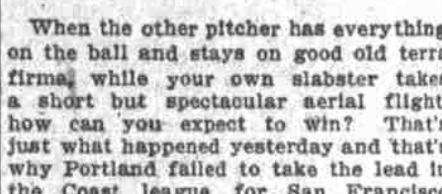
No Decision Routs Go.

BEGGARS RAIDED WHILE FEASTING

Paralytic Crooks Elbow for Champagne—Deaf, Dumb Man Converses.

Chicago, July 13.—Two unfortunate young men who eke out an uncertain living in the streets of Chicago by begging alms from the more prosperous received unexpected visitors in their lavishly furnished, poverty-stricken quarters at 163 West Huron street.

Charles Trent, the deaf and dumb man, was talking to Fritz Miller, the cripple, who was exercising his paralyzed arm with a champagne bottle. It was just before business hours, and as Trent conversed with his companion he was earnestly attaching himself to a sign which read as follows:

Friends.

I am deaf and dumb through sickness and am trying to make an honest living by making needle cases. These articles are always useful and they only cost 10 cents. The same will help you if that is needy this day. Don't pass on.

Other Was Pitiful Sign.

Miller, the cripple, who likes champagne, also was preparing to don a sign as well as a plaster of paris cast in which he incases the arm that is useless during business hours. Miller's sign announced:

Today a poor cripple appeals for your aid. Don't pass with a hurry or a frown, for God in his wisdom is the only one who knows when loved ones of yours may go down. Your aid will be appreciated. Please give what you can.

As Trent, the deaf and dumb man, conversed with Miller, the cripple, Detectives Curran and Tobin entered the room. Climbing over a miscellaneous collection of peg legs, crutches and plaster casts, the detectives informed the two beggars that they were under arrest.

Trent, the deaf and dumb man heard this statement with anything but humility. He demanded the reasons, and the detectives replied by seizing the peg legs, the crutches, the plaster casts, the signs and the two beggars.

Arraigned before Municipal Judge Himes on a charge of disorderly conduct, the beggars demanded a jury trial. They were taken back to the Chicago avenue police station and locked up. Reporters who attempted to interview them found that Trent was deaf and dumb again.

Rich Harvest Reported.

Detectives Curran and Tobin say they have been watching these able bodied unfortunates for a week. They have been operating chiefly in the Chicago avenue district, and the sleuths say the harvest has been a rich one. The detectives declare that when they entered the Huron street quarters they found, besides several champagne bottles and the general equipment which they seized as evidence, a young woman. They did not arrest the girl.

Gotch Against Johnson and the Same Purse? Oh, Say 'Tis Not So.

Chicago, July 13.—That Frank Gotch, champion heavyweight wrestler, is in dead earnest in his desire to meet Jack Johnson in the prize ring is the statement of H. H. Frazee, the man who planned the world tour James J. Jeffries was to make if he won at Reno. Gotch is at his Iowa farm, where Frazee has been in communication with him.

If the purse is made attractive the big wrestler will go to work to get into condition to fight and will practice boxing for a year. Gotch, according to Frazee, thinks the purse should be made fully as big as that offered Johnson and Jeffries.

He prefers to fight in Australia, Frazee says, and does not want any preliminary tour.

"Gotch says he wants to fight solely because he wants the white race again to hold the heavyweight title," Frazee said today. "He does not want any theatrical tour before the fight, because he fears the public would think he was in the fight solely for the money."

Gotch to Meet Frazee.

Humboldt, Iowa, July 13.—Frank Gotch, champion wrestler of the world, today said his plans for fighting Jack Johnson are indefinite. He added that probably he would leave this evening for Chicago to see H. H. Frazee, who has been in communication with him, and that later he would make a statement to the press.

"CHIMMIE" RETURNS FROM JIM-JACK GO

James J. (Chimmie) Richardson, who writes the breezy "Chimmie's Column" for The Journal, returned yesterday from the big brawl at Reno, after having spent a few days at his home in San Francisco. After summing up the big fight, Richardson said he felt mighty sorry for the Australian sports who traveled thousands of miles by steamer and rail to witness the fiasco. He occupied a seat in the press row directly behind Johnson's corner and heard much of the comment in the champion's rest periods. He says that Johnson could have disposed of Jeffries at any time after the second round, and that the showing of Jeffries was pitiful.

POLICE CHIEF PROTECTS "WHITE SLAVE" VICTIM

Denouncing a Greek who this morning tried to secure the release of Irma Jorgenson as a would-be "white slave" dealer, Chief of Police Cox this morning ordered him from police headquarters and threatened to arrest him if he returned again.

The Gorgenson girl is held at the city jail on a 30 day sentence. She was arrested in the Stratton hotel at Third and Pine streets, where she lived after being deserted by Andrew Morphis, who lured her from Salt Lake City on the promise of marriage, and then fled to San Francisco. Chief Cox has communicated with her mother. The girl will be released if the parents send for her.

Since she has been confined in the jail repeated attempts have been made by Greeks to have her released. One man was ordered from the station two days ago, and another brought a lawyer with him and tried to "bluff" Chief Cox. His attorney failed to help him. This same man returned this morning, with the result that the chief angrily told him to get out.

Chief Cox firmly believes the girl was in the clutch of "white slave" dealers before her last arrest, and is determined she will not get into their power again.

Athena Store Looted.

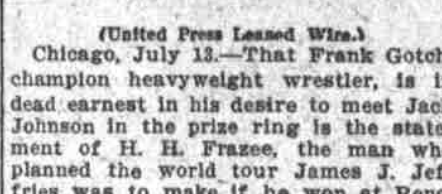

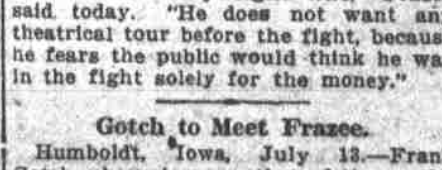
