ASQUITH HAS AS MANY KINDS OF INSURGENTS ON HIS HANDS AS SPEAKER CANNON.

(United Press Leased Wire.) London, July 13.—"Insurgent" and "progressive" factions are not alone confined to the American congress. Premier Asquith is encountering the reform element of the Liberal party and is believed to have failed in his attempt to force the Liberals into an arrangement with the Conservatives for indefinite abolition of the reform program for which the Liberals have been working. The premier is not in sympathy with the progressives. When the insurgents demanded the abolition of the house of lords Asquith was far from agreeing with the demand. He does not want to see the upper house abolished and he is not in sympathy with other governmental reforms demanded by the majority of his followers.

Asquith, however, has in his cabinet men who do not wish to lose the advantage they have gained for the Liberals by a "compromise," which is so favorable to the conservatives that they have openly shown their eagerness to accept it.

Asquith's stand was upon the claim that it would be unfair to King George to precipitate a great constitutional fight at the outset of his reign. His proposal was for the conservatives to agree to leave matters as they were.

The progressives are determined to prevent an agreement, and are appealing for aid to the laborites, who oppose the aristocracy, and to the Irish wing, who are separated from home rule by the existence of the house of lords.

It was given, and Asquith was forced to break off negotiations. Never having begun them openly, the premier was not forced to announce their discontinuance. The fight will be resumed at the autumn sitting of parliament.

SUFFRAGETTES ADD TO TROUBLES OF ASQUITH

(Special Dispatch to The Journal.) London, July 13.—Premier Asquith has the fight of his political life awaiting him unless he knuckles under to the demands of the militant suffragettes of England. The Shackleton bill, giving the franchise in parliamentary elections to women landowners, went through second reading last night and was then referred to the committee of the whole. It will not be considered again at this session, unless Asquith approves. The Liberal is known to be hostile to the bill.

"If Asquith does not yield to the popular demand," said a leading suffragette at headquarters today, "we will resort to such violence as will make former outbreaks seem tame. We want to obtain our rights peacefully, but when we cannot get them peacefully we make our demands militantly."

Walter L. Claren, who is the leading champion of the suffragettes in the house of commons, said that if the Shackleton bill was defeated, it would "signalize an outbreak such as England never saw before; women and the men who sympathize with their cause will temporize no longer."

FOURTH ST. FREIGHT SERVICE ENDS SUNDAY

Beginning Sunday next the Southern Pacific will take all freight trains off the Fourth street line and send the freight service out over the east side trade and back onto the west side across the Oswego bridge and by means of the Beaverton cutoff.

Two passenger trains will also be taken off the Fourth street run. The Sheridan train, leaving Portland at 4 o'clock, will be run over the east side and across the Oswego bridge. The round trip Forest Grove train, leaving at 12:50 p. m. and arriving at 11:50 will be sent down to the Jefferson street depot.

WANTS MOTHER KEPT FROM BABY

Manuel Hallack Tells Court Wife Exercises Bad Influence Over Infant.

Manuel Hallack, who some time ago charged his wife with carelessness in leaving a cup of lye where one of their children could reach it, with fatal result, and alleged she shamefully neglected the children, now makes the unusual request of asking the circuit court to deny her even the right of visiting her baby, little Leona Hallack.

In an affidavit filed by Hallack he says his former wife, Cora D. Hallack, has a bad influence on the child when she calls, as she is now permitted to do, under order of court, the baby being in the custody of its father. Hallack alleges she is violent in conduct and vulgar in speech. She calls him names, he says, frets the baby and abuses the nurse.

A supporting affidavit is on file from Mrs. Daisy Parker, the nurse, who says Mrs. Hallack has threatened her with bodily harm. Hallack was granted a divorce last October by Judge Gates, after a trial lasting several days. He asks to have the decree modified to prohibit any visit from the mother to her child.

PIONEER WOMAN IS ADJUDGED INSANE

(Special Dispatch to The Journal.) Medford, Or., July 13.—Mrs. P. J. Ryan of Jacksonville, widow of one of the first settlers of Jackson county, coming across the plains in 1851, was Tuesday adjudged insane by County Judge Nell and committed to the insane asylum at Salem.

Mrs. Ryan is nearly 80 years of age and has been falling mentally for the past year, or since her husband's death. Mrs. Ryan and her husband came to Jacksonville in the spring of 1852 and have resided there continuously. They accumulated considerable property and were one of the best known pioneer families in the county.

MALHEUR TO HOLD AGRICULTURAL FAIR

Vale, Or., July 13.—The Malheur county court, which is in session, has just made an appropriation of \$1000 to the Malheur County Fair association as asked by the board of directors a few days ago. This will be Malheur county's first agricultural fair and every town in the county is working harmoniously on this proposition. The fair grounds were located at Ontario, near the main line, so that the race circuit could be secured.

The grounds are being put into shape and buildings will be erected at once for the fair, which is to take place September 21 to 24.

SPEAKER BOOSTS POINDEXTER.

Martin, who did some notable clean-up work in Spokane and is now representing the state Grange in a special campaign for equal suffrage, addressed a large audience in the Methodist church Monday night. The result of Martin's talk is a movement to organize the county to secure the passage of the equal suffrage amendment.

While not campaigning for Poindexter, Martin is heartily in favor of his election to the senate, holding him to be a man of unusual qualifications and of broadness and independence of mind that is needed in that body. Martin says he finds considerable Poindexter sentiment in his travels.

ARMY DIRIGIBLE CIRCLES ST. PAUL.

London, July 13.—One of the greatest flights in the history of dirigible ballooning in England was accomplished yesterday by an army balloon, which flew from Aldershot to London and returned. Fully a million people witnessed the flight. Reaching London after an easy flight, the huge bag, guided by a full crew, steered itself to St. Paul's cathedral and circled the dome twice in full view of the vast throngs that watched from the streets. The dirigible then returned to Aldershot.
