

RED LETTER DAY ENDS FIRST WEEK OF CHAUTAUQUA

Gladstone Park Scene of Assembly, More Beautifully Decorated Than Ever; Membership of Classes Growing.

Debates on Temperance.
Late last evening a telegram was received from Ashland, saying that the first of the series of debates on temperance, which was to be held at that place this afternoon, was detained by illness, and a debate on prohibition was arranged between Rev. Clarence True Wilson and Colonel E. Hofer of Salem. This will no doubt attract quite a large, if not a larger audience than would Colonel Bain.

With a brilliant finale, the first week of the seventeenth annual chautauqua assembly closed last night at Gladstone Park. It was a red letter day from every standpoint. Never was the park more beautiful or in better condition. A plentiful supply of water and its liberal use has kept the dust down and the woodland avenues in perfect condition.

Early yesterday morning the crowds began pouring in, and the influx of people never ceased until the evening program was well under way.

While the courses are half completed, this morning found many still entering the classes, every one, without scarcely an exception, being as full as is desired for real good work.

In discussing the works of Sir Francis Bacon, in the department of English literature, under Professor Frederick Berthold, it was said that Bacon hardly wrote the English language, and wrote many of his works in the Latin tongue, supposing his own vernacular would ultimately disappear. This brought up the topic of Esperanto as a promising world language. The discussion was lively. It developed that neither this artificial language nor any other would ever become living, breathing organisms with anything like positive value or longevity attaching to them. These artificial creations have no history; they have no literature, nor any cherished or precious associations to make them near and dear to the human heart.

Classes Interesting.
The classes are intensely interesting and very popular. On Monday the class will discuss the Elizabethan age.

At 10 a. m. today the Sunday school class will be held, classes being arranged according to the usual method of Sunday school work. At 11 p. m. Mr. Pratt of Portland and Rev. Clarence True Wilson will deliver addresses under the auspices of the Oregon Dry State Campaign association.

The temperance people of the Chautauqua grounds were rejoiced at the reception of a telegram from the secretary of state that the prohibition petitions had passed that office and the measures for a dry state had been ordered printed upon the ballot. There had been no apprehension in regard to this, but the news was welcome, nevertheless.

The topic for the afternoon program at the W. C. T. U. headquarters was changed in absence of a leader, and Mrs. Unruh spoke in her usually interesting way on the "Peril of Impurity and Some of the Remedies" to a gathering that taxed the capacity of the large tent.

The leader of the Bible class being absent in the morning, Mrs. Unruh was called upon to fill that period, and she gave a talk on the Oregon dry campaign that brought forth frequent applause.

Today is W. C. T. U. day at Gladstone, and a great crowd is looked for. A splendid program has been planned for the 11 a. m. period.

Headquarters Decorated.
The headquarters of the University of Oregon are at about 100 feet east of the auditorium, on the best location on the grounds. Laman-yellow bunting is used with telling effect in the decoration of the surrounding trees and tent. On the walls of the tent are two beautiful Klier pictures of "Landings of the Indians." An alumnus of the university is present at all times in charge of the headquarters to answer questions and give out literature and to receive all friends of the university.

It has been left to a small club of women, numbering about 25 members, to erect the first permanent headquarters.

GROCERS GO ON FROLIC WEDNESDAY

With Families and Clerks Will Go to Canby for Day's Outing.

Next Wednesday morning the grocers of Portland will don their Sunday best and go early to their stores. They will look carefully behind the sugar barrels and the potato bins to make sure that no industrious clerk, anxious to work rather than have a holiday, have concealed themselves. Then the grocers will turn the keys in the locks of the front doors and the housewives may seek in vain to buy butter or salt, for the grocers will not be there to make the sales. They and their clerks, numbering more than 800, will all be picnicking at Canby, 25 miles from Portland.

The annual picnic of the Portland Retail Grocers' association is to be more a field day than a picnic. Eighteen events of athletic and festive nature have been arranged for. The wholesale establishments, commission men and local milling forces will all be represented.

In honor of the event, Canby's Commercial club has decorated the small city throughout its length and breadth. The picnic grounds have been made especially attractive.

Special Train Service.
Nothing is to be allowed to go wrong, and the great crowd is to be handled by special train service with the greatest expedition and the least possible inconvenience. Secretary Merrick of the grocers' association will be a sort of general overseer.

The chairman of the following committee will attend to executive details: Executive, R. A. Power; sports, Bert Landauer; music, W. F. Tate; reception, J. W. Caldwell; refreshments, F. W. Funk; judges, Ralph Hahn.

Then there will be more races, namely: Women's egg races, dressing race, grocers' relay race, fat man's race, hundred yard race, concluding with various tugs of war. Out of which there are prizes for the winners, and in many cases, for the losers. The grocers' annual picnic has this year seemed an unusually popular event, for more than 8000 tickets have already been sold.

young girl today in London expressed the belief that his daughter had also been murdered.

He said that she had been in constant fear of her employer and had often told him of it.

Scotland Yard today advertised in papers throughout the United Kingdom and on the continent in "personals" addressed to Ethel Clara Leneve, the stenographer companion of the fugitive girl, urging the girl to betray him to the police. They hope that this will aid them in retrieving the blunder of allowing the doctor his liberty upon "honors" after he had told conflicting stories about the disappearance of his wife.

Case Not Completed.
The work in London is along several lines. The case against the physician is by no means complete, for it is not yet proved beyond all doubt that the body found is that of Mrs. Crippen. It is so far destroyed as to be unrecognizable. It will be absolutely necessary to prove identity before any case can be established. This branch of the work is in charge of scientists who are taking advantage of every fragment found.

A second line of search is for the man who sold the quicklime. That will assist in the fixing of the first requisite of identity. This is a hunt for the jewels of the dead woman. It is known by Scotland Yard that Dr. Crippen could not trust himself with money.

Woman Drew All Checks.
Crippen's bank account was in Belle Elmore's name and she drew all checks. That money is intact. Belle Elmore's jewels were worth about \$3500 and these are all gone. They were pawned in the United Kingdom or anywhere else they will be discovered. Without them it is not believed that Dr. Crippen could have had more than \$300. This would not take him far, particularly as he would have to pay dearly for secrecy. Reports from London late today stated that search was being made for a French maid employed by Mrs. Crippen at No. 28 Hilldrop Crescent, North London. It was feared that she also had been done away with. Friends of Belle Elmore in this country do not understand this. She never kept a servant. Cleaners came once a week, but the rest of the time the house work was done by Belle Elmore. When they gave an entertainment it was in charge of a servant.

Physicians Still at Work.
The physicians examining the body found in the Crippen cellar are not yet through with their work and the request has been postponed until tomorrow. The police are satisfied that the body is that of Mrs. Crippen but the medical men may find evidence of the victim has not yet been established sufficiently to satisfy the law. After death the body was cut to pieces and some of the bones removed as if by a hand skilled in surgery. Then the flesh was covered with quicklime which destroyed the possibility of recognition.

Thorough examination of the Crippen residence and grounds has disposed of the theory that the premises had been used as a burying ground for bodies other than the one found.

Not a sign of another corpse was found.

One fact that leads to the hope that Dr. Crippen cannot be very far away or remain in seclusion very long is the discovery that he had only \$250 in cash when he and his companion disappeared on Saturday night.

It is believed that he took along a number of his wife's goods, but the police think him too smart to try to pawn or dispose of any of these for a long time to come.

TRUSTED EMPLOYEE BROUGHT TO BOOK

Albert H. Eames of Pittsburg Charged With Embezzling Funds for Gambling.

Pittsburg, July 16.—Albert H. Eames, until recently secretary of Alexander Peacock, one of the young Carnegie millionaires, was today held for the fall term of court on allegations of misapplying thousands of dollars' worth of stocks and bonds belonging to his employer. His bail was fixed at \$15,000. It is charged that Eames played on the stock market, hoping to make his fortune in mining properties. But the market acquired an unexplained panic and Peacock's securities were lost. According to the allegations, Eames sold some of the securities and retained others. An indefinite figure of between \$50,000 and \$100,000 is mentioned as the shortage.

Eames' arrest caused a big sensation. He is married and has been looked upon as a very upright churchgoing citizen.

MAJOR BURRITT LOSES WIFE BY DIVORCE AT RENO

Burritt Is Federal Judge in Philippines—Wife Alleged Extreme Cruelty—Goes With Sister to China.

Reno, Nev., July 16.—Mrs. Florence L. Burritt secured a decree of divorce this afternoon from Charles H. Burritt, an attorney and former federal judge in the Philippines. He was also a major in the Philippines during the Spanish-American war.

Mrs. Burritt alleged extreme cruelty and no time was lost after the filing of the complaint, July 15, to rush the matter through.

Burritt answered the complaint yesterday.

Mrs. Burritt left this evening for San Francisco, where she will join her sister, Mrs. C. A. Bidwell, whose husband owns the fashionable Hotel Savoy at Shanghai, China. The sisters will leave for China immediately.

The Burritts were married in Greeley, Colo., March 23, 1907. They met in the Philippines.

Mrs. Burritt testified that when she was drinking a cup of milk, March 20, her husband took it from her, choked her and called her the most unnatural woman he had ever seen and said that she was drinking her baby's milk. He threatened to kill her, but relented on account of her being the mother of his child.

Mrs. Burritt complained that her husband often told her in public that she was unfit to be the mother of his child. On other occasions he called her a murderer. She explained this by saying that Burritt accused her of trying to murder their child when she fell into a ditch, and insinuated that she bribed a boy to throw her daughter into the water.

Shortly after this, she testified, he struck her on the face when she asked him to take a bath.
