

BOWMAN MAKES SPEECH DEFENDING HIS CONNECTIONS

Compelled to Assume Defensive by Explaining Why He Is Attorney for Corporation—Does Not Favor Them.

(Salem Bureau of The Journal.)
Salem, Or., July 28.—Jay Bowman's maiden speech of the primary campaign, delivered to a good sized but unenthusiastic crowd in Marion square in this city Tuesday night, was taken up for the most part with an explanation of his corporate connections as attorney at Condon for the Harrison railroad. Mr. Bowman in his opening speech was compelled to assume the defensive.

He challenged his enemies to show an instance where, in public life as a member of the state senate, he had favored the corporation. He said the charges were unfounded, and asked the assembled voters if they had ever heard of a corporation lawyer in a town of 1200 people.

As for his policies, if elected, Mr. Bowman said he would favor good roads and better schools. He said he would make his appointments not at the object of paying political debts, but with the best interests of the people always in view. He also promised to use his influence to prevent tampering with the direct primary and other of the people's laws, in future as he said, he had done in the past.

ECHO GROWERS SELL 3600 TONS ALFALFA

Echo, Or., July 28.—One of the largest sales of hay ever made in Umatilla county here took place on Burner creek yesterday afternoon, and by the terms of the sale, Lemerger & McIntosh of Portland secured 3600 tons of alfalfa hay. The price paid was \$6 per ton in the stack and it is to be fed out to stock on the ground this winter.

Six hundred tons were purchased from the Vincent place, 350 tons from Ota McCarty, 100 tons from J. McCarty, 1000 tons from Mrs. Thomson and Allen Thomson, 250 tons from Grant Buchanan, and 300 tons from Mrs. Rogers.

Another large sale was made yesterday when Ass. B. Thomson sold 1100 tons to Heron Co. of Portland. The sale was made through the agency of Fred Walker of this place and \$6 per ton in the stack was the price paid. This is also to be fed out to livestock on the ground, during the winter.

Many Blindpiggers Sentenced.

Eugene, Or., July 28.—John Johnson and his wife, Besie, who were rounded up with five others in a raid made a week ago against blind-piggers by the sheriff and his deputies, were yesterday afternoon ordered out of the city, after a fine had been assessed against them by Judge Byron Johnson. The fine was \$50 and the woman \$200, but the latter's fine was not collected upon promise that she leave the city at once.

This disposes of all of the cases except that of Harvey Jones and his partner, William Bishop. Jones was acquitted by a jury on one count, but will be tried today on another. The others were all convicted, each receiving a sentence of 30 days in jail and fines ranging from \$100 to \$300.

Hood River County Will Be Scene of Hot Political Campaign; Open Debates.

The granges of the valley have unsheathed their swords for political warfare, and are determined to take the aggressive in the contest. The assembly plan for the nomination of candidates will be the object of attack. A series of open debates under the direction of the several granges of the valley will inaugurate the campaign. The grangers are now busy securing their list of debaters to defend the direct primary nomination plan against all comers. It is expected that Rev. J. G. Tate, candidate for state representative from Hood River county, will be called on to defend the side of the assembly. A. J. Mason, one of the leading members of the Pine Grove grange, stated that it was expected to open the series of debates in the near future. Mr. Mason is being strongly urged to run for state representative as an open candidate at the primaries.

FRYE WILL CLING TILL DEATH COMES

Gentleman From Maine Has No Intention of Following His Colleague.

Boston, July 28.—Senator William F. Frye of Maine, has no intention of following the example of his colleague, Eugene Hale, and retiring from public life. Frye's secretary, William Sande, vouches for the state that Frye will remain in the senate.

"The senator says he will resign only when he dies," said Sande. The retirement of Senator Hale came as a surprise to Maine politicians. Hale is one of the oldest senators in point of service, and his determination to drop out at the end of his present term followed shortly the announcement that Senator Aldrich would not be a candidate for reelection.

Senator Frye is a power in New England politics and the report that he would retire was widely discussed here. It was given some credence because of Hale's action.

PLAN TO MAKE BETTER CITIZENS

One Step Will Be Monster Meeting When Queen of Roumania Comes Here.

A meeting of the executive committee of the Better Citizenship association was held last night. A general conference of the membership, which had been called, was indefinitely postponed. Tentative arrangements were made for the holding of a monster mass meeting early in the autumn. A brief recount of the work already done toward realizing the association's ideal of "educating men away from criminality," was made. It was announced that the bureau of justice, of which Judge Lionel R. Webster is president and Rabbi Jonah B. Wise secretary, would begin an active campaign as soon as the vacation season is ended. The bureau of public health, under the leadership of Dr. Andrew C. Smith, it was stated, will also begin active work in the autumn. Lectures will be delivered before the school children and many other means will be utilized of impressing upon the popular mind the advantages of conserving health.

The bureau of mutual aid, under the leadership of Colonel C. E. S. Wood, has already commenced its work. A tract of land is being sought on which to place the dependent citizens, thereby making them independent.

Tract for Home. The bureau of social conditions, under the direction of General Charles F. Beebe and Father McDevitt will make inquiry in social evils, finding the causes and considering remedies which may be recommended to the association. The association also is looking for a philanthropist with a large tract of land which he will donate to be used as an industrial home. The philanthropist who makes the donation is to be made chairman of the association.

The Better Citizenship association is now a year old, with 5000 members in various parts of the world. The anniversary celebration will probably be held in September, when Carmen Sylva, queen of Roumania, will be in Portland. Letters came to the association and were exhibited at last night's meeting from the best citizens of the world. The majority of the communications expressed great sympathy with the better citizenship movement, and indicated a desire to aid.

Cosgrave, Frank Lawden, Robert M. La Follette, John Burroughs, Franklin MacVasagh, R. A. Ballinger, Ambrose Bierce, and James J. Hill. Telegrams were received from Governor Charles E. Hughes, Charles Klein, the playwright, and Nathan Sivin, who has done more toward saving the babies of the United States than any other 100 men. Charles E. Hughes, governor of New York, wrote: "I thank you for your letter. It would give me much pleasure, were it possible, to attend the conference of your association to be held at Portland on the twenty-seventh instant. Nothing is more gratifying than to observe the multiplying efforts that are being made in different communities throughout the country to direct men to the obligations of citizenship."

RUSHING WORK ON NEW BRIDGE

Expected Span Across River at Madison Street Be Ready in September.

Work of riveting the west span of the Madison street bridge and of erecting the west tower began today. Riveting work on the tower will be taken up as soon as the west span is completed. This will be inside of seven days. The work is considered on time, as planned, and the contractors expect to have the bridge ready for use about the middle of September.

Erection of the fourth span will begin Thursday, as will the construction of the false work for the lift. This false work will be placed beside the fourth span, and the lift span constructed on this and floated into place. The work of sinking piling for the false work started Monday. It is estimated that four weeks will be consumed in putting together the lift span.

The two towers on the lift will be approximately 240 feet high, measuring from the low water mark. There are 25,000 rivets in the west span. The Robert Wakefield company is doing the work. While it started late with the work, the plans were to erect a span a month. This has been done, the work progressing more rapidly than expected. Double gangs of men have been put at work. All efforts possible are being made to have the bridge ready for use within the time specified.
