

CANDIDATE CURRY SEEMS FAVORITE OF CALIFORNIANS

Alderson, Railroad Candidate,
Lacks Popular Support, and
Espee Would Down Johnson
at Whatever Cost.

(Special Dispatch to The Journal.)
San Francisco, Aug. 15.—California is today applying a state wide test to the direct primary law, and unless all signs fall the fight for the Republican nomination for governor will be one of the closest in the annals of California politics. The victory lies without doubt between Curry and Hiram Johnson, the latter the champion of the Lincoln-Roosevelt league, the avowed enemy of the Herrin machine.

Alden Anderson, the railroad candidate, would seem to be hopelessly beaten. The orders went down the line last night to throw all possible strength to Curry, as Herrin and the Southern Pacific had resolved to beat Johnson at all hazards.

Curry slightly favored.
As the ballots are being cast the odds seem slightly to favor Curry. He will undoubtedly carry San Francisco by a fair plurality over the Roosevelt league candidate. It remains to be seen whether the boasted strength of Johnson in the south is reality or myth. It is believed that Phil Stanton, who with Nat Ellery completes the quintet of Republican candidates, will pull a big vote in Los Angeles. If so Curry's nomination is assured.

Little interest is taken in the Democratic ticket. Theodore Bell has unopposed for the nomination, and thousands of Democrats in California are today voting as Republicans at the primaries. Curry if nominated will receive the railroad support in the November election. If Johnson gets the plum, then the Herrinites will be out teeth and nail for Bell.

Large Registration.
The registration returns for the state are simply staggering. With Inyo county missing, the primary election registration shows a total of 489,449, or approximately 78,000 more than the whole vote cast at the general presidential election in 1906. The Republican registration, less Inyo county, shows the astounding total of 326,628, or 142,000 more than the total vote cast for the Taft electors in 1908. The Democratic total is 101,043, or approximately 30,000 less than the total polled for Bryan electors in 1908. The Socialist total is about one fourth the party vote cast in 1908 and the Prohibition party's registration is approximately one third the total poll two years ago.

Hearst's "Doodle Dees," who polled nearly 5,000 votes in 1908, make a showing of only 200 in the state for the primary. Undoubtedly the vote polled today will show a big shrinkage from the registration totals. A conservative estimate places the Republican total at 300,000. One half of the total will probably be cast in San Francisco and the counties of Los Angeles and Alameda. Stanton, Santa Clara, San Joaquin, Fresno, San Diego and Humboldt counties, even on a 50 per cent basis, will add 25,000. The fact that vigorous fights have been made in each of these counties indicates that the ratio of their primary vote will compare favorably with the vote in San Francisco and Alameda counties.

Los Angeles County a Puzzle.
Los Angeles county offers the biggest puzzle. The Los Angeles total registration is 97,333, with a Republican total of 57,310. Both Stanton and Johnson managers confidently expect that Los Angeles county will poll 55,000 or more Republican votes. They estimate, but past performances are against them. Two years ago for the general election the Los Angeles county registration was only a few thousand short of the present total. None was debared from participation in the general elections because his affidavit of registration did not state his partisan affiliations. Where the Republicans and Bryan Democrats and non-party men got through voting for Taft, the record showed a total of 41,000. Estimating today's vote is guessing. To place it at 200,000 is conservative, and placing it at 250,000 means that the candidate who can muster 80,000 votes before 6 o'clock tonight will be the Republican nominee for governor tomorrow.

IDENTITY OF DEAD CROOK ESTABLISHED

That Ernest A. Frazier, who was shot and killed by a Sacramento, Cal., police officer after attempting a purse snatching, was the notorious "pink domino burglar" of Portland, was firmly established by Acting Chief of Police Moore today when he learned that the name of the step-father of the Portland desperado was Frazier. Under the name of Ernest Lane, Frazier terrorized the city in March and April of 1907. Robberies and holdups were committed in great numbers, the criminal using the most daring methods and frequently resorting to violence. Each time he wore pink domino and this gave him his nickname.

Lane was finally detected through a tip from Tom Finner, a former police officer. His home was in Lebanon, Or., and he at one time was a student in the Oregon Agricultural college.

EARTHQUAKE SHOCK IS FELT IN FRANCE

THIRD SLANDER SUIT IS BEGUN

J. N. Windsor Is Again Sued
for Slander in Consequence
of Directorate Row.

J. N. Windsor, head of one of the squabbling factions of the Campbell Automatic Safety Gas Burner company, is being sued on the installment plan in the circuit court, \$10,000 at a whack. Today the third suit for that sum on the charge of slander was filed by E. Hollowell, the others having been filed within the last week at intervals of a few days by Henry Haggelstine and H. J. Quackenbush.

Cicero M. Idelman is the attorney for the plaintiffs in each suit, and has kept his typewriter busy grinding out the slanders alleged to have been uttered by Windsor against Haggelstine, Quackenbush, Hollowell, C. C. Mourer, L. C. Hammer, C. E. Belding, H. C. Luckner, M. P. MacCallister and Victor E. Campbell. Other installments at \$10,000 per may be coming on behalf of the others alleged to have been falsely charged with misdoings by Windsor.

Allegations in the Hollowell complaint are the same as in the former suits against Windsor. They grow out of the troubles in the directorate of the Campbell Gas Burner company, wherein Windsor was finally ejected from the company's factory. Windsor went into court with a complaint charging Hollowell with libel, and making a way with \$100,000 paid into the treasury of the Safety Investment company, which was a kind of subsidiary concern, and with selling stock to unwary purchasers under misrepresentations. Hollowell, like Haggelstine and Quackenbush, says they were never connected with the investment company and had nothing to do with the acts of which Windsor complained. He says his business standing has been injured by what Windsor stated in a complaint, denies any conspiracy and declares he should have \$10,000 damages for injury to his good name.

C. J. REED SAYS HUMOR WILL NOT DESERT HIM

BUY WATER PLANT IS SALEM SENTIMENT

Salem, Or., Aug. 15.—The special election held yesterday for the purpose of determining whether the city charter should be amended to empower the city, through its council, to purchase the water plant of the Salem Water company, carried by a majority vote. The amendment, which would authorize the council to purchase the plant for \$450,000. The plant will be connected with a gravity system, thereby securing a pure water supply, a need that the citizens have felt since the epidemic of typhoid fever last fall and winter. Because there is no law authorizing the city to keep open registration books for a special election, some trouble was experienced yesterday at the polls and the defeated faction may seek to make it a basis for a contest.

DALLIES BOOTBLACK COMMITTS SUICIDE

The Dalles, Or., Aug. 15.—Andrew Hall committed suicide Sunday afternoon by stepping in front of a fast moving freight train. He was carrying a piece of machinery. Hall was sitting in front of a restaurant and threw himself beneath the engine. The brakeman saw him and signaled the engineer, but before the train could be stopped Hall had passed over Hall's body. Hall had been about the Dalles for two or three years, working at odd jobs. Last spring he was declared insane and was sent to the asylum in Salem, but was discharged about a year ago. Since his return here he had been blacking shoes.

TENNIS CHAMPIONS FAVORED IN BETTING

Newport, R. I., Aug. 15.—Owing to threatening weather, the doubles match of the National Tennis tournament were postponed indefinitely today. The singles will be played off this afternoon. Betting on the outcome of the doubles favors Hackett and Alexander, the present champions, five to one against Bundy and Hendrick, the challengers, according to local experts. Bundy is from Los Angeles.

Dalles Man Killed

The Dalles, Or., Aug. 15.—Roy Taylor, a well known farmer and fruit-grower of this place, was killed last Saturday afternoon while moving a well drilling rig to his farm on Three Mile. The brake gave way allowing the wagon and rig, which weighed about 9,000 pounds, to force down onto the horses. Taylor attempted to run the wheels of the wagon into the bank, but instead the outfit overturned, throwing him to the ground, his head striking against the machinery, fracturing the skull. Chris McWay, owner of the drilling rig, was with Mr. Taylor when the accident occurred, and after freeing himself from the wreckage, got one of Twedy Brown's cars, which was passing, to pick up the injured man and bring him to the hospital in this city, where he died later in the evening, never regaining consciousness.

JOHN LIND SHUNS POLITICAL TALK

Minnesota Lawyer Will Not Say
Whether He Will Accept Gu-
bernatorial Nomination.

John Lind, former Democratic governor of Minnesota, who was again given the gubernatorial nomination by the Minnesota Democratic state convention recently, arrived in Portland last night with his wife and two daughters. John B. Burdard of St. Paul, Minn., a lumberman prominent in Democratic politics of the state, met the former governor at the Hotel Portland today and conferred with him for some time.

"The Democratic outlook in Minnesota is excellent," said Mr. Burdard. "With Lind as a candidate it would be a walk-away." Governor Lind avoided a discussion of politics. He would not say whether he will or will not be a candidate for governor on the Democratic ticket. He shunned the subject of Democratic politics in the state of Minnesota and would not be interviewed on national politics. He said that for weeks he has been in the backwoods of Washington and in regions where he could not keep in touch with current events.

Mr. Burdard told him that Democrats over all the state of Minnesota were pleading that he make the race for governor. Burdard told him of the excellence of his chances and of the rosy hue of Democratic prospects in the state.

Governor Lind said he is interested in the operation of the direct primary and assembly in the state of Oregon. "If the assembly is good then the direct primary is bad," he said. "We have tried the direct primary in Minnesota with great success. Generally, and with the great mass of voters, it is popular, but, of course, a few bosses do not favor it, because it robs them of their power."

He spoke for conservation. "I believe that in the past," he said, "we have wasted our forests and resources and I believe laws should be passed for their protection." But as to whether he will accept the Democratic gubernatorial nomination he would say nothing. He asked that he be relieved of a discussion regarding the nomination.

ASKS BIG DAMAGES FOR BROKEN BONES

Having lost the use of his right arm and leg by the fall of a 600-pound chain block, as he alleges, Louis Vanyi has begun suit in the circuit court against the Portland Flouring Mills company for \$25,000 damages.

Vanyi says he was formerly employed at the mill as a grinder, looking after the big grain rollers, but about two weeks before the accident Head Miller Brown ordered him to assist as a laborer and machinist in shifting and reconstructing the machinery. On March 28, he says, he was helping to raise a five ton dynamo when the sling chain broke and allowed the heavy block to fall upon him.

It was with a smile that Mrs. A. M. Benjamin left municipal court this morning to return to prison after she had been bound over to await the grand jury's action for shooting her husband yesterday night. Benjamin's condition yesterday was serious, but there are good prospects of his recovery and his wife may not have to face a murder charge. On the advice of her attorney she waived the hearing in municipal court.

Brothers Robbed Brother.
Michael Povloch has not recovered \$128 which he alleges his brothers stole, but he gained considerable satisfaction this morning when George and Frank Povloch were bound over to the grand jury on the charge of robbing him. The victim left his money in his purse in his trousers, and when he awakened in the morning his money was gone. He had locked the door before retiring and only his brothers were in the room.

Peterson Paid for Flirting.
The attempted flirtation of Antone Peterson cost him \$10 in municipal court today. He was arrested Sunday night by Patrolman Humphries, after he had accosted a girl at Second and Salmon streets without any encouragement from her.

ATTACK METHOD OF ASSESSMENT

B. M. Lombard Would Try Out
Legality of Brazee Street
Work.

On the ground that assessments for street opening should be made by lot and block and not by "lumping" a whole addition, B. M. Lombard has begun suit against the city of Portland to restrain the collection of the assessment and adoption of the report of viewers on street opening in the Brazee street addition.

Lombard declares the result of the manner of assessment pursued in the case all the expense to fall upon him, although he has sold considerable property to other purchasers. The opening of the streets calls for taking numerous tracts or strips of land owned by individuals, and the cost of each hundred dollars each have been assessed.

Technical objections are also urged against the assessment, including an allegation that the viewers allowed more than a week to elapse between their meetings, contrary to the rules of such bodies. Lombard asks the court to declare the whole assessment void.

HAS ANYBODY HERE SEEN KELLY? POLICE WANT HIM

Kelly has been seen, but they are looking for him again. He is Patrick O. Kelly, his eyes are blue and he's Irish through and through, but—he's no true Irishman. Kelly double-crossed a countryman and he is wanted more badly than before. He is wanted by the police.

Kelly mingled his brogue with that of James Milligan, a plumber, in a down town saloon last night. Kelly would have bought a drink, but he said he had no change. "Any Milligan, me bye," said Kelly. "Will you cash for me a check?" "Sure, Mike," said Milligan. "The check was for \$25. When the bank got it today it was returned marked 'No funds.'"

Burglar's Kit Causes Fine.
Caught with a kit of burglar tools in his possession, Joe Goldberger, a police character and drug fiend, was sentenced to pay \$100 fine or serve 30 days on the rockpile by Judge Bennett in municipal court this morning. John Davis and John McCool, who were with Goldberger when the arrest was made by Patrolman Frey, received similar fines. It was suspected that the men were looking for some promising place to rob when arrested at 2 o'clock this morning.

GREENFIELD SAYS WIFE WORKED HIM

Charges She Persuaded Him to
Buy Furs in July, Then De-
serted Him.

Protesting that his wife "worked" him for \$68 worth of furs in the hot month of July, also for a \$25 lavallier and a \$36 skirt after she had filed suit for divorce, making these things conditions before she would become reconciled to live with him again, George L. Greenfield appeared in the circuit court this morning to resist the allowance of \$10 per week alimony to Laura B. Greenfield, pending the trial of her suit for divorce.

Bristling affidavits charging bad faith on both sides were presented to Presiding Judge Gatens when the case was called. Mrs. Greenfield asserted her husband returned to live with her and back with her, also that he had agreed to and two checks for her suit for divorce, and after about two weeks told her she was glib and an easy mark, as he had not intended to become reconciled to her.

Greenfield denied he made any such statements. He produced receipts to show his expenditures for furs, jewelry and clothing in the month of July. He admitted he had promised to take a long trip to the east with his wife and to bring a child of hers by a former husband back with him, also that he had agreed to and two checks for her suit for divorce, and after about two weeks told her she was glib and an easy mark, as he had not intended to become reconciled to her.

Greenfield, who is the head of the Greenfield Shoe company, attributed his wife's conduct to the pernicious influence of Helen Cardwell, a friend of his wife, whom she insisted should live with them, he says. He asserted he had done enough for her until the time arrives to try out their divorce case on its merits.

Despite this, Greenfield was willing to pay \$5 per week, as he announced through his attorney, F. Shelton. G. Johnson and W. W. Graves, attorneys for Mrs. Greenfield, wanted \$10 per week. Judge Gatens split the difference and allowed her \$7.50 per week pending the trial of the suit for divorce. The court said \$10 per week or even \$20 would be reasonable under most circumstances, but in view of the showing made by Greenfield in his affidavits the court would not feel justified in using its discretion very strongly against him.

ENGINEER IS KILLED AT ARLINGTON, WASH.

Everett, Wash., Aug. 15.—Engineer Barney Finnegan of Seattle was killed and Fireman Bowers slightly injured in a North Pacific freight wreck at Arlington, 30 miles north of here, at 4:30 this morning. The wreck occurred 100 yards from the depot where the Darrington branch leaves the main line. It was caused by spreading rails. Finnegan's body will be taken to Seattle. The engine overturned, crushing Finnegan beneath.

Young Women Biblical Students.
Lake Geneva, Wis., Aug. 15.—The annual central city conference under the auspices of the national board of Young Women's Christian association opened here today and will continue until August 24. Several hundred young women registered at the opening today and many more are expected to put in an appearance before the end of the week. The conference is planned for all members of the Y. W. C. A. students and teachers in educational institutions, and other persons interested in Bible study and in missionary work. Many well known lecturers have been engaged for the present conference.

Colored Business Men to Meet.
New York, Aug. 15.—The eleventh annual meeting of the National Negro Business league will be held in this city beginning tomorrow and will continue for three days. About 1,000 delegates, representing more than half the states of the union, are expected to attend. The league was organized in Boston 10 years ago, with Booker T. Washington as its president. The object of the organization is to inform the world of the progress the negro is making in business and to stimulate local business enterprises in colored communities.

SELLWOOD POOL READY FOR USE

Sellwood Park Swimming Pool
Will Be Opened to Public
Thursday Morning.

The swimming pool at Sellwood Park will be opened for use Thursday morning at 11 o'clock. All days except Wednesday and Thursday will be free, while on these days a fee of 25 cents will be charged for the use of the pool, bathing suits, towels and lockers. Fred Perkins has been selected as instructor and will be on hand during the open hours. Classes will be organized among adults and children and the services of the instructor offered such organized classes. A few bathing hints have been formed by Fred Superintendent Mische as follows: Don't enter the pool while the body is heated; don't bathe on a full nor empty stomach, as an hour should elapse between bathing and eating; don't enter the pool before cleansing the body in the showers; do not spit in the pool.

The pool is 120 feet long, 80 feet wide and two feet deep at the shallow end, and graduates to a depth of eight feet at the deepest point. Bull Run water is used and it is essential to keep the running so that 100 gallons shall be used for each person. All towels and bathing suits are sterilized before second using.

It is planned to have the pool open at 11 o'clock, and use will be offered until 7:30 o'clock in the evening. It is also planned to designate certain days for use by males and other days for females.

FATHER MURRAY HAS BUSY TIME ON VISIT

Rev. Father Patrick Murray, superior general of the Redemptorists Fathers, following his arrival in Portland yesterday morning, spent the day and this forenoon in visiting the Catholic institutions in and around Portland, accompanied by Archbishop Christie and Rev. Edward K. Campbell at the head of the Redemptorist school at Piedmont.

This morning the superior general visited St. Mary's school, where he made a short talk to the assembled sisters. He was entertained at luncheon at the school of the Holy Redeemer, and will be the guest this afternoon of Archbishop Christie at the archbishop's residence on Fifteenth street.

Yesterday, the superior general visited the Catholic institution at Oswego and was entertained there at luncheon. He leaves tonight for California, where he will visit other Redemptorist houses.

Father Murray is the first English-speaking superior general of the Redemptorists. He, heretofore, the heads of the order having been invariably selected from among the Italian clergy. Up to the time of his election one year ago, he had been at the head of the order in Ireland. His headquarters are at Rome, which he left June 24, for a three months' visit to the 46 Redemptorist institutions in the United States and Canada.

SAYS THREE THIEVES FORCED HIM TO SLAY

Lewistown, Idaho, Aug. 15.—Hugh Lavery, the Kamiah mining man, who was shot and instantly killed at Trammey Sunday afternoon by Fred Thomas, was buried in the Catholic cemetery today by the local Knights of Columbus lodge, to which he belonged.

The train that bore his victim also brought the youthful slayer, who has been held by the coroner's jury and will be taken to Grangeville by Sheriff Byrom of Idaho county this afternoon. Thomas sticks to his original story of the shooting, in which he claimed to have been forced to kill Lavery by three men whom they found looting Lavery's cabin, but the people of the community where he lives express the opinion that he himself was ransacking the cabin when surprised by the owner, and that he shot him in order to make his escape.

The prisoner is only 18 years old.

WAGON IS SMASHED BY STREETCARS

An express wagon was smashed between two streetcars this morning at 7:30 o'clock on the Steel bridge. The wagon was empty, and both the driver and the horse escaped injury.

The draw of the bridge was open and several cars were waiting on the east end to pass over. Just in front of an approaching Williams avenue car, and close behind another car, stood the express wagon with the driver, E. Hensen, employed by George Boron, 908 East Seventh street, in the seat.

Coming along the track toward the express wagon, Motorcar F. W. Hammett on the Williams avenue car, attempted to turn on the sand and stop the car before it reached the wagon. The wheels of the car slipped, however, and it crashed into the wagon, jamming it against the car in front. The horse became frightened in the meantime and broke loose from the wagon, while the driver jumped and escaped injury.

HUGE ANGLO-AMERICAN COPPER TRUST RUMORED

18 FIRE FIGHTERS INCORPORATED, IS KOOSKIA REPORT

Major Fenn, in Charge of Idaho
Situation, Believes Men Who
Went Into Selway Forests
Have Met Death.

(Special Dispatch to The Journal.)
Lewistown, Idaho, Aug. 15.—A report from Kooskia, the morning stated that 18 men are thought to have been lost in a battle against the forest fires near here. The 18 men were sent to Selway about 50 miles from here, and have not been heard from. The Selway district has been the scene of fierce fires, which have approached it from all sides, and the men are thought to have been surrounded and overcome by the flames. Major Fenn, who is in charge of the fire fighting in this section, has given up all hope of the return of the men.

The fire at the head of Selway creek, just outside the forest reserve, is now controlled and the progress of the flames has been checked. Twenty men have been battling with this fire, and they report that the worst is over. On Eldorado creek, where there has been a very bad fire, 40 men have steadily fought against discouraging odds, but today reported that the fire had been extinguished. Men are kept constantly on watch for new fires appear while the remainder of the party is paying attention to flames in other districts.

Florence is in serious danger of being destroyed by the fires in the Boulder creek district. It is predicted that only rain or a change in the wind can save the old mining camp. People arriving from the Selway district report that the fire is gaining at the rate of two miles per hour and steadily advancing on the town. It has reached to within nine miles of Florence and the forest rangers while fighting every inch of the advance say it is impossible for them to check the flames. The timber in the district separating the fire and the town is black pine and is more resinous than that previously burned.

Nearly all of the men who have been in the Selway district have been sent to Florence. A call for assistance has been sent to all surrounding towns.

REPUBLICANS HOPEFUL IN SUNNY TENNESSEE

Nashville, Tenn., Aug. 15.—Enthusiasm appeared to be the keynote of the Republican state convention which assembled in this city today for the nomination of candidates for governor and state railroad commissioner. Never before in the history of the party in Tennessee have the Republicans been more hopeful of success than they are now. The result of a Republican executive to succeed Governor Patterson when the latter's term expires are heard on all sides.

Republican confidence is based not so much upon the strength of their own party as upon the disaffection in the Democratic ranks. The result of the recent judicial election, in which the independent candidates were successful over those endorsed by the state administration, showed conclusively that a restoration of harmony in the Democratic ranks is at least a matter of time.

From nominating a judicial ticket and threw their strength to the support of the independent candidates. In return the Republicans expect that the independent Democrats, or a large part of them, will vote for the Republican gubernatorial candidate in November in order to make the downfall of Governor Patterson complete.

If the coalition which buried the administration judicial ticket stands until the fall election, it is believed that the retirement of Governor Patterson as a private life may be accomplished. The governor's only hope is that those Democrats who combined with the Republicans in the recent election will return to the party fold before November. If they do not, then the election of a Republican governor in November seems to be not only possible but probable.

HISTORIC PAGEANT IN NEW HAMPSHIRE

Peterboro, N. H., Aug. 15.—All business was suspended in this quaint New England town today while its citizens joined in a multitude of visitors in attending the opening of the three day historical pageant planned by the MacDowell Memorial association. For nearly a year committees have been actively at work preparing for the festival, which is held in honor of the memory of Edward A. MacDowell, the celebrated composer, who was a native of Peterboro.

The festival will continue three days. In a vast natural amphitheater against a background of forest, sky and mountain, 500 men and women in the costumes of various times will pose, act and sing in scenes representing the history of Peterboro and its vicinity. An important part of the program will consist of MacDowell's music, adapted for chorus and orchestra.

Reunion of Morgan's Men.
Cathlamet, Ky., Aug. 15.—Survivors of General John H. Morgan's command assembled in annual reunion today at the Parks Hill assembly ground, and will spend two days in renewing acquaintances and swapping yarns of war days. General Basil W.
