ARKANSAS BLACK APPLES BRING 'GOOD' PRICES

J. MANNING WITH CHAMBERLAIN IN COLUMBIA COUNTY

Telling Addresses by Both, in Which Records and Pretenses of Bowerman and Lafferty Are Shown Up.

(Special Dispatch to The Journal.)
St. Helena, Or., Oct. 13.—Senator George E. Chamberlain and John Manning, Democratic candidate for congress, spoke to a crowded house here last night. It was by far the largest and most enthusiastic political gathering held here since the opening of the year's campaign. The St. Helena band furnished music.

"I am a firm believer in the Oregon system of government," said Mr. Manning in opening his address. "This includes the initiative and referendum, the direct primary law and the recall amendment. All of them have been wholesome and patent factors in making Oregon one of the safest and in a civil sense the purest states of the union in which to invest or find a home."

The speaker promised that in the event of his election he would beg every energy looking to further improvement of the Columbia river. "I want to see it open from the ocean to Canada," said Manning. "An open river means cheaper rates of transportation; a closed river means a closed highway of commerce, higher transportation and higher cost of living."

Physical Valuation of Railroads.
Mr. Manning defined his stand for the La Follette plan of physical valuation of railroad properties. He favored enlarging the powers of the Interstate Commerce Commission so as to enable the commission to determine the actual physical value of railroad property and the fix transportation rates based on the legitimate cost of the road.

Never for Joe Cannon.
"And if I am elected I will never vote for Joe Cannon for speaker," said Mr. Manning in conclusion and the audience applauded the statement. "Nor will I vote for any man he controls or suggests. I am opposed to Cannon and Cannonism; not the man, but the scheme of politics and power which he represents."

Chamberlain Reads From Record.
"My friend Manning, here, is a strong man," said Senator Chamberlain, in opening his remarks. "If he had been less modest, he might have told you what he did for the people of Portland during the bank crisis three years ago—how he met the situation with great courage and protected the depositors who had their all at stake and punished the wrong doers. Manning is a man of action, rather than of words. He has always made good at home and you should elect him to congress where he will continue to make good."

Oregon's Paramount Issue.
The senator went directly into the issues involved in the state campaign and handled the situation without gloves. "The issue before the people of this state at this time is the life or death of the assembly scheme," said the senator. "Others may try to divert attention or evade the issue, but that is the only issue. It is a long way from being dead. Assemblyism is nothing but conventionalism, and conventionalism is nothing but assemblyism. In the earlier history of government the people have time after time broken away from it and they are going to do so again."

Agency of Predatory Interests.
"Assemblyism is extra-constitutional and extra-legal. It is provided for in neither the constitution, nor the statute law as a method of conducting our government. The constitution has always been, and so long as it exists will continue to be, the agency through which the predatory interests and seekers of special privileges exert an influence upon and control the legislation and politics of our government."

Bowerman Father of Assemblyism.
"The father of assemblyism in this state is Mr. Bowerman. He has always

avored it, and the convention which nominated him for governor was stacked in his favor. Mr. Bowerman is hostile to the primary law and to Statement No. 1. While he was president of the senate at the last session of the legislature he supported the Marine's bill, which was an assault upon the direct primary law, and he was so anxious to see it pass—so anxious to return to the old convention system—that he left his seat as president of the senate, took the floor and urged its passage."

Trying to Mount the Band Wagon.
He favored the Brook-Bear bill at the same session. This measure practically made it a crime for any person to take the pledge to obey the suffrage of the people on the election of United States senators. And now that he has been nominated for governor and the sentiment of the people upon this question is so well defined, Mr. Bowerman is trying to mount the band wagon and now is trying to come around to some of the things which formerly he denounced.

"Vote for Oswald West!"
"My friends, the only way to preserve the Oregon system in its spirit and its integrity is to elect Oswald West governor of this state. He stood for it before the primaries and he stands for it now—he has always stood for it. "And now we find Mr. Lafferty flopping. Before the primary election he went up and down this district advocating the defeat of every man who was sailing under assembly colors. With other anti-assembly candidates, he advocated this as vital. But now what a change, my friends! Now we find him coming out in the public press urging the people to elect assembly candidates to office. Any man who will abandon his political position and his political principles in 24 hours is unfit to be entrusted to represent the people of this state in congress."

Brewers Seek Lower Rates.
Fort Worth, Texas, Oct. 13.—The interstate commerce commission, represented by Judge Gerry, began a hearing today in the complaint of the Texas Brewing company against the Santa Fe and other railroads, in which the brewing company is seeking a reduction in the freight rates on barley. It is stated that the reduction, if granted, would mean a saving of about \$600,000 a year to the breweries of the United States.
