

PROBLEMS UP  
AT CONGRESS  
AT SAN ANTONIO

Trade With South America One of Chief Topics; Rival Fair Boosters Busy; Eminent Men in Attendance.

San Antonio, Texas, Nov. 21.—The twenty-first annual meeting of the Trans-Mississippi Commercial congress has attracted to San Antonio the largest gathering of distinguished men ever assembled here.

Other subjects slated for discussion during the four days' session include the improvement of inland waterways and harbors, Pan-American trade and the Panama canal, the reclamation of lands by irrigation and drainage, merchant marine, insurance, interstate commerce, the conservation of natural resources, the development of Alaska and the caribou post.

DETECTIVES ASK AN INVESTIGATION

Want Chief Cox to Look Into Captain Slover's "Protection" Accusations.

There will be no official investigation of the trouble between Captain of Police Slover and the detectives whom he charges as interfering with the work of the uniformed men.

"I am of the opinion that the charges are not true," he said this morning, although he does not deny that Captain Slover believed they were. I have investigated the affair and the detectives assert positively they did not step into the Damatio case in any way, while they were supposed to have approached, denying that officers had attempted to influence them.

"I believe Captain Slover exceeded his authority in presenting the matter in the form he did. He should have made his charges to either myself or Captain Moore, as the officer commanding the accused men."

Captain of Detectives Moore made an informal investigation of the charges Saturday night and declares he is positive none of the detectives intruded into the Damatio case. Detective Snow obtained a letter from B. F. Boynton, claim agent of the Portland Railway, Light & Power company, in which he said he had never been approached by Snow or any other detectives and requested to drop prosecution of Damatio, who was accused of using abusive language on a streetcar.

Captain Slover says he is not positive that Mr. Boynton was the official spokesman, although he was not to believe this. He declares an employe of the company told him that Detectives Snow, Coleman, Hellyer and Malone had asked to have the Damatio case dropped, but had been flatly turned down.

Street Gives Way Under Heavy Oil Wagon

Representatives of the paving company, Portland Railway, Light & Power company, water department and the city engineering company are investigating the breakdown in efforts to determine where the fault should be placed.

All existing ordinances of the city of Portland are to be repealed and an entire new codification regulatory of the liquor business of the city is to be substituted, according to the plan proposed by the Oregon Home Rule association, the attorneys for which organizations are now putting the finishing touches on the new model license ordinance to be submitted to the next meeting of the city council.

Saloons will be closed at midnight, and many strict rules for the conduct of places where liquor is sold will be put in the ordinance, according to the statement of H. S. McAllister, manager of the association. He says that there will be no attempt made to open the front of the saloons so that the interiors may be seen from the street. He contends that this would be impossible in view of the existing building arrangements in a great many of the places in the city.

The attorneys are now working on the ordinance and it will be ready for submission to the next council meeting Wednesday.

WANT NEW NAME FOR THE STREET  
PUT UNDER BAN

Those Who Want Thoroughfare Widened Suggest It Be Called Broadway.

Included in the general plan for widening Seventh street and making it one of the really important west side highways is the proposition to change its name to Broadway. This, say the promoters of the design to widen Seventh street from the west approach of the Broadway bridge to Burnside street, is the logical name for the street.

Portland's Broadway is an east side residence street and without special import in the city's system of streets; but to make of Seventh street on the west side of the river a continuation of Broadway would be in keeping with the custom in most large American cities of giving the name Broadway to one of the great arteries of travel.

The carrying out of the suggestion to change the name of Seventh street depends upon the building of the Broadway bridge and as the prolonged litigation affecting the bridge has about reached the end of its string it is probable that the promoters of the change will present their proposal to the council at an early date.

The movement to widen Seventh street from Burnside to the west approach of the Broadway bridge took another turn last week when the matter was referred back to the original board of viewers with the request that the assessment be continued as far south as Jefferson street. In the first report the viewers laid an assessment against all the property facing Seventh street between the Broadway bridge approach and Morrison street.

Some of the property owners filed remonstrances against the assessment, alleging that the benefits assessed against their holdings were excessive. These benefits ranged from \$100 a quarter block in this district north of Burnside street down to \$500 a quarter, which was assessed against the quarters at Seventh and Morrison.

Several of the remonstrators indicated that objection to the report of the viewers might be withdrawn if all property on Seventh as far south as Jefferson were made to help bear the burden of widening the north end of the street. Acting on this suggestion the board of viewers has instructed the viewers by the council with instructions to reassess the entire street as far south as Jefferson.

Property owners on Seventh street south of Morrison are by no means pleased with the prospect of having to help pay for widening Seventh north of Burnside and it is not improbable that the new report of the viewers will meet with the same strenuous objections that faced the first report.

WARRANT ISSUED FOR CLERK WEBB
