WILL FIGHT HARD

(By the International News Service.) San Francisco, Dec. 17.-Encouraged by the failure of the purser of the steamship Humboldt to identify any of the four prisoners charged with the success of \$60,000 worth of gold buillion from the vessel last August during her younge from Alaska to Seattle, the law-

yers for the defense are now planning to carry the fight to the prosecution and attempt to regain possession of the bul-lion and currency that was selzed by the

polles. The disputed treasure consists of \$8080 worth of gold bars and \$4600 in currency. In order to prove that the conflicated bullion was stolen the pros-ecution will have to bring many wit-messes from distant points in Alaska, and the expense will be enormous. But beyond that it will be more difficult to prove that the \$4500 in currency found in the possession of E. L. Spith and Margaret Henry is part of the procession of the sale of stolen bullion.

Defense Is Confident.

Defense is Confident. Attorney Beajamin 1. Bloch, of coun-sel for the accurace prisoners, said today ihat he was confident that the state never would be able to prove the theft of the bullion, or even its ownership. And in that event, he said, both bullion and currency would have to be returned to Smith and the Henry woman. "When the preliminary examination of Smith and Margaret Henry and of J. T. and G. M. Woodson shall be called in the police court next Monday." he sedd, "we will immediately move for a reduction of ball. We think that \$25,000 ball for each of the four prisoners is excessive. We also will resist any further attempt upon the part of the progecution to secure a postponement of the examination. Our clients have now been in jail for a week, and they are entitled to an immediate hearing."

The police say they are not at all alarmed over the prospect of losing any of the bullion and currency now in their possession. They express the belief that they will be able to establish the ownership of the disputed property and that they will easily prove that it was stolen.

"We have not published all the evi-dence we have against Smith and the other prisoners," said Captain of De-tectives Wall. "The four persons now in jail are likely to remain there for some time, and we hope soon to in-crease their number. Before we shall have finished with this case, all the guilty persons will be behind the bars."
