

NO HOT TIME HERE NEW YEAR'S EVE

Police Instructed to Arrest Anyone Using Confetti of Feather Ticklers.

In anticipation of the possible trouble that New Year's celebrations will cause tomorrow night, Chief Cox has announced that extra service will be required of all patrolmen. He has also announced that no confetti or feather ticklers will be tolerated and that any one using them will be liable to arrest. Any one found selling either of these articles will be arrested.

To provide for the extra service, orders were issued this morning that the duty relief which usually goes off duty at 4 o'clock will remain on their beat until 5:30 o'clock. The first night relief will not come on until 5 o'clock, and will report in at 10 o'clock for assignment to some district to be named tomorrow, to remain on duty until relieved.

The second night relief will report at 5:45 for duty instead of 11 o'clock, as usual.

Chief Cox said this morning that while considerable noise and trouble is anticipated and will be necessary to be tolerated, he is not going to allow any rioting and will draw a sharp line at the antics of the crowd when they begin to border on rowdiness. All officers will be instructed to see that all saloons close promptly at midnight and all cafes will be ordered to refuse to sell any liquor after that hour.

The following order was today addressed to each captain by the chief:

Dec. 30th, 1910.

"Captains of Police—December 31st being New Year's eve, no doubt there will be a great deal of hilarity and noise, especially so in the center of the city, and to prevent any possible destruction of property and other excesses it will be necessary to detail a number of officers for localities where most needed, such as Washington street corners from Second to Twelfth, and on Morrison and Alder streets from Third to Fifth. The duty relief will remain on duty until 5:30 p. m. The first night relief will report for duty at 5 p. m. and will remain on duty in time to report again at the station at 10 o'clock to be assigned to duty immediately in localities where most needed and will remain on duty until such hour as to enable them to catch the last car home. The second night relief will report for duty at 5:45 p. m. to be assigned to their respective beats.

"You will instruct the men to stop all discharge of firearms and to arrest anyone found shooting revolvers or other firearms and to also enforce ordinance making it a misdemeanor to throw upon any person confetti or other material of similar character or thrusting a feather duster in a person's face."

RAILROAD TO DO MUCH WORK AT ONTARIO, OR.

Ontario, Or., Dec. 30.—While here this week assisting in the transfer of the Malheur Valley railroad to the Oregon-Washington Railroad & Navigation company, A. B. Stevenson, division superintendent of the Oregon Short Line, laid out and made plans for granting a right of way for another crossing over the track in the northern part of the town at Tennessee avenue near the Standard Oil company's distributing station to relieve the congestion at the Idaho avenue crossing, and also ordered some improvements at Idaho avenue looking to the safety of life and traffic.

Considerable freighting is soon to be carried in the Ontario yard, including a bulkhead to the Standard Oil distributing station.

The commission has authorized the graveling of the Snake river wagon bridge road from Main street to the bridge one mile east of town. The contract for graveling this road has been awarded to G. W. South, who now has a force of men and teams at work.

The Ontario Commercial club has taken up the matter of road work and will start a campaign along this line looking to the material improvements of all the roads leading into Ontario during the coming spring and summer.

Fire Destroys Waldport Mill.

Waldport, Or., Dec. 30.—Fire yesterday afternoon destroyed the shingle mill and planer mill of the Waldport Lumber company's plant at Waldport, 16 miles south of Toledo. The fire occurred just at dark and the origin of the fire is unknown. The sawmill was saved, but the shingle and planer mills were totally destroyed. The telephone wires were attached to the buildings that burned, and this morning communication with Waldport is cut off.

TWO CHINESE TONGS FRAME UP PEACE PACT

(Continued from Page One.)

agreed to assume and settle the debts that its members may owe to members of opposing tong. Gambling debts are to have special attention, and the tongs are to see that they are promptly paid. Ends Oldest of Chinese Feuds.

The peace agreement ends the oldest feud between warring Chinese tongs in the United States. The Four Brothers and the On Leongs have engaged in fights in the Chinese quarter here and in other cities ever since the communities have been established. In New York many murders have occurred which, the police have charged, are a result of these wars. In most cases the police have been powerless to punish the offenders, the members of the tongs banding together to prevent outside interference and shield the guilty from arrest, and when arrests have been made, they have kept witnesses from being taken to court. The tongs have preferred to settle their own disputes by killing some member of the tong that committed the first murder.

Vendetta "Bad for Business."

Leaders in the Chinese colonies, largely influenced, it is reported, by the members of the Chinese legation, have been seeking to end these wars. The head men of the tongs have agreed that the practice tended to put the Chinese colonies in disrepute in the cities in which they are located and were "bad for business." Peace proposals hitherto have always ended in misunderstanding and the wars have continued.

Only Two Tongues Affected.

The final agreement between the Four Brothers and the On Leongs was reached with much ceremony. The signs of the tongs gathered and there were long speeches, in which the terms of the understanding were outlined. The final agreement was formally adopted and the signs of the two societies pledged its members in cups of tea wine. The two legation officials made complimentary speeches.

The peace pact now reached affects only the Four Brothers and the On Leongs. The Hip Sings have been engaged in a three cornered war with them. It is believed, however, that the agreement is the first step toward a settlement that will include all the tongs represented in America.

SAN FRANCISCO TONGS EXPECTED TO FALL IN WITH REGIME OF PEACE

(United Press Leased Wire.)

San Francisco, Dec. 30.—The On Leongs, the Hip Sings and the Four Brothers are at present the only tongs at work in San Francisco. A three cornered fight, each tong for itself, has been going on intermittently for the past three years. Before that the On Leongs and the Four Brothers fought for many years. The accidental killing of a Hip Sing man during a fight between On Leongs and Four Brothers run men drew the Hip Sings into the feud.

As the fight now stands, the On Leongs are said to be ahead of both their rivals, two Four Brothers men and one Hip Sing having been the last killed. According to local Chinese, the On Leongs will have to pay indemnity.

That the action of the On Leongs and the Four Brothers will be followed by a similar agreement involving the Hip Sings is believed by many prominent local Chinese. Some predict that within a short time there will be a universal peace pact.

FINED \$50; REARRESTED FOR DISORDERLY CONDUCT

S. R. Montgomery, who was fined \$50 yesterday by Police Judge Tarswell for speeding his automobile "Wednesday night" was rearrested this morning on a bench warrant issued by Judge Tarswell on a charge of disorderly conduct.

When the case was called in court yesterday, Montgomery pleaded guilty for the purpose of avoiding any investigation into the case and the matter was disposed of before the judge was advised as to the details. When told this morning that a large number of complaints had been made against Montgomery, who is charged with shrieking his siren at its greatest capacity without reason, Judge Tarswell became indignant and immediately ordered the man's arrest on the disorderly charge. His case has been set for tomorrow morning and Montgomery has been released on a \$500 bond.

Schettler Will Recover.

Marshfield, Or., Dec. 30.—Otto Schettler, manager of the local office of the Western Union-Telegraph company, who was accidentally shot while duck hunting, will recover from the accident. His ankle was badly shattered and it was necessary to amputate the foot. This was the first serious accident that has occurred here during the hunting season.

DAIRYMEN MAY FIGHT ORDINANCE

Reported They Will Oppose Adoption of Measure Rem- edying Old Law.

Indications at this time are that dairymen will make a fight on the adoption of the new pure milk ordinance introduced at the last session of the city council by Councilman Gay Lombard and referred to the health and police committee for consideration.

The ordinance, which was drafted by Deputy City Attorney Tomlinson, not only remedies the defects on account of which the old ordinance was declared illegal, but contains a number of new provisions found to be necessary or advisable from the experience of the dairy inspector and his deputies.

One of the features of the pending measure is that which makes it unnecessary for the city to prove the existence of a guilty knowledge of the part of a milk vendor in order to obtain a conviction on a charge of selling impure milk.

The mere fact that impure milk may have been sold shall, in each instance, be enough to obtain conviction and procure a fine for the violation of the law.

Another provision that will not find favor with the dairymen is that which requires the score of each dairy within the jurisdiction of the city inspectors to be published every month in the city official newspaper. The tuberculosis test of cattle is one of the features of the old ordinance that is also retained in the new one.

FUNERAL SERVICES OF EDWARD ROGERS HELD

Funeral services of the late Rev. Edward Rogers, who died December 21, in San Diego, Cal., where he had gone for his health, were held yesterday afternoon from Holman's chapel. The services were under the auspices of Harmony Lodge No. 12, A. F. and A. M., with Rev. Benjamin Young, pastor of the Taylor Street Methodist church and chaplain of the lodge, officiating.

Rev. Rogers was born in England in 1842, and had been a resident of Oregon for 30 years. He retired as an active minister some years ago, although re-

taining membership in the conference, and had been residing in Hillsdale, Or., a widow, five sons and four daughters survive. The daughters are Anna E. Rogers, teacher in the Ladd school; Mrs. J. Bartosch and Nellie and Bernice Rogers; W. J. Rogers, Denver, Colo.; Edward E. Rogers Jr., Hillsdale; Joseph, Charles and Arthur Rogers, Portland, are the sons.

"BUFFALO" VERNON TO HAVE MANY RIVALS

Pendleton, Or., Dec. 30.—"Buffalo" Vernon, who made such a reputation at the roundup last year by his "bull dogging" stunt, will have no monopoly on that thrilling feat next year, according to Clarence Adams, a cowboy who rides the ranges in this county and who was one of the buckaroos in the "bucking" contests last year. He declares there are any number of cowboys on the ranges of this section who are practicing the stunt daily in order to enter in the contests. So popular has this pastime become, he says, that these cowboys have discarded the rope altogether in throwing steers on the range except in the case of extra large animals. When they want to throw a steer for any purpose, according to Adams, they ride alongside of the animal, leap from their mounts and, grabbing the steer by the horns, proceed to "bull dog" him. It is evident from this that there will be much rivalry in this department next year.

May Extend Streets Franchise.

Marshfield, Or., Dec. 30.—A petition asking that the matter of giving J. M. Blake further extension on his street railway franchise in Marshfield be put to a vote of the people has been submitted to the city council. It is asked that the question be voted upon at a special election to be held March 16. The city council has granted Blake the extension but some of the property owners object and want the franchise left open, as Blake has done nothing in the way of building the road. The matter will probably be decided at the special election.

TYPHOID IN EUGENE DUE TO BAD WATER

Nearly 50 cases of typhoid fever, Eugene are due to ill sanitation, according to a report made yesterday evening by Dr. Calvin S. White, state health officer, upon his return from an inspection of the infected district. Sewage carried from Cottage Grove and Springfield by the river has been found to mingle with Eugene's water supply, said Dr. White. Wells are sunk in gravelly soil so the sewage seeps from cesspools into wells. Dr. White described graphically how in one instance he found two little girls sick of typhoid in one bed. Behind the house was a well in direct connection with a cesspool. There have already been a number of deaths and more are expected.

Meanwhile the town is building a new filter system and the people are being warned to drink only boiled water until the water supply has been declared pure. Examinations of Eugene water made by Professor Emile F. Pernot, bacteriologist to the state health board, show both sewage and colin bacilli in the water which the people of Eugene have been drinking.

IROQUOIS MEMORIAL HOSPITAL OPENS

Chicago, Dec. 30.—The Iroquois Memorial emergency hospital, erected as a permanent memorial to the 800 victims of the Iroquois theatre fire, was formally turned over to the city today on the occasion of the seventh anniversary of the terrible holocaust. The hospital was built with funds raised by the Iroquois Memorial association. The equipment and furnishings were paid for by the city. The building is a four story structure, located in the heart of the business section. It will be operated as an emergency hospital, receiving emergency cases and victims of accidents in the downtown district.
