

## CARNEGIE SAYS ARBITRAL COURT WOULD SUCCEED

Philanthropist Voices Opinion  
That World Peace Could Be  
Maintained Through Influ-  
ence of International Body.

(By the International News Service.)  
New York, Jan. 7.—Andrew Carnegie, who recently gave \$10,000,000 toward a fund to help establish universal peace, was speaking today at the Republican club.

The club is holding a series of meetings every Saturday and the subject today was "Universal Peace Through an International Court of Arbitral Justice."

Previous to the speaking there was a luncheon.

Mr. Carnegie described the new international court of arbitral justice. He said:

"Such a court would bring universal peace to this world within a year or I would give it an option of a second year. It is easy for a man to make predictions without setting dates, but it is possible, in my mind, to bring the establishment of this court about today. What nation would dare to refuse its decision?"

"I love a healthy criticism," continued Mr. Carnegie, "and whenever I see my name in the papers, I cut it out and lay it away. Many have criticized me for my having made money in the manufacture of armor plate. Benjamin F. Tracey knew why I went into armor. It was because of a telegram from him that I did it. I was at that time in Scotland and he wired me as follows: 'The president says it is your duty to make armor plate to save the warring of our battleships.' I tried it, although there is much more money in the manufacture of pig iron. The president called upon me and I take the word of a president as the word of God. It is my duty to obey."

Referring again to the court of arbitration, Mr. Carnegie said:

"I want to make a prediction that if the senate of the United States would approve of such a court, would pass upon it and ratify it, within a year you will see such a treaty in operation among the nations of the earth and then the object of those who have been working for the international peace would have been accomplished. Take things easy, all will come out right."

to the St. Vincent's hospital. There Dr. A. Tinker, the family physician, was called.

The boy did not appear seriously injured, as he was able to talk, but he had lapsed into unconsciousness. At 9 o'clock he apparently fell asleep and soon died. Just what caused death is scarcely understood, as no marks or contusions could be found on the head or body. A post mortem examination is to be conducted today by Coroner Norden to determine the exact cause.

As soon as possible after the accident, Mr. Connell appeared at police headquarters and reported the affair to the chief. As soon as word was received that the boy was dead, Mr. Connell surrendered himself again at the station. He called the district attorney on the telephone and was told there was nothing to charge him with as the affair seemed to be an accident. Mr. Connell then returned to his home. He is very much distressed over the affair and has stated that he will do all possible for the afflicted family. All the funeral and medical expenses will be attended to by Mr. Connell.

"My conscience is very clear on the matter, for it was just a pure and simple accident, but one that I regret beyond expression," he said.

"When R. E. Chapman, a prominent local timberman, ran over and killed a Jewish boy within three blocks of the home of this little unfortunate, I felt sorry for him and little thought that I would be the next to cause the death of anyone."

As soon as friends of the mother heard of the accident, they crowded to the hospital, very much aroused over the affair, especially on account of the death of the other Jewish boy a few weeks ago. The mother is prostrated with grief.

## J. J. HILL TO GIVE A \$50,000 FUND TO WILLAMETTE

Empire Builder Will Endow Oregon School; R. A. Booth Promises \$100,000; Hope to Raise Half a Million.

Salem, Or., Jan. 7.—President Fletcher Homan of Willamette university today announced the receipt of a letter from James J. Hill promising an endowment fund of \$50,000 for Willamette provided Mr. Homan raised not less than \$250,000 additional. Mr. Hill gives the Oregon school two years in which to raise this sum.

In addition to the promised endowment from Mr. Hill the president of the institution announced today he had received a provisional offer of \$100,000 from R. A. Booth, the Eugene lumberman, contingent upon the school raising a total endowment fund of \$500,000. Alumni and friends of the school have already promised \$50,000 as a start with which to meet the conditions prescribed by Mr. Booth and Mr. Hill.

Mr. Hill's letter to President Homan reads:

"St. Paul, Jan. 3.—Mr. Fletcher Homan, President Willamette university, Salem, Or.—Dear Sir: In response to your letter of the 16th ultimo, I wish to say that I will give \$50,000 as endowment fund for your university whenever you have raised not less than \$250,000 in cash in addition to my subscription."

"The above is to be for a permanent endowment fund, the income from which is to go to the university."

"Funds for building or other improvements not to be counted or considered part of the arrangement."

"The offer to remain open for two years, and advice to be furnished from time to time or on request being made, the collection of the fund. Yours truly, JAMES J. HILL."

## MONA REES STAYS BY HER PROPHET

Chicago, Jan. 7.—Defying courts and police and firmly maintaining that her relations with Evelyn Arthur See, apostle of the "Absolute Life," are of the law's concern, Mona Rees, the 17-year-old girl whom See says he was training to be the "perfect mother," today declared she would continue to conduct the "junior commonwealth" in the building where she and Mildred Bridges, also 17, lived with the "prophet," in their plan to develop the "perfect race."

Miss Rees is pretty, cultured, wealthy in her own right, and fearless in her avowals of the philosophy of the cult. To Police Captain Dahner, who arrested her and who notified her that she would not be permitted to open the resort again, the girl said:

"One has the right to invade one's rights of conscience, unless we injure them. This action by the police is a usurpation of power."

Sixteen followers of See, most of them women and young girls, also declare they are perfecting themselves in her own right, and while in jail, which purposes freedom of selection by the sex and the consecration to each other "for the improvement of the race."

See is still in jail, being unable to furnish bonds of \$1000 in each of two cases growing out of his alleged relations with the Rees and Bridges girls.

He said the statute was so little known that it took months for attorneys to find it out and hence Ross should not be made to spend five years in the penitentiary because of his violation of it.

## TO TURN TIDE OF IMMIGRATION TO STATES OF WEST

Omaha Boosters Start Movement for Western Development Association; Convention January 18 to 28.

Omaha, Jan. 6.—In response to a demand from western governors, immigration officials and commercial organizations for an association which shall devote its energies to turning the tide of immigration into the western states, a call is being sent out from Omaha this week for a meeting to be held here between January 18 and 28, for the purpose of organizing the Western Development Association. As the meeting is called on the advice of some powerful state and private interests, the organization promises to become potential in stopping the tide of people going from the Mississippi river valleys into Canada.

Eleven States in the Movement.

Nebraska, Colorado, Wyoming, Utah, Idaho, Montana, Washington, Oregon, Nevada, California and Arizona are the states which will take the lead in attempting to see that the new settlers are turned from the south and from the Canadian northwest into the most fertile and promising parts of the United States.

The organization of such an association for the purpose of devoting the next few years to the gigantic task of turning the trend of men and women toward the distinctively western states was proposed by the publishers of the Omaha Daily Bee and the Twentieth Century Farmer, which papers organized the Western Land Products Exhibit with such an end in view. The publishers consulted western governors, heads of commercial organizations and railroad men.

Big Men Indorse the Project.

That their idea is popular and will result in a more or less permanent association is shown by the following replies received to the inquiry as to whether there was a demand for such an organization:

James J. Hill, chairman of the board of directors of the Great Northern railway—Such an organization could do a great deal of good if the work could be intelligently handled.

J. H. Hall, commissioner of agriculture for Montana—The move is one in the right direction and an organization ought to be formed for that purpose.

Joseph P. Fallon, commissioner of immigration for Idaho—I believe such an organization would do a great deal of good for the western states, and I will lend any aid in my power.

Ex-Governor J. H. Brann of Idaho—We are interested in the movement you suggest. Do not hesitate to call on me for anything I can do.

Colonel W. E. Skinner, president Denver-Laramie railroad—The information of an association looking directly to western development would be highly advantageous. We feel very grateful to you for the suggestion and know everyone in the west will.

E. L. Lomax, passenger traffic manager, Western Pacific Railway company—We realize the practical results that can be accomplished by the proposed organization, and we think we can assure you of a hearty welcome from the states of Utah, Nevada and California, and particularly from the Western Pacific Railroad company, which traverses these states.

F. E. Fisher, general passenger agent Colorado & Southern Railway Co.—It would be a good plan to call such a meeting and I believe something really beneficial might result from the formation of such an association.

George L. McDonough, colonization agent Union Pacific Railroad company—The suggestion is a good one, as it will enlist and secure the cooperation of each and every one of the states mentioned.

F. A. Nash, general western agent Chicago & North Western Railway Co.—I would say without hesitation that a great deal of good could be accomplished by just such an organization as you suggest.

S. F. Miller, general freight and passenger agent Nebraska and Wyoming divisions Chicago & Northwestern Railway Co.—I would say without hesitation that a great deal of good could be accomplished by just such an organization as you suggest.

## MAIL ROBBERIES BAFFLE OFFICERS

San Francisco, Jan. 7.—The series of mysterious mail robberies aboard the ferryboats Piedmont, Berkeley and Newark, the latest of which occurred at 7:40 Thursday night, while a double force of postal clerks were on guard, has set the entire staff of government postoffice inspectors and Southern Pacific detectives on the trail of a well organized gang of eastern postoffice crooks who are believed to be in this city for the winter months.

So suddenly and destructively were the pouches of registered mail taken from trucks aboard the boats that the authorities have no clue upon which to work.

The first theft occurred aboard the ferryboat Piedmont at 7:40 p. m. on December 25. Three inner pouches were taken from a mail truck in charge of Postal Clerk J. W. Naylor. One of these pouches contained one registered package enclosing legal documents. The pouch was destined for Reno.

From a mail truck which was wheeled aboard the steamer Berkeley at the Overland Mole from the overland limited at 10:35 a. m., December 29, a registered pouch was stolen. It disappeared under circumstances similar to the former thefts.

Thursday night another registered pouch containing 23 pieces of first class and two pieces of second class mail was stolen. A special guard of postal clerks had been detailed to watch the truck but this precaution apparently did not check the operations of the robbers.

## BOOKS OF BUTTE MEN ARE SHORT

Butte, Mont., Jan. 7.—Former City Treasurer Phil Goodwin, one of the most prominent Democratic politicians in Montana, is in the tax roll department, according to a report filed by Mayor Nevins by the auditing firm of Pogson & Peloubet, engaged by the city to make an audit of the city's financial accounts since the departure of the defalcator. The report of the defalcation has caused a big sensation by reason of the prominence of Goodwin.

Goodwin retired from the office of city treasurer in 1909 after having served two terms. Called before the mayor, Goodwin denied any knowledge whatever of the show-up, and the opinion is said to prevail among officials that the defalcation will be traced to some minor clerk.

Mayor Nevins will begin proceedings to recover the missing money from Goodwin. The report of the defalcation is completed. Goodwin is chairman of the Silver Bow Democratic county central committee, the largest county Democratic organization in Montana. Two years ago he was his party's candidate for state treasurer, and two years preceding that he was Democratic candidate for state auditor, being defeated both times.

## NEW CONCERN TO BUILD SAWMILL

The Saginaw Orchard & Timber company filed articles of incorporation at Salem yesterday, with a capital stock of \$100,000. C. C. Shaw, a well known timberman of this city, C. E. Brainerd, S. C. Brainerd, of Payette, Idaho, and Omar Hoskins being the incorporators.

The company has purchased a tract of 3000 acres of fir in the vicinity of Cottage Grove, Lane county, paying \$100,000 for the timber, and early in the spring will build a 100,000-foot capacity saw mill near Cottage Grove. The logs will be flumed to the mill, a distance of three miles.

The members of the company operate two tie mills in the Lewis river district and have recently completed a 60,000 foot capacity saw mill near Cottage Grove. This mill is now in operation and gets logs from a body of 25,000,000 feet of timber located near Cottage Grove. The mill is operated under the name of the Orchard Land & Timber company, incorporated with a capital stock of \$50,000. The tie mills, between the two forks of the Lewis river, are operated under the name of the Payette Timber & Milling company.

## MANAGER ARRESTED IN FIGHT AGAINST PLAY.

Edward DeCoursey, manager of the "Trunk Mystery in Chinatown" company that was preparing to play at the Bungalow theatre this week, beginning this afternoon, was arrested last night by Police Captain Bailey, on a warrant charging him with advertising and showing an act of a desperado.

Manager Baker of the Bungalow theatre, was asked to produce the manager, and at 9 o'clock last night he called at the station in company with Mr. DeCoursey. A bail bond of \$250 was placed for the release of the theatrical manager.

## FIFTEEN POLICEMEN STOP STREET RIOT

Fifteen police officers were necessary to quell a riot at Second and Burnside streets at 10 o'clock last night, when a group of soldiers from Vancouver, who were on their way to the city, were stopped by a crowd of soldiers from Vancouver.

For 10 or 15 minutes the fighting was extremely fast and furious. Many blows were struck and taken, one especially on the head of a soldier, who was taken to the hospital.

After the fuss had quieted down, William Dougherty, another soldier, was placed under arrest and brought to the station. Both were booked for being drunk and disorderly.

## POLICE HUNT FOR MINISTER'S LOST BOY

A general alarm has been sent out by the police for Wallace McKenzie, the nine-year-old son of the Rev. Donald A. McKenzie, pastor of the Fourth Presbyterian church, who lives at No. 28 Hamilton avenue. The boy was last seen playing about the house at 8 o'clock last evening. His parents do not believe he has been kidnapped, but think he strayed away in the dark and is lost.

## CANADIANS HOLD CONFERENCE WITH U. S. OFFICIALS

Representatives of Dominion of Canada on Hand in Washington to Talk Reciprocity With State Department.

Washington, Jan. 7.—Representatives of the Dominion of Canada and the United States held the first meeting of the reciprocity treaty negotiations late this afternoon at the state department.

The discussion lasted one hour and a half, and consisted in laying out a program for the conference. There were present W. S. Fielding, minister of finance, and William Patterson, minister of customs, representing Canada, and Secretary of State Knox, with Chandler Anderson, Charles Pepper and John B. Osborne, of the state department, representing the United States.

The conference came at the end of a day spent largely in official visits. The Canadian negotiators, with Ambassador Bryce, were received at the White House before noon. They were also presented to Secretary Knox.

Another Conference Monday.

The next conference will be held at the state department Monday. Secretary Knox, it is understood, will attend the meeting and direct the discussion as far as the United States' case is concerned. Both sides have entered the negotiations with an apparent disposition to make whatever concessions are promising an improvement in trade conditions between the states and Canada. The greatest obstacle the president will have to meet is declared to be the house and senate.

Any treaty agreed upon will be inoperative unless ratified by congress. The Canadians have come to Washington with a divided sentiment behind them. The farmers in western Canada are demanding free entry of American agricultural implements and wish the United States to remove the duty on farm and dairy products.

## MICHAEL MCCONNELL, SWITCHMAN, KILLED

Tacoma, Wash., Jan. 7.—Michael McConnell, a Northern Pacific switchman, living at 711 South E street, was struck and killed by a switch engine in the yards of the company on East L street shortly after 6 o'clock last night. He was one of the best known railroad men on the coast and had been in the employ of the Northern Pacific for a long time. He was formerly with the company at Minneapolis and St. Paul.

Gives Patient Wrong Medicine.

Tacoma, Wash., Jan. 7.—Unaccountable carelessness of a nurse at the Fannie Faddock hospital early Saturday morning resulted in the death of a patient named S. Olson of whom little or nothing is known, except that he was a foreigner, about 24 years of age. The nurse, who is said to be responsible, according to the superintendent of the hospital, made the mistake of giving the man oxalic acid, a deadly poison, in place of the usual dose of sodium phosphates.

## BOXING BOUT IS ENDED WHEN MAN TAKES THE COUNT

C. M. Dustin May Not Recover From Blow Delivered by Law Student; For Benefit of Church Club.

Salem, Or., Jan. 7.—As a result of a more exhibition of the many art, given before and for the benefit of the members of the Junior Brotherhood of the Unitarian church in the basement of the Unitarian church in this city last night, C. Mial Dustin, one of the principals in a boxing bout, was put out of business in the second round of the match by Tracy Lane and is laid up for repairs for an indefinite period at his lodgings, 817 Mill street, without much hope being entertained for his complete recovery.

The Junior Brotherhood of the Unitarian church is a semi-social athletic organization of the Unitarian church for scientific instruction of members of the club. There are occasionally given harmless sparring contests. Last night Tracy Lane, who is a student in the college of law at the Willamette university, and C. Mial Dustin engaged in a friendly bout for the benefit and instruction of members of the club. The first round terminated peacefully enough, but, as explained by one of the participants, "we got a little rough in the second, which lasted for 27 minutes."

During this round Lane landed a solar plexus by a stiff jab with his right upon his antagonist, who was seized with cramps and had to be carried from the ring and to the open air. His condition did not improve and a physician was summoned with the result that Dustin was carried home on a stretcher. During the night he had delirious spells and his ultimate recovery is still doubtful, though he rested quite easily today.

Mr. Dustin was injured during his service in the Philippines by reason of a horse falling upon him and it is suspected that some old injuries suffered at that time have been reopened.

## CARNEGIE TRUST PRESIDENT SAYS PAYMENT IN FULL

Management Says Over Suspicious; He Replies, "Unsafe Paper"; Defense of Dickinson; Robin's Trail.

New York, Jan. 7.—With \$550,000 of the city's money in its coffers, and with thousands of depositors throughout the United States cut off from immediate control of their funds amounting to \$11,000,000, Joseph T. Howell, president of the closed Carnegie Trust company, declared tonight that the company would pay "dollar for dollar."

Howell insisted that the "taint" of Joseph G. Robin, indicted wrecker of the Northern Bank of New York, was responsible for the closing of the Carnegie Trust company by the state superintendent of banking, O. H. Cheney.

Cheney denied this, declaring that the real reason was that the officials of the bank had failed to produce \$500,000 to retire securities whose value was problematical.

The attempt to lay the blame at the door of C. C. Dickinson, organizer of the corporation, who died mysteriously as the result of inhaling gases while witnessing an experiment in the transmutation of base metals into silver, at Scranton, Penn., was bitterly resented tonight by his brother, S. C. Dickinson, who said:

"We sold out all the stock we owned in the concern in January, 1910, and we left the bank in good shape. If the men responsible for today's failure try to hide behind a dead man, I will make the public acquainted with the actual proof."

When Robin was forced out of the bank's directorate, he owed it \$300,000. This was a year ago, and he gradually reduced the amount to \$225,000. This \$225,000 was paid two days after the failure of his Northern Bank of New York, in cash. Robin's attorney, William Travers Jerome, declares the payment was made without his knowledge.

It was officially declared tonight that Andrew Carnegie, whose name the trust company bore, never had any connection with the institution.

It is understood the trust company has lately passed into the hands of a coterie of southern financiers, of Tennessee, Georgia and North Carolina.

## FAREWELL DINNER FOR STEEL EXECUTIVE

Pittsburg, Jan. 7.—President W. E. Corey of the United States Steel corporation bade farewell to his former co-workers of the Carnegie Steel company at a dinner at the Duquesne club last night. Mr. Corey's remarks were not made public. Eighty-six officials of the Carnegie Steel company were present. Owing to criticism on elaborate decorations of former years, the dinner was very simple.
