JOE HEINRICH HOT AFTER O'CONNELL

Baker Athletic Instructor Issued Torrid Challenge to Multnomah Teacher.

Joe Heinrich, who used to wrestle in these parts, but who is now wrestling instructor of the athletic club at Baker, Or., wants to know why Eddie O'Connell, the Multnomah club wrestler, has not answered his challenge to wrestle a regular match. Heinrich beat Heinrich three years ago two out of three falls. Joe writes that he has been after a return match for the last three years but insists that O'Connell has given all sorts of excuses to avoid him.

Now comes Joe with a challenge to O'Connell that the latter can hardly overlook and retain his present position in the wrestling world, thinks the Teuton. Says Joe: "There are articles of agreement now in Portland which O'Connell refuses to sign. When O'Connell signs the articles and parties, I will forfeit with responsible parties, I will be ready to throw him three times in an hour for a \$250 side bet. I to weigh 165 pounds ring-side. O'Connell said he would wrestle me here in Baker on those conditions and I readily accepted them and posted my money here.

"Now to show this chap O'Connell up, I will do more. I will agree to throw him three falls in 60 minutes of actual wrestling time, catch-as-catch-can style for \$250 a side in private or in public in Portland or in Baker. If he wrestles here in Baker, I will guarantee him \$200 more on the day of the match. If the match is in public in Portland, I will ask that the winner take all the wrestler's share of the receipts.

"If O'Connell refuses to meet me after these conditions have been read by him, then I can only say that he is four-flushing."

VERNON TRADES PUT SPOKANE DEALS OUT

WHEN BILL LANGE SAVED SIMOLEONS

Makes Great Catch, Smashing Center Fencé, and Gets Fines Canceled.

A lot of crack ballplayers have been brought up in the Pacific Coast league and most of them good, husky sluggers, too. Just look over the list—Denny Shay, Tilly Shafer, Mike Dunlin, Hal Chase, old George Van Halteren, Harry Weller, Frank Chance, Orvie Overall, Helme Helmlinger, Sindow Merles, Mike Mitchell, Joe Wood, Larry McLean, Big Bill Lange, Joe Corbett, Gus Johnson, Rolfe Zeller and scores more.

While going over this list it will bring to many minds the great catch Bill Lange made last season for Chicago. It was in Washington in 1905. There is a funny story connected with the play. Lange had missed a train in Boston two days before, failed to reach New York in time to play there, and Captain Anson had fined him \$100. Thereupon he missed a train to Washington, arrived on the grounds after the teams had practiced and just in time to play and for that Anson fined him another \$100.

The game that afternoon went 11 innings, Chicago scoring one run in the seventh. There were two men out and a runner on the bases when Kip Selbach, then one of the hardest hitters in the business, snote the ball a terrific clip and sent it flying over Lange's head toward the center field fence. The hit seemed a sure home run, but Lange, a man weighing 225 pounds, turned and, without looking, sprinted desperately straight out toward the fence. At the last instant as the ball was going over his head, Lange leaped, stuck up both hands, turned a somersault and crashed against the fence. The boards splintered, one entire panel crushed outward and out of the wreckage crawled Lange, holding the ball in his gloved hand. The crowd went crazy.

As he came limping into the bench he shouted to Anson: "Fines go, Cap!" "None," said the captain, and the catch saved Big Bill 200 "iron men."

St. Louis, Jan. 21.—The American Bowling Congress, in point of attendance, the biggest tournament for the night of the ball and pin ever held in this country, opens here tonight, and will continue until February 6. The entries comprise 414 five-man teams; 852 doubles and 1721 singles. There will be bowling daily from morning until midnight. Cash prizes aggregating \$21,000 are offered and the fees from the contestants will total \$27,525.

OREGON TOSSERS RUN UP SCORE ON PACIFIC

University of Oregon, Eugene, Jan. 21.—The University of Oregon basketball team played its first game yesterday when they defeated the five from Pacific university by the one sided score of 63 to 7. Oregon played circles around Pacific, scoring at will. Pacific scored on two baskets and three fouls. The ball was seldom in their end of the field and in all they did not get more than 10 shots at the basket.

In the second half Oregon sent in four subs, who were tried out in order to determine the personnel of the road team, which will leave early in February for a tour of the inland empire. Jamison and Fenton were the stars for the varsity, each throwing 11 baskets. The scoring for Oregon was as follows:

Captain Jamison (F) 25, Fenton (C) 22, Simms (G) 4, Elliott (G) 10, Watson (G) 2.

The first line-up was Jamison (F), Walker (F), Fenton (C), Simms (G). The subs were Kay, for Walker, Wasson for Elliott, Moore for Jamison, Perkins for Simms, Service for Fenton.

The result was very satisfactory to Coach Hayward, who certainly has the making of a championship team. Fulton, Walker and Jamison are a trio of exceptional ability and their work yesterday was a revelation to the Eugene fans.

Johnson starts for California next week and will sail later for Australia.
