Weather Conditions.

A small low pressure area is central over western Montana; a second disturbance of moderate energy is central over northern Texas, and a third disturbance of decided character is moving down the St. Lawrence valley. A new high pressure area is central over Oregon and the barometer is relatively high over the Dakotas and over the east Gulf states. No precipitation of consequence has occurred in the north Pacific states since yesterday morning. Moderately heavy rains fell yesterday in California, and light snow occurred in northern Nevada, northern Utah and southern Idaho. Snow has also fallen in Wyoming, South Dakota and the upper lake region. It is much colder in southern Idaho, northern Nevada, northern Utah, Wyoming, Colorado, Kansas, Nebraska, Iowa, Minnesota and Wisconsin, and the temperatures have risen decidedly over a wide strip of territory extending from New England southwestward to the lower Mississippi valley.

The conditions are favorable for fair weather in this district tonight and Sunday, except in northwestern Oregon and western Nevada, where light rain or snow will occur.

Portland and vicinity: Over Oregon light rain or snow tonight and Sunday. Winds shifting to southerly.

Figure Etchers' Works Displayed.

At the Museum of Art, Fifth and Taylor streets, there is now on exhibition a collection of the works of some of the modern figure etchers. A number of plates by Anders Zorn, including the portraits of St. Gaudens, King Oscar of Sweden, H. S. Morgan and of New York, Ernest Benar and Paulus are shown together with Zorn's famous "Toast." There are a few dry points by Mary Cassatt, of children with mother or nurse; three plates by Rodin, the great sculptor, and ten exquisite lithographs by Fantin Latour.

Italian Flees From Robber—Tony Demotta had his Italian blood stirred to a high pitch this morning about 3 o'clock when a masked highwayman stepped from the brush on the road leading to the city from Milwaukie, and demanded that "they put hands up."

Demotta whipped his horse into a run, and fled down the road, regardless of ruts and mud holes, while the disappointed highwayman stood in the middle of the road, cursing and shouting after him. Tony landed at police headquarters to explain his troubles.

McGinn Paroles Embeszeled—O. A. Jackson, charged with embezzling \$66, pleaded guilty yesterday afternoon before Judge McGinn of the circuit court and was paroled. Jackson has been in the county jail since July 1 and the judge said that was sufficient punishment.

DIRECTED VERDICT FREES PHYSICIAN

Court Deems Evidence in Vera Hall Murder Case Insufficient to Convict.

Dr. J. J. Rosenberg was yesterday afternoon set free by a directed verdict in the circuit court, where he has been on trial on a charge of killing Vera Hall, the 20 year old girl from Oregon City, while preparing her for an operation. Judge Morrow held the state had not introduced sufficient evidence to show that the physician was careless or intended performing an operation on the girl.

Another reason for the dismissal lies in the fact that one of the most important witnesses for the state went back on Deputy District Attorney Fitzgerald and told an entirely different story on the witness stand than he has previously given. Elmer Erickson was the witness. He is accused of being responsible for the condition of Vera Hall and originally said he took her to the office of Dr. J. J. Rosenberg for the operation. He had also been her sweetheart for three years. On the stand, Erickson said he went to the physician's office with the girl, because she had the nose bleed. He denied knowing her condition.

Acquittal Ordered.

Attorney George Stapleton and Ralph Moody asked the court to direct the jury to return a verdict of acquittal Thursday afternoon when the state closed its side of the case. Arguments continued until late yesterday afternoon. They contended the state had failed to show the physician was either negligent or contemplated an illegal act.

Deputy District Attorneys Fitzgerald and Collier argued that the accused was culpably negligent, in that he administered chloroform without taking the proper precaution and that he was preparing to do an illegal act, and while preparing for this act caused the death of the girl.

The mother of the girl was the only witness that gave any testimony tending to show that the physician knew the condition of the girl, and that he had given her chloroform. The mother said Dr. Rosenberg told her he had given her daughter an anaesthetic and it had not worked as he expected it to do. He further told her the girl came to him for an operation, she said. Erickson originally told the same story, but when placed on the witness stand denied knowing anything about it. If he would have kept to his story the testimony of the woman would have been corroborated and the state could have gone on with the case.

Evidence Not Sufficient.

Judge Morrow said: "The rule is that an inference cannot be based upon an inference. As the evidence now stands, we have first to infer that the physician knew the condition of the girl and then we have to infer he intended an operation. There is no testimony that he knew her condition. The evidence does not show that any unlawful act was committed without due caution or circumspection, or tend to prove any unlawful act whatever."

Attorney Moody asked Judge Morrow to cite the several newspaper reporters to appear before him and show cause why they should not be punished for contempt of court in writing certain articles about the physician. The attorney said the articles tended to poison the public mind against the doctor. The court said he would think about the matter.

WALLA WALLA ISSUES BEAUTIFUL BOOKLET

Descriptive of the bountiful Walla Walla valley is a beautiful booklet issued by the Walla Walla Commercial club. The cover design shows an Indian maiden pouring water with a lavish hand from earthen jars upon the soil, this picture being illustrative of the origin of the name of Walla Walla, which is the Indian for "many waters," or the "valley of many waters."

The Baker Commercial club is also in the field with a beautiful booklet describing the resources of Baker and of eastern Oregon in the vicinity of that thriving city.

BAD \$10 BANKNOTE DECEIVES EXPERTS

Thickness and Length of the Silk Fiber Best Means of Detection.

Warning against a \$10 National bank note, so skillful a counterfeit as to make it unusually dangerous, has been received by United States Secret Service Agent S. A. Connell from headquarters at Washington. The note is said to deceive even experienced money handlers, being distinguishable only by the thickness and length of the silk fiber.

The note is on the National Bank of Commerce of Wichita, Kan., the series of 1882-1908, signed by J. W. Lyons, secretary of the treasury, and Ellis H. Roberts, treasurer. Its issue number is 539,132.

The report on the note states that the counterfeit is evidently made from photo-mechanical plates, printed on two pieces of paper with silk threads, too long and thick to be genuine, between.

Another distinguishing feature of the counterfeit is that the hand of the female that grasps the lighting flash appears to be maimed, the fingers apparently being cut off at the middle joint while the genuine notes show the closed fingers well defined.

Bollinger of the Highland Congregational church told the church members at the close of the Thursday night prayer meeting this week that it was the silver wedding anniversary of himself and Mrs. Bollinger, he did not expect on going home a few minutes later to see all the house lights flashed on as he opened the door and to find numerous friends and members of the church awaiting Mrs. Bollinger and himself. After congratulations, C. A. Mann made a felicitous address, and in closing said:

"Your friends undertook to bring as many silver dollars as the occasion represents in years, but they lost the count somewhere." The amount turned out the equivalent of about three times the number of years.

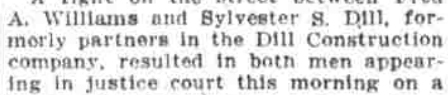
