

CLYDE B. AITCHISON DEFENDS STATE'S NEW UTILITIES ACT

Says He Drew It Himself, That It Is Modeled on Wisconsin's Law, That Oregon Will Like It.

The Oregon public service commission act was defended this morning by Clyde B. Aitchison, chairman of the state railroad commission, and author of the bill passed by the legislature, and the criticism which has come from certain sources was vigorously answered.

Those who say they find the Oregon utility law unsatisfactory now confine their argument principally to the fact that two provisions of the law, the act upon which the bill was modeled, were not included. These were the clauses providing for indeterminate permits for utilities and fixing the cost for hearings upon the defendant companies if they were found to be at fault. In discussing the new law Mr. Aitchison confined himself to those two points and the indeterminate permit provision in particular.

"The Oregon bill was not drawn up until Mr. Campbell, then chairman of the railroad commission, and I had carefully gone over the Wisconsin act with members of the commission of that state," he said this morning. "We were in Washington, D. C. last November at the convention of the National Association of Railway Commissioners and members of the Wisconsin board were in attendance. With them we took up their act section by section, discussing their opinions and illustrations of the operation of the various clauses on every point. We had the full benefit of their experience."

"Later we went to New York City to visit the offices of the New York public service commission, first district. There again we were favored by a full and frank discussion of features of their act. I was told that Oregon could not do better than follow the Wisconsin law, wherever possible, as it was of more recent enactment than the New York law, and was at least equally satisfactory."

"The Wisconsin men assured me that the indeterminate permit provision was not indispensable. In their state it is largely in its experimental stage, and only one other state, Massachusetts, has anything akin to it. Added to this was the fact that it was not demanded in Oregon, and also that it frankly is based upon the idea of public utilities being essentially monopolies to stifle competition. In some of the eastern states, which have attained something like their full growth, additional competition is not needed and would become a burden, but is there anyone who will say that Oregon utilities have the competition that the people require? It is doubtful, at least."

"One section of the indeterminate provisions of the Wisconsin law reads as follows:

Class Considered Undesirable.

"No municipality shall hereafter construct any such plant or equipment where there is in operation under an indeterminate permit as provided in this act in such municipality a public utility engaged in similar service, without first securing from the commission a declaration after a public hearing of all parties interested, that public convenience and necessity require such municipal public utility. But nothing in this section shall be considered as preventing

PEOPLE CAN BUILD BROADWAY BRIDGE

Judge Gantenbein Rules That Obstructionists Have No Ground for Action.

Overruling the Broadway bridge obstructionists has become such a commonplace affair in the circuit court that scarcely a ripple is caused when such a thing takes place.

Attorney R. R. Dunlavy and his suit of Walter F. Burrell were given a severe jolt this morning by Presiding Judge Gantenbein, but the interest has fallen to such a degree that the hangers around the court house did not attend. The suit of Burrell against the city was to cancel and enjoin the contract under which the Broadway bridge is to be built. Attorney Dunlavy also asked that the city be enjoined from taking further steps in the work. Assistant City Attorney Benbow entered a demurrer to the complaint. The matter was argued yesterday evening, the argument being continued this morning. Judge Gantenbein gave a decision as soon as arguments were closed, sustaining the city, which leaves the obstructionists again to go before the supreme court.

Object to Modjeska.

Walter F. Burrell complained, this morning, that the city had no right to hire Ralph Modjeska, architect, when City Engineer Morris could have done the work. He also contended that the city is wasting much money in erecting the structure by using granite piers, and placing ornamentalities on the bridge.

Assistant City Attorney Benbow replied that the city had full authority to build the bridge as it saw proper. This authority was given it by the charter amendment authorizing the bridge. Judge Gantenbein sustained the city in this respect throughout.

Amendment Covers Case.

"I hold that the charter amendment adopted by the people gives the city the right and authority to build the bridge, and that the executive board wishes," said the judge. "There is no question in my mind but what they will use the best methods possible, hire the best help, and do the work with as little expense as possible."

"This is the fourth time the obstructionists have been thrown out of court."

a municipality acquiring any existing plant by purchase or by condemnation as hereinafter provided."

"It is easy to imagine what a howl would have gone up if such a provision had been incorporated in the Oregon law," continued Mr. Aitchison. "It would have been declared that a commission which would be friendly to the corporations would some day prevent the city from establishing a municipal plant that was urgently needed. This particular clause throws light on a phase of the indeterminate provision of the Wisconsin law, which the people are not familiar and which the critics of our law have kept in the background."

Another Effect in Oregon.

"Another provision of the Wisconsin act says that a public utility may at any time turn in its franchise and operate under an indeterminate permit."

"If an indeterminate permit provision in the Oregon law is wanted, the people can get it at any election through the initiative or through the legislature. But it has been and is my belief that it should not be incorporated at this time. Let us watch the result of the Wisconsin experiment and benefit by the experience of that state."

Is Sure Law Will Work Well.

"As to the Wisconsin provision requiring companies to bear the expense of hearings when they are found to be guilty of the charges, I can answer that in a few words. The Wisconsin law is entirely impracticable in operation and we would have the same result in Oregon."

"As a last word I wish to say broadly that, under the public service commission bill passed by the Oregon legislature, the public utility corporations can be required to provide adequate service and reasonable rates. I do not believe the public asks more than these two things and they can get them if the law is intelligently administered."

**HOLLY LODGE DOINGS
GO BEFORE GRAND JURY**

Holly Lodge, that pleasant little roadside home that came into existence and went out of existence almost in one and the same breath, attracted the attention of the grand jury for some time this morning. The owners, M. E. Fitzgerald and Frank Senn, are charged with selling liquor in quantities of less than a gallon. "Dad" Hunter, deputy sheriff, arrested the men.

Edith McNeil, another young girl, told the same stories to the jurors as they told to the sheriff's force, an indictment charging the two men with selling liquor to minors, may be returned.

Holly Lodge was just outside the city limits at Lents. The grand jury finished the street car investigation yesterday, but has filed no report as yet. The jury will serve until March 6.

He recently had a hearing before Mary Garden and she expressed herself as being pleased with the quality of his tones. Cutter came from Alaska to Chemsawa school more than 19 years ago.

LINEN PEDDLERS ACCUSED OF FRAUD.

Housewives Complain Fabric Is Glazed Muslin; Warrants Are Out.

Complaints were issued from the office of the district attorney today against Pietro Segger, the two Pietro brothers and 12 Rigolo, who are charged with having defrauded hundreds of housewives of Portland during the last three months. The men are Italians.

J. J. Fitzgerald, assistant district attorney, told today that the authorities did not know how numerous were the victims of the four men. He has asked that victims report to the office of the district attorney.

H. D. Hanna, of 1111 East Lincoln street, swore to the complaints. He named, among other victims, Mrs. C. T. Anderson, 187 East Grant street, Mrs. J. W. Fice, 1055 East Grant and Mrs. R. Riley, of 44 East Thirty-sixth street.

With the Italians every day was "bargain day" according to the complaints. The four men, holding a peddler's license, are alleged to have gone from house to house, calling upon women and offering for sale what they represented to be the best grade of linen, at 20 and 25 cents a yard. As the price of real linen ranges from 40 to 70 cents a yard, many women bought. When they washed the fabric they found, it is said, that it was glazed muslin, worth about 12 cents a yard.

**HIRED MAN ELOPES
WITH FARMER'S WIFE**

The old story of the hired man eloping with the farmer's wife who deserted her children, was retold in police headquarters last night after the arrest of Mrs. Pearl Grant and Ralph Underwood, a swapper in local studies. In a rooming house at 1331 North Sixth street, on complaint of the woman's husband, D. C. Grant.

Grant has a ranch near Condon, in eastern Oregon, and last spring Underwood applied to him for work. Grant took him in and showed after covered things that made him suspicious. On asking his wife was reassured that nothing was wrong. Last November, the wife and Underwood came to Portland on the same train and later Grant came. The couple lived at the home of the woman's parents and the woman secured work in a downtown drug store. Recently the woman has been staying out late at night, it is said, claiming that she has been working overtime. Two or three nights away from home entirely aroused Grant's suspicions and last night he saw Underwood together in the rooming house and the arrest followed. Underwood was found locked in a clothes press. Underwood was sentenced to 40 days on the rock pile today.

**DRIFTING SANDS DELAY
EASTERN TRAINS**

Trains between Huntington and Portland have met considerable trouble the last two days on account of drifting sand in the vicinity of Celilo along the upper Columbia with the result that they have been two or three hours late reaching Portland.

Now that the wind has moderated somewhat, the sand is causing less trouble, but crews of section men have to be kept in readiness to respond to calls on short notice to get out and clear the track. In some places the rails were buried beneath 18 inches of sand during the worst of the storm.

Railroad reports indicated a heavy snowfall in the Blue mountains, the depth being four feet in some places. No trouble is anticipated from the snow unless it should thaw very rapidly in which event there may be slides.

**MAYOR RECALL ELECTION
DATE CHANGED; APRIL 4**

(United Press Special Wire.) Tacoma, March 1.—At a meeting today of the citizens' committee in charge of the recall movement against the city commissioners it was decided to hold the election to select a successor to Mayor Fawcett on April 4. It had practically been decided to have but one recall election for the entire city council, petitions for the other four members now being in circulation with indications pointing to the securing of sufficient names to bring about a recall. As the petitions for Mayor Fawcett's recall were completed in advance of the other city officials, however, it was decided to hold a separate election for mayor.

**FAMILY QUARREL
KEEPS COURT BUSY**

That his brother, James P. Moffett, greatly altered his various times was the testimony this morning in the circuit court before Judge Gatens by William Moffett. The mother of the two men brought suit to set aside a trust deed secured by James Moffett.

William said that his brother had called him an idiot and used vile and abusive language toward him. This treatment, he said, had continued during the last two years. He further said that James had roughly pushed him aside a number of times. Several other witnesses testified to hearing the abusive language. James will tell his side of the story tomorrow.

**CITY MILK CHEMIST
MAY GET HIGHER PAY**

The city health board this morning adopted a resolution recommending a raise in salary for City Milk Chemist E. D. Smith. The recommendation will have to be passed by the city council. The proposed increase is from \$125 a month to \$150.

The board also recommended that the salary of School Nurse Rachel D. Shatt to be increased from \$75 a month to \$90 a month.

THREE POSSES ON MURDERERS' TRAIL

Men Who Killed Saloonman at Haines Hotly Pursued by Determined Men.

Baker, Or., March 1.—Three posesses are scouring the country for a trace of two men who last night held up the Stockmen's Exchange saloon at Haines and killed Edward McCulloch in cold blood. The men fled immediately after the shooting and had a start of only a few minutes before pursuers were after them. The murderers headed toward Baker and bloodhounds are being used in an attempt to trail them.

A posse left Haines this morning on the trail and another posse left Baker at 10 o'clock to intercept the men before they reach here. No trace of them has been found yet, but it is believed they will be captured soon.

Salem, Or., March 1.—At a special meeting last night the student body of Willamette university passed resolutions apologizing for their action in declaring George Washington's birthday a school holiday, contrary to the wishes of the faculty, and differences between students and faculty of Willamette university have been healed over and everything is serene and calm again at the Methodist institution today. Everything is attending classes and there will be no effort on the part of the faculty to suspend any student for his part in passing the resolution of last Wednesday, granting the faculty a holiday, and then remaining away from classes in order that the faculty might enjoy the vacation given them by the students. The matter was so serious, however, that President Booth of Eugene, of the board of trustees of Willamette university; Rev. T. S. McDaniels and T. B. McSengal of Portland, two other members of the board of trustees, came to Salem yesterday to assist President Fisher Boardman of the institution to bring about peace again between himself and the student body.

(Special Dispatch to The Journal.) Chehalis, Wash., March 1.—Monday night the Chehalis city council passed a resolution which in effect forbids the employment of Greeks, Italians and other aliens on public work in this city. Contractors, subcontractors and others are prohibited from employing these people on any kind of public work. The action is the result of a recent large influx of Italians and Greeks who have been employed on paving, etc. Contractor Murphy of Tacoma who has a \$51,000 sewer job on which work was to begin today, expected to employ some Italians on the work. He states that a number of these men are American citizens and that they are property owners and residents of Tacoma. Mr. Murphy will employ all the local American labor he can get, but states that it is impossible to get these in sufficient numbers to do his work and get the 10 miles of sewer laid by fall.

**SILVERTON MAN DIES;
WAS PIONEER OF 1865**

(Special Dispatch to The Journal.) Silverton, Or., March 1.—William J. Jerman, one of the oldest and most highly respected citizens of this part of the state, died at his home in this city Sunday at 11 p. m. He was born in Boone county, Missouri, August 6, 1830. He crossed the plains in 1865, locating in Nevada county, California, where he was engaged in mining for two years. In 1865 he came to Oregon and remained in Lane county until 1867, when he came to Silverton, which place has since been his home. In 1866 he was married to Miss Martha Hilton, who died a little more than a year ago. To this union 11 children were born, seven of whom are still living—George, La Grande, A. G. Salem; Mrs. W. Jarvis, Silverton; James, southern Oregon; David, Salem, W. L., city mayor of Woodburn; Isaac, California.
